


Non-partisanship





The League is governed in its advocacy by documented position statements.


Positions are developed through studies.

The LWV Richmond Metro League holds its **Advocacy Program Planning** meeting each January to discuss proposed state positions from studies and local advocacy priorities.



Get engaged through Current Virginia Studies

There are no studies underway at the present time.

Note: 2021 Convention approved the studies and positions on:

- 1. Affordable Housing
- 2. Election Security

These are the four studies completed in 2021-2023:

- Money in Politics: to cover the full scope of financing campaigns in Virginia, from a donation through its expenditure including public disclosure of the donor, transparency in actual use of funds before and after the election, limits on personal use, and Virginia executive branch structure to conduct effective oversight and enforcement.
- **Environmental Justice:** to review LWV-VA natural resource position, to address how Virginia can best support environmental justice initiatives to halt or prevent future racial and economic environmental inequalities.
- Education Equity: whether state funding is equitable and ensures high quality education for all K-12 students.
- Childcare: to examine the nature of Virginia's childcare system.

Get engaged through Statewide Issue Groups

State issue groups will be reviewing and supporting advocacy on state issues. They will be very busy as bills drop for the next session of the General Assembly.

- Affordable Housing: second Tuesday of the month at 6 p.m.
- Behavioral Health and Criminal Justice: second Wednesday of the month at 7 p.m.
- Child Care: second Sunday of the month at 7:30 p.m.
- Domestic Violence: second Thursday of the month at 7 p.m.
- Education: TBD
- Environment: first Thursday of the month at 6 p.m.
- Gun Violence Prevention: fourth Wednesday of the month at 7:30 p.m.
 - Reproductive Health: first Wednesday of the month at 7:00 pm
- Transportation: meets quarterly on third Wednesday of the month at 5 p.m.
- Voting & Elections (includes Elections Security, Money in Politics, and Voter Access): second Friday of the month at 3 p.m
- Two new groups forming: Transparency, Mis/Dis Information

2. Mission of League

The League of Women Voters of the Fairfax Area is a nonpartisan political organization that encourages informed and active participation in government, works to increase understanding of major public policy issues, and influences public policy through education and advocacy.

Nonpartisan means that the League does not oppose or support any political party or any political candidate.

Credibility and Non Confrontational. (Tell story)

Elevator Speech - We register voters. We educate voters. We get out the vote. We advocate on issues.

3. **Structure of League** – The League is a grassroots organization. By regularly collecting feedback from every level of the organization, the League stays focused on the issues that its membership considers most pressing.

Local - The League of Women Voters of Fairfax Area (LWVFA) focuses on the large geographical area of Fairfax County, Fairfax City and the towns that fall within the boundaries of Fairfax County: Clifton, Herndon and Vienna. This is a large geographical area and for that reason LWVFA members are encouraged to join one of the smaller groups (called Units). There are 10 Units. These groups meet to discuss material published in the VOTER, LWVFA's monthly newsletter. The schedule and location of meetings can be found in the VOTER.

LWVFA also holds a General Meeting, usually held in November and an Annual Meeting that is held in April. These meetings are open to all members.

State – The League of Women Voters of Virginia (LWV-VA) is comprised of local Leagues within Virginia and addresses concerns at the state level, such as Voting Rights and Redistricting Reform.

The LWV-VA publishes the monthly Virginia Voter, an electronic newsletter and sponsors the League Legislative Roundtable.

National – The League of Women Voters of the United States (LWVUS)

Headquartered in Washington, DC. Membership operations.
