

Workshop on Civility and Civil Discourse

Civility is a factor that has been lacking in both political and interpersonal communication in recent years. This fascinating two-hour presentation will be conducted by two highly experienced trainers from LWV San Luis Obispo County, Sharon E. Kimball and Carol Courcy. They will focus on: acquiring a mindset, tools, and resources that can proactively contribute to a civil environment; trusting prior experience in dealing with incivility; expand choices and tools when experiencing incivility; and developing increased understanding of others' needs and approaches to incivility. They will discuss **ways to be respectful** (disagree without being disagreeable), **listen with an open mind** (recognizing opposing opinions), and **find common ground** (seek shared values), among other ways to cope with conflict by peaceful means.

Sharon E. Kimball is the first Vice President and Director of Civil Discourse for the LWV SLOC, of which she has been a member since 2011. Sharon has over 30 years of experience in business and education, with many "firsts," among them being one of the first women invited to join Rotary International. Her final report on Civil Discourse Study was accepted and published on the LWV (continued on page 2)

Sharon and her Action Team not only promoted Civility and Civil Discourse to elected officials, their staff, and the public in SLO County, but also been encouraging other Leagues in California and across the US to adopt the League's Study and Position by concurrence, and promote Civility and Civil Discourse in their own cities, counties and states.

Carol C. Courcy is a **Master Certified Coach** (her profession's highest designation), author and international speaker. She has more than 7000 hours of professional coaching with individuals, non-profit and profit organizations.

Carol has also written a book to help overachievers titled "Save Your Inner Tortoise: Learn How to Cross the Finish Line Joyful and Satisfied."

With her LWV civility work, Carol says a common challenge is when people say *"more of the same is NOT an option."* She recognizes that the simplicity of what we "know" needs to change, and that the "how" to change is NOT easy.

SUBJECT: Question on Citizenship in 2020 Census

Dear Congressman Panetta:

The Commerce Department has made the decision to include a question pertaining to citizenship in the 2020 Census. Make no mistake: this decision isn't about improving demographic data on citizenship. It's designed to frighten immigrants—citizens and noncitizens alike—so they won't participate in the Census. It's a blatant political maneuver meant to disenfranchise these groups and deny them equal representation.

Including this question on the Census undermines the rights of eligible voters and threatens a process vital to our democracy.

For more than 200 years, the Census has collected information about the geographic distribution of our population so we can provide representation and invest in our communities equitably.

Without a complete count of our nation's people, businesses will not have the tools to make sound investment decisions that keep our communities thriving.

The United States Constitution mandates an accurate count of all people living in the United

States – not all citizens.

Non-citizens are an integral part of our economy and need to be included in the 2020 Census to paint a complete picture of our great country.

The clock is ticking toward 2020.

We urge the House of Representatives to act to address this issue. Thank you for your consideration.

DIVEST FROM ILLEGAL WEAPON INVESTMENTS

ast month the LWV of California went before the California Public Employees' Retirement System (CalPERS) Investment Board to support California State Treasurer John Chiang's proposal to divest from companies that deal in weapons that are illegal to own or sell in California

What is the Problem?

- 346 mass shootings in the US in 2017 (Gun Violence Archive)
- 57 Mass Shootings in 2018 (as of April 2, 2018: Gun Violence Archive)
- 346 mass shootings in the US in 2017 (Gun Violence Archive)
- 7 out of 10 shootings happen at schools and businesses (FBI)
- 35% of U.S. stock funds include investments in a maker or retailer of guns and ammunition (Goodbye Gun Stocks/CBS News)

The weapons used in many mass shootings are military-style assault rifles, like AR-15s. California banned their sale or possession, deeming them a public health threat, yet its pension funds are still putting taxpayer and member dollars into their mass proliferation, a fact of which most Californians are unaware.

What are Solutions?

If Congress and statehouses are unwilling or unable to deliver real gun safety policy, the fight needs to go where the money is. Our State Treasurer has called on the nation's largest institutional investors (e.g., BlackRock, Fidelity, Vanguard, Allstate, PIMCO, Bank of America), and the nation's two largest pension funds (CalPERS and CalSTRS), to use the power of their purse strings and divest from wholesale and retail sellers of banned militarystyle assault weapons.

What is Divestment?

Divestment is when investors sell shares of stock, or stop investing, in a given company that has been identified as violating their principles.

How Does Divestment Work?

If many investors agree at the same time to sell a company's stock, that company faces immense pressure. Over time, a low stock price can make it harder for a company to get loans, finance sales, or expand its business. If the pressure becomes high enough, an entire industry or national government may change how they do business. Divestment campaigns were essential components in some of the most successful changes in public policy of the last 30 years, including US tobacco policy and the end apartheid in South Africa.

What Can You Do?

Check your personal investments, including your 401(k), to see if you are investing in the manufacturers or sellers of banned military-style assault weapons. Show your support for divestment by using **#DivestForOurLives** on social media and contacting CalPERS and CalSTRS.
