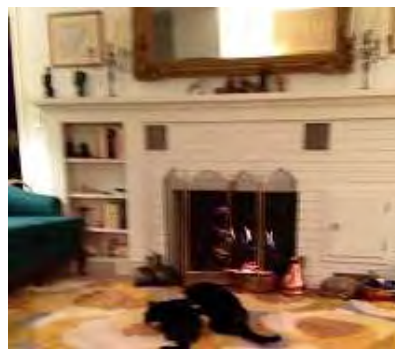
We were adopted in October 2008 as kittens from the Edgewater Animal Shelter which was showing several of us at a pet store in Daytona. Our adopter had

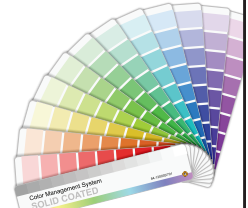
