Q1: Summit County is projected to have an additional \$4 million budget shortfall in 2019, due in part to having one of the lowest sales tax rates in Ohio. What measures would you recommend in dealing with the budget deficit? The truth is that we need to do a comprehensive evaluation and assessment of the overall tax structure in Summit County. To pin-point the fiscal shortfall solely on the sales tax rate may be a premature conclusion. There are multiple tax structures, fees, assessments and contractual relationships that have contributed to the fiscal condition. Each is subject to a forensic audit and an alternative matrix can be constructed to adequately address this matter with the most up-to-day statistics and data.

Q2: What role does County Council have in promoting good stewardship and management of water resources? Without question our role is that of being good stewards in all things that pertain to serving the public interest. As such we have to develop an equitable resource management system that allows non-county clients to utilize a fee structure that supports the additional cost of services to those communities. Leveraging cost benefits the water industry and the consumer. Continue join efforts studying solutions regarding the flooding problems. When we work to facilitate these relationships we demonstrate good stewardship.

Q3: In regard to addressing the opioid epidemic, what role can County Council play in addition to what has already been done? County Council can promote family and community based remedies that begin with availing resources to the whole family. Families need support in terms of education and stability management when any or all family members are engaged in the use, abuse, or care giving of the opioid epidemic. This may call for engaging community agencies, ADM, the water department, electric companies, gas companies, programs, churches, temples, synods and the retail community. All of us contribute to the demise of our community when we fail to realize opioid addictions impact the very fabric of our families and community. To effectively resolve this national crisis we must have everyone at the table. Our strategy would mean that we stop victimizing the victims of the opioid epidemic and start empowering them to overcome the strains of addiction. Within Summit County we have the power and ability to effect change. We do know that incarceration is not the answer.

Q1: Summit County is projected to have an additional \$4 million budget shortfall in 2019, due in part to having one of the lowest sales tax rates in Ohio. What measures would you recommend in dealing with the budget deficit? As a council person, I will look to pass legislation that keeps the best interests of residents in mind. I do not want to burden Summit County residents by forcing us to pay more for goods through taxes. Ideally, Summit County's economy will thrive with common sense legislation, thus addressing this budget shortfall. If we continue to bring solid, good paying jobs into the county, we will not have to worry about raising the sales tax.

Q2: What role does County Council have in promoting good stewardship and management of water resources? Obviously as a council person, I will be concerned about stewardship and management of our water resources. I will be willing to work with all of my colleagues to ensure that Summit County has good, clean, safe drinking water. Safety of Summit County residents is obviously a top priority of mine.

Q3: In regard to addressing the opioid epidemic, what role can County Council play in addition to what has already been done? I will be ready and willing to work with law enforcement any way I can to assist in bettering the drug epidemic. I will work on legislation based upon what law enforcement and health professionals suggest is the best effort to battle this ongoing problem.

Q1: Summit County is projected to have an additional \$4 million budget shortfall in 2019, due in part to having one of the lowest sales tax rates in Ohio. What measures would you recommend in dealing with the budget deficit? Prior Ohio law only allowed counties to raise the sales tax in .25% increments. Under a recent amendment to Ohio law, counties may now raise the sales tax in .10% increments. Under the Summit

County Charter, any sales tax increase must be placed on the ballot and approved by voters. In light of the change in Ohio law, I am willing to consider whether it now makes sense to ask Summit County voters to approve a small sales tax increase to make up for some of the money that used to come to Summit County from Ohio in the form of local government funds but no longer does because of the legislature's raiding of those funds to provide decreases in the state income tax. In deciding whether to approve placing such an increase on the ballot, I would need to be convinced that any new funds would be dedicated to specific needs, including criminal justice needs.

Q2: What role does County Council have in promoting good stewardship and management of water resources? County Council recently approved a storm-water management program to be administered by the County Engineer. Participation in the program by Summit County local governments is voluntary. (A number of Summit County communities already have their own programs.) So far, Bath Township is the only local government to participate in the County's program. It is my hope that, as other communities see what the engineer is able to accomplish in Bath Township, they will agree to participate as well so we can build a county-wide method of dealing with water management. Because water crosses local government lines, the larger the authority dealing with storm water, the more effective it can be.

Q3: In regard to addressing the opioid epidemic, what role can County Council play in addition to what has already been done? The opioid epidemic is a problem that must be dealt with at every governmental level. County Council has supported the Alcohol, Drug Addiction & Mental Health Services Board's funding of 20 additional residential treatment beds at IBH Addiction Recovery Center, assisting in providing more timely treatment and recovery services. The county has also donated 25 acres at the former Edwin Shaw Hospital property to Hope United and Restore Addiction Recovery on which they plan to build drug treatment facilities. There is not easy answers to the epidemic. We will continue to look for ways in which the County can participate in helping people to avoid becoming addicted and treating those who are addicted.

Current Occupation: During my years as Treasurer/Fiscal Officer I took continuing education classes in Treasury Management through the County Treasurers Association of Ohio and the County Auditors Association of Ohio. These classes took place two times per year and I attended all of them throughout my 34 years of service as an elected official.

Q1: Summit County is projected to have an additional \$4 million budget shortfall in 2019, due in part to having one of the lowest sales tax rates in Ohio. What measures would you recommend in dealing with the budget deficit? Summit County does and has dealt with budget shortfalls over the years without the need to tap our current contingent fund of approximately \$25 million. This fund is and will only be used for any emergencies that may arise within the county. The 2019 shortfall will be handled by providing county offices with a flat budget, meaning they will receive the same amount or operational dollars as budgeted for 2018. County officeholders deserve a great deal of credit for providing quality services on limited funds during these tough budget times. As a county we all must do our best with less.

Q2: What role does County Council have in promoting good stewardship and management of water resources? The City of Akron is the major supplier of water within most of Summit County under the Division of Water Distribution. County Council recently approved a storm water management program under the direction of the County Engineer and plays a role in the Gorge Dam removal. These are two areas where County Council assists with the management of water. Surface and storm water control is a very important issue to many areas of our county. As problems arise it will always be a priority for Council to work to solve those problems immediately. It is imperative that Summit County continue to review, monitor and make any future changes necessary to insure good stewardship and management of water issues.

Q3: In regard to addressing the opioid epidemic, what role can County Council play in addition to what has already been done? Summit County Council and the Executive's office, under the leadership of Ilene Shapiro, continues to work with federal, state and county agencies to provide any assistance possible. Educating both young and old is an essential part in helping to solve this crisis. The problem wasn't created overnight and cannot be solved overnight. Executive Shapiro announced in 2017 a new partnership to revitalize the county owned land where Edwin Shaw Hospital was formerly located. The county intends to donate 18 acres of the land to Restore and Hope United, both 501c2 organizations focused on addiction recovery. The footprint in Lakemore will include a treatment facility for in-patient counseling as well as a community center.



Elizabeth Walters Democrat

Q1: Summit County is projected to have an additional \$4 million budget shortfall in 2019, due in part to having one of the lowest sales tax rates in Ohio. What measures would you recommend in dealing with the budget deficit? The County has been proactive in preparing for the projected deficits. We are currently undertaking a review of all County fees and assessments to look for opportunities for additional revenues. Returning to flat budgeting, which will require all County entities to maintain service levels without growing their annual cost, may also be considered. This practice helped the County to come through the recession

relatively well. Summit County will also continue to rely on workforce attrition as way to continue stabilizing the annual operating budget. We are already operating with 800 employees less than we were 10 years ago and will continue to re-organize positions and distribute duties among existing employees as others retire. Finally, and perhaps most importantly, Council will continue to advocate as strongly as possible for the restoration of the state and local government funding that the state government has taken from cities and counties.

Q2: What role does County Council have in promoting good stewardship and management of water resources? County Council is proud to be an active partner in the Gorge Dam removal project that is well under way. By 2019 the structures, located on the border of Akron and Cuyahoga Falls will be removed, to reveal the original Cuyahoga Falls. By creating sixty miles of a free flowing and healthier river, the dam removal process will improve water quality by removing close to a million cubic yards of sediment. In addition, it will create the opportunity for more outdoor recreation for water sports. As a Council, we can also work with other municipalities and County offices to address surface and storm water management. In 2017, Council voted to create a new, optional Surface Water Management District. This new utility allows local municipalities to alleviate runoff and flooding issues and reduce costs.

Q3: In regard to addressing the opioid epidemic, what role can County Council play in addition to what has already been done? As elected leaders of this community we can use our platform to remind fellow residents and other community partners that this is a public health crisis. Addiction is a medical disease and those struggling with it deserve compassion and access to reliable, low-cost treatment options. We can also continue to look for innovative and cost-effective investments in projects that will support treatment and sobriety for Summit County residents. In late 2017, the County sold part of the old Edwin Shaw property to Hope United, for a very low cost to support additional treatment options. These partnerships will be critical to meeting the need for residents in recovery now and in years to come. Finally, as with the County's budget, we must continue to advocate to our state and federal partners, that they do more to fund this public health crisis.

Q1: Summit County is projected to have an additional \$4 million budget shortfall in 2019, due in part to having one of the lowest sales tax rates in Ohio. What measures would you recommend in dealing with the budget deficit? The projected shortfall has been caused in part by the State of Ohio doing away with tax revenue that was used by local governments. The following measures could be used to remedy the shortfall. County offices could freeze budgets at current levels. The county could limit non-essential services when required. If a sales tax increase would become necessary it should be submitted to voters in a referendum.

Q2: What role does County Council have in promoting good stewardship and management of water resources? Council can collaborate with the local health department, the Ohio Department of Natural Resources, and the EPA to ensure that current best practices are used at the county level. Council can also engage and educate the public in using best practices for resources management. Council could further utilize the Summit Soil and Water Conservation District to assist in these efforts.

Q3: In regard to addressing the opioid epidemic, what role can County Council play in addition to what has already been done? County Council can collaborate with the Sheriff's Office and other law enforcement agencies to help increase enforcement efforts against drug dealers and pill mills. Council can collaborate with local school systems and libraries to educate children and public about avoiding drugs and the importance of looking for warning signs of drug addiction. Council can also help eradicate the opiate problem by encouraging successful programs geared toward helping people get off drugs.

Q1: Summit County is projected to have an additional \$4 million budget shortfall in 2019, due in part to having one of the lowest sales tax rates in Ohio. What measures would you recommend in dealing with the budget deficit? This new shortfall is the result of the State phasing out sales tax collections on Medicaid managed care providers. Fortunately, the County has planned for such an event, and is prepared to keep department and officeholder budgets flat next year. We will see more attrition in County employees, continue to improve the efficiency of our operations and continue to search for lower cost solutions. The County has been a good steward of our taxpayer dollars, and I will make sure that continues.

Q2: What role does County Council have in promoting good stewardship and management of water resources? Luckily, we live in a district that is rich in natural resources, including the Portage Lakes. As our district continues to develop, the County will play a critical role in ensuring that our commercial and residential areas are sewered properly in order keep those resources clean and safe for both current and future generations. While we benefit from the job opportunities that result from development, we need to ensure that we grow in a smart and responsible manner.

Q3: In regard to addressing the opioid epidemic, what role can County Council play in addition to what has already been done? The County is currently involved in litigation against several opiate manufacturers and distributors. As we move forward with that litigation, we can use it as a tool to end practices that contribute to the epidemic and to provide funds for continued drug and alcohol treatment. We should also support the expansion of quick response teams and similar measures to ensure that those struggling with addiction receive fast and effective treatment.

Q1: Why are you running for this particular court seat?



9TH DISTRICT COURT OF APPEALS

The Courts of Appeals are established by Section 1, Article IV, of the Ohio Constitution, and their jurisdiction is outlined in Section 3, Article IV. As intermediate-level appellate courts, their primary function is to hear appeals from the common pleas, municipal, and county courts. Each case is heard and decided by a panel of three judges. The state is divided into twelve appellate districts by Section 3, Article IV, of the Ohio Constitution and Section 2501.01 of the Revised Code. Each district is served by a court of appeals that sits in each of the counties in that district. The number of judges in each district varies from four to twelve. In addition to appellate jurisdiction, the courts of appeals have original jurisdiction, as does the Ohio Supreme Court, to hear applications for wits of habeas corpus, mandamus procedendo, prohibition and quo warranto. Court of appeals judges are elected in even-numbered years to six-year terms on a nonpartisan ballot. Appellate judges must be attorneys with at least six years of experience in the practice of law. The Governor makes appointments to fill vacancies in courts of appeals that occur between elections.

Q1: What changes, if any, should be made to Ohio's electoral system? We must always ensure that Ohio's voting system results in competitive and fair elections. Therefore, I, Kristina Daley Roegner, voted in favor of Senate Joint Resolution 5, supported by the League of Women Voters and subsequently approved by the voters i May 2018. Green energy is the future, and the question for Ohio is simple: do we want to lead the world or follow countries like China and Germany in green tech jobs. We should start by removing regulations and impediments to clean energy, such as the current setback requirements for wind turbines. We should also retool our tax code and credits to encourage green tech jobs and development. We should simplify the permitting process to get projects off the ground. Just as we currently do with gas/oil exploration, we should allow green energy projects to occur on state-owned lands. For example, there is no reason why the state cannot lease space on buildings for solar panels or park areas for wind turbines or geothermal. Ohio should start by working with our high schools, tech centers and colleges to create curriculums for green tech careers, such as welding, electrical, construction and plumbing. We need to have an educated workforce to supply employees to green tech companies.

I'd like to begin the testing of blockchain to provide a low-cost and wholly-secure voting technology, which can be accessed from anywhere -- not just a polling location.

Q2: Explain your position on regulation of gun safety, sales, and ownership. I believe the Second Amendment has meaning, but I will honestly assess any gun regulation. Safety is the primary objective

Q3: What will you do to ensure that Ohio is at the forefront of the clean energy industry, increasing job opportunities that both safeguard our environment and reduce reliance on fossil fuels? We need to reduce setbacks for wind generation. We need to adopt an "all of the above" approach, so that costs are contained and our grid is sufficient until the day when renewables can sustain

Q4: Explain your position on reproductive health care choices for women. I'm pro-life. That position comes with an emphasis on economic opportunities for single mothers and making adoption affordable and removing unnecessary red tape.

Q5: What are your legislative priorities for the Ohio environment? Discuss climate change, renewable energy, water resources, and clean air. I'd love to see us re-deploy brownfields into commerce, using grants rather than loans. I'm going to be an advocate for reducing toxic algae, and thereby improving our water resources. I believe in making Ohio a leader in renewable energy.

Q1: What changes, if any, should be made to Ohio's electoral system? We need to do even more to fix gerrymandering in the state of Ohio. Issue 1 was a good start, but we should take politicians out of the equation entirely. Arizona and California, a red state and a blue state, have both implemented Independent Redistricting Commissions to great success. We also need to take a serious look at campaign finance reform. Candidates for the state legislature can receive contributions of \$12,707.79, which is nearly five times greater than the federal contribution limit.

Q2: Explain your position on regulation of gun safety, sales, and ownership. As a veteran of the United States Air Force, I was trained and certified on the M9 and M16. Having become familiar with these weapons of war, I can say with confidence that we should look to reinstate an assault weapons ban — they have no place on our streets. More broadly, the regulations that govern civilian firearm use should be made to reflect those regulations used in our military. Some specific provisions I support include: implementing a minimum age of purchase and ownership for firearms, increased coursework and continuing education for those with a concealed carry permit, the establishment of red flag laws, and closing the "boyfriend loophole." At present, many victims of domestic violence are in relationships not recognized legally, and abusers are not prohibited from purchasing or possessing firearms in the same way an abusive spouse would be.

Q3: What will you do to ensure that Ohio is at the forefront of the clean energy industry, increasing job opportunities that both safeguard our environment and reduce reliance on fossil fuels? In 2017 the American Wind Energy Association found that Ohio had the potential to generate up 92,000 megawatts in wind energy, but was only generating 617 of those megawatts. We are not living up to our potential is because we have some of the strictest wind setbacks in the country, which require wind turbines be built at least 1,225 feet from the nearest property line. The laws must be changed to match those used in our neighboring states. Not only are we missing out on +90,000 megawatts of clean, home-grown, renewable energy, we are also missing out on billions of dollars in investment, and good paying jobs. The fastest growing job in the nation is wind turbine technician, and the average pay is more than the median household income in Ohio.

Q4: Explain your position on reproductive health care choices for women. Women's reproductive health care decisions should be made between women and their doctors. The government should not have a say in how people do or do not to seek treatment.

Q5: What are your legislative priorities for the Ohio environment? Discuss climate change, renewable energy, water resources, and clean air. The whole reason I am running for office is due to our lack of clean air. When my daughter Nora was born, she had trouble breathing and was diagnosed with severe childhood asthma exacerbated by our region's poor air quality, which is the 10th worst in the nation. My wife Amanda and I spent many sleepless nights watching Nora, making sure she was able to breathe. I want to make sure no one has an experience like mine again. It is why amending our wind setback laws is a top priority of mine, as is bolstering the Alternative Energy Portfolio Standards (AEPS) which require 12.5% of utilities come from renewable energy sources by 2026. 12.5% is not enough. The original goal for AEPS was to hit 25% by 2025, and given that we were ahead of schedule before the program was frozen for two years in 2014, I know we can do it. Achieving that original goal is a must to not only improve the state of our air and water, but to stave off the devastating future impacts of climate change before it is too late.

ISSUES

Ohio State Issue 1:

Proposed Constitutional Amendment; Proposed by Initiative Petition
To add a new Section 12 to Article XV of the Constitution of the State of Ohio
A majority yes vote is necessary for the amendment to pass.

LEAGUE EXPLANATION OF ISSUE 1

Issue 1, also known as The Amendment to Reduce Penalties for Crimes of Obtaining, Possessing, and Using Illegal Drugs, would add a new section 12 to Article XV of the Ohio Constitution. The amendment is designed to reduce the number of people in state prisons for low-level, nonviolent drug possession; drug use offenses; or for non-criminal probation violations. In addition, it would provide sentence credits for participation in rehabilitative programs; and is intended to direct the savings achieved by such reductions in incarceration to substance abuse treatment programs, crime victim programs, probation programs, graduated responses programs, and rehabilitation programs.

The amendment would:

- Reclassify drug offenses from felony to misdemeanor for both accused and convicted drug users.
- Require the state to spend savings due to a reduction of the number of prison inmates on drug treatment and rehabilitation programs.

PROS ACCORDING TO PROPONENTS:

- 1. It would make the possession, obtainment and use of drugs no more than a misdemeanor.
- 2. It would create a sentence reduction credits program for inmates' participation in rehabilitative, work, or educational programs
- 3. It would reduce the number of people in state prisons for low-level crimes
- 4. It would save tens of millions of dollars annually in prison spending and direct the savings to addiction treatment and victims of crime.

CONS ACCORDING TO OPPONENTS:

- 1. The amendment would make it more difficult to prosecute drug traffickers.
- 2. This belongs in the Ohio Revised code. The constitution should contain fundamental principles and organization of government. Appropriation directives should not be added to the constitution.
- 3. This takes away available resources from the court for rehabilitating people and doesn't give judges the ability to use incarceration when it's necessary.
- 4. This proposed constitutional amendment does not provide adequate funding for treatment infrastructure nor treatment itself.


Summit County Initiative - Proposed Tax levy (Renewal and Increase)

A renewal of 2.25 mills and an increase of 1 mill to constitute a tax for the benefit of Summit County to support children services and the care and placement of children by the Summit County Children Services Board at a rate not exceeding 3.25 mills for each one dollar of valuation, which amounts to 32.5 cents for each one hundred dollars of valuation, for 6 years, commencing in 2019, first due in calendar year 2020.
