Help the League of Women Voters of Wisconsin monitor the April 3rd election. We are seeking volunteers to be trained as Election Observers and placed in polling places in specific areas around the state. We will do our best to assign you to a location near your home. You don't need to be a League member to volunteer for this -- although we'd love to have you join us!

What is it like to volunteer as an election observer? Penny Robinson reports that she has found it very rewarding. Although she had to sit quietly several feet from the poll workers and could not talk with voters unless they went outside, she has been helpful several times. In the last election, poll workers were just learning about

provisional ballots, so Penny was able to leave her position and remind voters as they left that they could ask for a provisional ballot.

In a previous election, she noted that the building was not 100% accessible, and the room for voting was too small. She also noted that the machine for people with other abilities was not working. Generally, she has found poll workers to be very competent.

Working with Willems student marketing team

The League of Women Voters of Appleton has been working with the Willems student marketing team through the Appleton School District to develop strategies to increase voter registration and education among young people. We have had two meetings with the team and have another scheduled to finalize their proposals. Some of their ideas for outreach to youth include:

- Birthday boxes for their 18th birthday with fun stuff as well as voting information. These would be given out at the schools.
- A Youth Voters tab on the Appleton League website that would include information that is pertinent to young voters.

- A simplified flow chart on how to vote.
- Alternative post cards and brochures that would appeal to young people.
- QR codes on all written information postcards, brochures, and posters.
- Open source texting.
- Awareness events at each of the high schools including presentations at civics classes to get students excited about voting at a younger age, which might include young government officials. Another event may include a flex time event at the senior level in May after the AP tests are done to inform seniors of voting issues related to them as they graduate.

Voter Services: past and upcoming candidate forums

The LWV of Appleton conducted their first of two forums for this election season when they welcomed all three candidates for the Appleton School Board. Jacqui Klimaszewski moderated a lively forum which included quite a bit of input from the audience. Several audience members submitted thoughtful questions on a wide variety

Voter Services collaborating in "Let them vote" project

The LWV of Appleton has teamed with the ACLU, LWV of Winnebago County, AAUW and Celebrate Diversity Fox Cities to develop a local branch of a program designed to help people who are having difficulty in either obtaining a photo ID for voting or using the forms of ID that they have when they are at the polls. Molly McGrath of the ACLU

provided education on a program that she has developed to help people in other areas who were having ID difficulties. A second meeting included volunteers who met to discuss how to implement this program in the Fox Valley. A follow-up meeting is scheduled for those volunteers to continue to develop the program.

Lake Michigan Region watersheds highlighted

Our state League has partnered with the LWV Lake Michigan Region (LWVLMR) to update fact sheets on four major watersheds that flow into Lake Michigan. Completed in 2017 by dedicated volunteers, this work has recently been published on the LWVLMR website. The research updated information and action plans on four separate areas: Door/Kewaunee watershed, Lower Fox

River watershed, Manitowoc/Sheboygan watershed, and Pike Root watershed. Find valuable information at www.lwvlmr.org.

The LWV-Appleton has two positions to advocate for the health of the Fox River, and these fact sheets on the Lower Fox River watershed are aligned with our positions. I have included a



Actions needed

small excerpt here. The LWVLMR determined the following actions are needed:

- Support use of technology and weather awareness for better targeting application levels of nutrients and pesticides to prevent loss of applied products into runoff for farms, golf courses and other large areas.
- Improve habitat and water quality by constructing stream buffers, restoring wetlands and other practices on streams for both farms and developed areas.
- Review Wisconsin Department of Natural Resources streams status reports to target areas where action is needed.
- Identify areas where sediments are entering and how they are moving as a result of streambank erosion to prevent and repair erosion.
- Factor changing climate and intensive storms into storm water management using stream buffers, wetland restoration and naturalized detention areas practices to prevent flooding, polluted runoff and to aid ground water recharge and possible recreational open space opportunities.
- Collaborate to gather or support research on the movement of sediments and beach sand due to changing storm intensity.
- Maintain and leverage the momentum of the Clean Water Act's framework of State Water Quality Standards and Section #319 Watershed Planning.
- Maintain and leverage the momentum of the recent watershed projects of the federal Great Lakes Restoration Initiative.

Effective and holistic lake management planning requires input from a variety of stakeholders, including technical experts, area residents, property owners, lake users, and people that rely on Lake Winnebago for their drinking water supply. Wisconsin Statewide Constitutional Referendum on the April 3, 2018 Ballot

What it will say on the ballot

At the April 3 Spring Election, all Wisconsin voters will be asked to vote on the question:

Elimination of state treasurer. Shall sections 1 and 3 of article VI and sections 7 and 8 of article X of the constitution be amended, and section 17 of article XIV of the constitution be created, to eliminate the office of state treasurer from the constitution and to replace the state treasurer with the lieutenant governor as a member of the Board of Commissioners of Public Lands?

Some history

The Wisconsin Constitution contains the following language: "The qualified electors of this state . . . shall . . . every 4 years . . . elect a secretary of state, treasurer and attorney general who shall hold their offices for 4 years. The powers, duties and compensation of the treasurer and attorney general shall be prescribed by law."

The state treasurer is a partisan office. The current duties prescribed by WI law include signing certain checks and financial instruments and helping to publicize the state's unclaimed property program (the program is managed and advertised by the Department of Revenue). Per the constitution, the treasurer serves along with the attorney general and secretary of state on the Board of Commissioners of Public Lands.

The Board manages the state's remaining trust lands (more than 77,000 acres of forest), manages trust funds (more than \$1 billion) primarily for the benefit of public education, and maintains the state's archive of 19th-century land survey and land sales records.

Historically, the treasurer had custody of state

funds, including state investments; handled receipts and payments of the State Fair; notified utility companies to pay taxes to the treasurer's office; settled with each county treasurer for the state's share of taxes; and made financial reports to the governor. Successive legislatures have assigned these duties to state agencies, primarily the Departments of Administration and Revenue.

Currently the only employee of the treasurer's office is the state treasurer, whose annual salary is approximately \$70,000. The total office budget is approximately \$113,500 per year.

What this referendum vote would do

This amendment would complete the transfer of financial duties from an independent elected official to agencies under the control of the governor. **Supporters** of the amendment contend that there are no remaining responsibilities that justify a separate office. **Opponents** are concerned about the consolidation of power in the executive branch.

Two successive legislatures voted to put this question to voters (as required by the Wisconsin Constitution).

What a Yes or No vote means

A "Yes" vote means the voter agrees that the constitutional position of state treasurer should be abolished.

A "No" vote means the voter wants to retain the constitutional position of state treasurer.

Homeland Security Provision an attack on our democracy

3/12/2018 Washington, DC – League of Women Voters President **Chris Carson** issued the following statement in response to a Department of Homeland Security bill provision that would allow President Trump to dispatch Secret Service agents to polling places:

"Polling places must be safe, accessible and welcoming to all voters—not places where eligible Americans will feel threatened and intimidated.

"Elections are the life blood of our democracy and

sneaking in a provision that allows the President to order armed Secret Service agents to polling places is simply appalling. This is just one more attempt this Administration has made to attack voters and flagrantly dismantle core tenants of our democracy.

"The League will continue to stand against these shameless assaults. The best way for all of us, as Americans, to fight back against attacks on our rights is to register and vote in 2018."
