### **VOTER IDENTIFICATION: WHAT TO TAKE TO THE POLLS**

## TEXAS REQUIRES MOST VOTERS TO SHOW PHOTO ID

The seven forms of approved photo ID's are: (must not be expired more than 4 years; for voters age 70 or older no limit on the expiration of the ID)

- Texas driver license issued by the Texas Department of Public Safety (DPS);
- 2. Texas personal identification card issued by DPS;
- Texas Election Identification Certificate issued by DPS:
- 4. Texas handgun license issued by DPS;
- 5. United States military identification card containing the person's photograph;
- United States citizenship certificate containing the person's photograph; (Note: Does not expire.)
- 7. United States passport.


**OPTIONS:** Voters who do not have any of the approved photo IDs and who are on the official list of registered voters may sign a simple form called a

"reasonable impediment declaration" and vote a regular ballot if they present a:

- · Valid voter registration certificate (card)
- · Certified birth certificate (original)
- · Current utility bill
- · Bank statement
- · Government check
- Paycheck
- Any other government document with the individual's name and address (original).

ID address does not have to match the voter registration address

### **VOTING IN TEXAS PRIMARIES**

The upcoming Texas primary is an extremely important election in Texas!

Voters in the Texas primaries and conventions choose who will run for office in the General Election. For many com munities in Texas, their elected officials are chosen in the primary election because many districts heavily favor one party over the other.

The Republican and Democratic Parties choose their candidates in a primary election. The Libertarian and Green Parties choose their candidates in party conventions.

Texas has open primaries. That means that ALL Texas voters can participate in one of these events.

Voters who don't strongly identify with any political party can and should carefully consider the choices and participate in one of the primaries or conventions. But you can only participate in one. Once a voter has voted in one party, that voter cannot participate in another party's election or convention.

The League encourages all registered voters to participate in the Texas Primary Election and vote for the best candidates. Don't forget, voting in a primary does not commit you to vote for a particular candidate in the general election.

## **U.S. SENATOR**

6-year term. Must be at least 30 years old, a resident of the United States for at least nine years, and a resident of Texas. One of 100 members of the U.S. Senate which has specific powers to advise and consent to presidential appointments and treaties and to try impeachments. Powers the Senate shares with U.S. House of Representatives include the power to levy taxes, borrow money, regulate interstate commerce, and declare war. Current annual salary: \$174,000

### Sema Hernandez (D)

**Background:** I do not have previous political experience. Instead, I offer a genuinely human approach to fixing our political system. I am a working-class, first-generation American. I can relate to the struggle of working

Americans because I've lived it.

**Disaster planning:** Absolutely. By including this in the budget, the federal government will be prepared to handle the needs of impacted people. I live in an area impacted by Hurricane Harvey and

have experienced the disaster firsthand. FEMA came to my area and offered disaster relief loans rather than grants. Putting people further into debt is not the answer. This system has to change.

**Health care:** I support single-payer healthcare for all. We are the wealthiest nation in the world that does not guarantee universal healthcare.

A single-payer system would put healthcare in the hands of patient and doctor, taking the profit-driven health insurance companies out of the picture. I support single-payer health-

care and H.R. 676 because healthcare is a human right!

**Immigration:** Undocumented immigrants in Texas are treated as second-class citizens even though they play a crucial role in our state's economic vitality. As your senator, I will work to pass legislation that gives undocumented immigrants a clear pathway to citizenship. I will also push for the simplification of the immigration process and ending immigration waitlists.

**Other issues:** I believe that higher education is a right and anyone should be able to attend public colleges and universities tuition-free. I support the decriminalization of marijuana, which could bring in major tax revenue for the state. I believe that our military has grown too bloodthirsty and we should cut the military budget, bring our troops home, and pursue a policy of peace.

**Background:** CPA, Master's in Accountancy and Taxation, over thirty years of business experience while supporting my sailor as he served the USN for 27 years, MOTHER, proud American, and prouder Texan. I work for you, not special interests.

**Disaster planning:** Absolutely. With the current system, there is little or no control over the process and with emergency appropriation bills, the risk runs high they will contain pork. The solution is an annual budget that adequately funds FEMA's Disaster Relief

Fund (DRF), ensuring the balance carries over as intended rather than budgeting the minimum and consistently failing.

**Health care:** Small businesses are drowning in the Obamacare obligation. And strangling small business isn't the way to get the economy thriving. History has shown us that a prosperous middle class is the key to economic benefits for everyone. The employee level is too low that demands coverage. Healthcare should be required for over 100

employees rather than 50.

### **VOTE BY MAIL**

Who can vote by mail in Texas? (no longer called absentee voting).

You may request a ballot to vote by mail if you

- · Will be away from your county on Election Day and during early voting
- · Are sick or disabled
- · Are 65 years of age or older on Election Day
- · Are confined to jail but otherwise eligible to vote

voters will be asked to supply a copy of an ID to vote by mail.

Request an Application to vote by mail from the early voting clerk in the county where you are registered, or download the form from www.VoteTexas.gov. The completed form must be received by mail by **February 23, 2018.** Note: postmarks don't count.

A ballot will be mailed to you, and you must return your completed ballot to your county elections department by 7 p.m. on Election Day, **March 6, 2018.** The ballot must be received, not just postmarked, by that date. If you are mailing your ballot from outside the United States, the early voting clerk must receive your ballot by the fifth day after Election Day. (You must mail it no later than 7 p.m. on Election Day.)

Generally, you do not need a photo ID to vote by mail. In some cases, first time

Among duties: executes all laws and conducts all business with other states and the federal government; fills appointive offices; fills vacancies in state or district elected offices by appointment; calls special sessions of the Legislature and sets their agenda; signs or vetoes bills passed by the Legislature. Current annual salary: \$150,000

**Background:** I am a former Mayor, Police Chief, School Board Trustee, and EDC Board Director. I am accessible, influential, and energetic political leader. I have spearhead new school, roadways, and social projects. I have a B. Sc. in CJ, in Grad. Studies for MPA

Election laws & voting rights: Drop voter ID law,

fairly redistrict voting maps, explore more technology for electronically registering and voting. I believe this measure ensures equity, not suppression.

**Health Care:** Seek the \$100 Billion of Medicaid Expansion refused by Gregg Abbott, drop lawsuit over women productive rights and restore proper CHIP funding for children and mothers. I would welcome Planned Parenthood as a mean of women affordable health care.

**Infrastructure:** Stop long-term tax abatements for the large corporation, I would not allow corporations to abate the educational tax. Allow non-violent offenders to learn a STEM, HVAC, Plumbing, and Engineering training so once released they may be contracted to become em-

ployed by the state to rebuild infrastructure for a 2 yr. period. Design new water reservoirs and seek new aquifers.

Improve schools so that our kids are better educated and qualified for more tech jobs, including free public pre-K and 2 years tuition-free training in community

Our students and teachers need an advocate in the governor's office. We will teach parents (especially poorly educated ones) how to help teachers teach their own kids with online programs and also ty programs

**Election laws & voting rights:** Red & blue states across the country are reforming election laws. To modernize our elections, I support automatic voter registration, an independent redistricting commission, repealing discriminatory voter ID laws, shedding light on dark money,

and any practical steps that protect the integrity of our elections and make it clear we want the people's voice to be heard.

**Health Care:** I am committed to adopting the Medicaid expansion, adequately funding state mental health facilities, stopping the attacks on women's healthcare, and ending the medical deserts in urban and rural Texas, where maternal mortality rates are unacceptable. ### WHAT IS PROVISIONAL VOTING?

The Federal Help America Vote Act (HAVA) of 2002 provides for provisional voting if a voter's name does not appear on the list of registered voters due to an a dministrative error. If your name is not on the rolls of registered voters in your precinct, but you believe you are registered, the election judge will attempt to determine if you are registered somewhere in your county.

If your registration cannot be found, you may cast a provisional vote by filling out an affidavit and a paper ballot. This ballot is kept separate from the regular ballots, and the case will be reviewed by the provisional voting ballot board. The ballot will be counted only if the voter is determined to be a registered voter in that precinct. Provisional voters will receive a notice in the mail by the tenth day after the local canvass advising them if their provisional ballots were counted and, if they were not counted, the reason why.

## LIEUTENANT GOVERNOR

Four-year term. Must be at least 30 years old, a U.S. citizen, and a Texas resident for the five years immediately preceding the election. Among duties as part of both the Executive and Legislative branches: assumes powers of Governor when Governor is absent or unable to serve; acts as President of the Senate; by statute, is a member of several Legislative branch boards and committees. The salary is that of a state senator when serving as President of the Texas Senate and that of the Governor when serving as Governor.

### **REGISTERING TO VOTE**

You must register to vote at least 30 days before the election date. The last day you can register to vote for the 2018 Primary Election is February 5.

### Who can register?

To register to vote, you must be

- · a citizen of the United States.
- a resident of the county, and
- at least 18 years old on Election Day.

You must not have been declared mentally incapacitated by a court of law.

If you have been convicted of a felony, you may register to vote only after you have completed the punishment phase of your conviction, including any terms of incarceration, parole, supervision, or period of probation ordered by the court.

### Where do I register?

You can register

- in person at the voter registration office in your county, or
- fill out an application that can be mailed or returned in person to the voter registrar in your county of residence.

Application forms are available at many libraries, government offices and high schools. The application is available online at the Secretary of State's voter information website, www.VoteTexas.gov. The website also allows you to search to see if you are already registered.

After you apply, a voter registration certificate will be mailed to you within 30 days. This certificate includes your precinct for voting on Election Day as well as your congressional, state legislative, county, and local districts.

Although in some states judges are appointed, most judges in Texas are elected. Voting decisions in judicial races are among the most important that a Texas voter makes.

### WHY ARE JUDICIAL

### **ELECTIONS IMPORTANT?**

Judges make decisions about fundamental issues that affect all of us — family life, education, health care, housing, employment, finances, discrimination, civil rights, public safety, and government actions. Those decisions can have long-lasting impact on individuals, groups, and the public as a whole. It is critical that our judges make fair decisions based upon open-minded and unbiased consideration of the facts and the law in each case. Judges must know the law and not be influenced by any external political and economic factors.

### WHAT SHOULD VOTERS LOOK

### FOR WHEN ELECTING JUDGES?

According to the American Bar Association, principles to consider in selection of judges include:

- · Judges should uphold the rule of law.
- Judges should be independent and impartial.
- · Judges should possess the appropriate temperament and character.
- Judges should possess the appropriate capabilities and credentials.
- Judges and the judiciary should have the confidence of the public.
- · The judicial system should be diverse and reflective of the society it serves.
- Judges should be constrained to perform their duties in a manner that justifies public faith and confidence in the court.

Unlike candidates for most political offices, judicial candidates cannot make promises about decisions they would make when certain issues or types of cases come up in their court. Questions posed to judges, therefore, focus on improvements they would make to their court, the need for impartiality and how they would increase access to justice.

### **HOW IS THE TEXAS COURT**

### SYSTEM ORGANIZED? —

The Texas court system is made up of a statewide network of trial courts and appellate courts. In trial courts, judges and/or juries evaluate the facts and the law and make a decision in a civil or criminal legal dispute. When decisions in most trial courts are appealed, they are sent to an appellate court where judges consider what happened at the trial court, evaluate legal arguments, and then decide if a mistake was made. The state's two highest courts, the Texas Supreme Court and the Court of Criminal Appeals, have both administrative and appellate responsibilities. The Supreme Court is the final court of appeals within Texas for both civil and juvenile cases. The Court of Criminal Appeals hears criminal cases that are appealed from one of the 14 Courts of Appeals and death penalty cases that by law go straight to the Court of Criminal Appeals.

All members of each court are elected for six-year terms, with three elected every two years. Any vacancies are filled by gubernatorial appointment until the next general election.

### WHERE AND WHEN TO VOTE



**Other issues:** If given the opportunity to serve in this role, I will ensure curriculum resources are culturally inclusive, relevant to the generation they serve, and effective in promoting rigorous learning environments. I believe creating and encouraging parent and family curriculum is a crucial supplement to every students holistic learning experience.

**Testing:** The STAAR test is only one piece of information that should be used when evaluating student needs. While group-administered assessments are efficient, important individual data can be missed.

Although generally a valid reflection of student performance as a group, one-on-one testing is necessary to reliably evaluate individual students with unexplained academic deficits.

**Funding:** Reliance on fossil fuel should decrease with increased investment in renewable energy, particularly as we work to improve our children's futures. Unfortunately, the legislature increased funding from the PSF for charter schools, which are inherently inequitable and risky investments. Therefore,

limiting charters granted would result in more equitable distribution of funds.

**Other issues:** As a scientist trained to objectively evaluate data, I will insist upon unequivocal fact-based TEKS and materials. I also strongly support comprehensive sex education. Additionally, I will advocate for effective educational interventions that support functional independence, and I will ensure that special education students are assessed in the most appropriate manner.

STAAR was not designed to diagnose individual learning needs. Individual learning needs are diagnosed in numerous ways, beginning with the classroom teacher.

**Funding:** The success of the investment policies of the PSF are demonstrated by the strong returns of the PSF. While the SBOE sets the rate of return for instructional materials, that is the

extent of its role in the distribution of funds sent to the Available School Fund. Equitable distributions for funding is under the purview of the Legislature.

**Other issues:** One of the main functions of the SBOE is setting the state standards. We shall soon have a newly streamlined set of excellent standards. My concern is with the lack of fidelity on the part of school districts in carrying out the state standards. They were designed with learning and critical thinking in mind but unfortunately test preparation has become more emphasized.

**Testing:** The STAAR test is specifically designed to assess what students are learning at grade level and measure if students are ready for the next grade. Though there are STAAR for special education

students and English language learners (ELLs), the test is not designed to diagnose individual student learning needs. To do this requires a collaborative approach from all stakeholders.

**Funding:** The current investment policies is clearly stated in the Texas Administrative Code Title 19 Part 2 Chapter 33 (TAC) and covers all areas necessary for investment and administration of the fund. I would support management of the funds which is the largest

educational endowment in America. Same thing applies to equitable distributions to schools for instructional materials.

**Other issues:** Many of our elementary aged students are not well prepared for secondary grades and beyond. I would work with fellow members to champion implementing instructional approaches that will ensure all our students have equal opportunity to succeed in secondary grades and beyond. Such as a consistent statewide transition plan that bridges elementary grades to secondary grades.

**Funding:** Funding is a hard issue, b/c of huge differences in needs between Spl Needs & Gifted kids (like my own two kids), or e.g. a child born in a distant or low income area, w/ little to no access to good schools, but who is highly gifted.

data with ensuring that our students are on track by considering new ways of gauging performance. Finally, students with learning disabilities need modifications and support.

**Funding:** The Texas economy is ranked No. 6 nationally by U.S. News and World Report. Yet, Texas' education system is ranked No. 41 in the country. Texas, while it has invested the Fund well, has kicked the can on school finance reform for decades, and that has to change. I will

closely monitor the progress of the TX Public School Finance Commission and will champion real change.

**Other issues:** 1) Strong start through pre-K – Quality early education from birth to 3rd grade provides the highest ROI for the success of our students 2) Whole child - Attention must be given to children who come to school hungry, whose asthma problems inhibit their activity or who feel unsafe 3) Teaching recruitment/excellence/retention – Teachers are a big driver of student success

### **REGISTERING TO VOTE**

You must register to vote at least 30 days before the election date. The last day you can register to vote for the 2018 Primary Election is February 5.

### Who can register?

To register to vote, you must be

- · a citizen of the United States,
- a resident of the county, and
- at least 18 years old on Election Day.

You must not have been declared mentally incapacitated by a court of law.

If you have been convicted of a felony, you may register to vote only after you have completed the punishment phase of your conviction, including any terms of incarceration, parole, supervision, or period of probation ordered by the court.

### Where do I register?

You can register

- in person at the voter registration office in your county, or
- fill out an application that can be mailed or returned in person to the voter registrar in your county of residence.

Application forms are available at many libraries, government offices and high schools. The application is available online at the Secretary of State's voter information website, www.VoteTexas.gov. The website also allows you to search to see if you are already registered.

After you apply, a voter registration certificate will be mailed to you within 30 days. This certificate includes your precinct for voting on Election Day as well as your congressional, state legislative, county, and local districts.

# See WHAT TO TAKE TO THE POLLS on the front page for a list of accepted photo IDs.

This section provides additional information about the photo ID requirements.

- The photo ID needs to be current or have expired no more than 4 years before voting (citizenship and naturalization certificates have no expiration date).
- The name on the photo ID should match the voter registration card or be "substantially similar."
  - · If the names don't match exactly, but are substantially similar, the voter will initial a box for similar name when signing in to vote.
  - To avoid confusion, you can change the name on your voter registration to match that on you photo ID at least 30 days prior to the election.
- Voters with a documented disability from Social Security or Veterans Affairs can apply for a voter registration certificate exempting them from the photo ID requirement.
- Voters without another acceptable ID can obtain an Election Identification Certificate (EIC) from Texas DPS at no cost by providing proof
  of citizenship and identity and registering to vote at DPS or showing a voter registration card. Requirements for the EIC can be found at
  http://www.txdps.state.tx.us/DriverLicense/electionID.htm. There is no charge for the EIC but the
  necessary documentation may have a cost.

### Photo ID is generally not required to vote by mail.

Voters may apply for a mail ballot if 65 or older, ill or disabled, or absent from their county during early voting and on Election Day. In some cases, first time voters will be asked to supply a copy of an ID to vote by mail.

- Voters who do not show an acceptable ID and do not sign the reasonable impediment declaration can vote a provisional ballot and have six days to show the required photo ID.
- Those who lack a photo ID because of a religious objection to being
  photographed or because of a natural disaster declared by the president will be allowed to vote a provisional ballot and complete an affidavit within six days of the election.

### **VOTER IDENTIFICATION: WHAT TO TAKE TO THE POLLS**

### TEXAS REQUIRES MOST VOTERS TO SHOW PHOTO ID

The seven forms of approved photo ID's are: (must not be expired more than 4 years; for voters age 70 or older no limit on the expiration of the ID)

- Texas driver license issued by the Texas Department of Public Safety (DPS);
- Texas personal identification card issued by DPS;
- Texas Election Identification Certificate issued by DPS;
- 4. Texas handgun license issued by DPS;
- 5. United States military identification card containing the person's photograph;
- United States citizenship certificate containing the person's photograph; (Note: Does not expire.)
- 7. United States passport.

**OPTIONS:** Voters who do not have any of the approved photo IDs and who are on the official list of registered voters may sign a simple form called a "reasonable impediment declaration" and vote a regular ballot if they present a:

- Valid voter registration certificate (card)
- · Certified birth certificate (original)
- · Current utility bill
- · Bank statement
- Government check
- Paycheck
- Any other government document with the individual's name and address (original).

ID address does not have to match the voter registration address.



### **VOTING IN TEXAS PRIMARIES**

The upcoming Texas primary is an extremely important election in Texas!

Voters in the Texas primaries and conventions choose who will run for office in the General Election. For many communities in Texas, their elected officials are chosen in the primary election because many districts heavily favor one party over the other.

The Republican and Democratic Parties choose their candidates in a primary election. The Libertarian and Green Parties choose their candidates in party conventions.

Texas has open primaries. That means that ALL Texas voters can participate in one of these events.

Voters who don't strongly identify with any political party can and should carefully consider the choices and participate in one of the primaries or conventions. But you can only participate in one. Once a voter has voted in one party, that voter cannot participate in another party's election or convention.

The League encourages all registered voters to participate in the Texas Primary Election and vote for the best candidates. Don't forget, voting in a primary does not commit you to vote for a particular candidate in the general election.

### **STUDENT VOTERS**

Students may use either their parents' address or their college address for voter registration, whichever they consider to be their permanent address. Students cannot be registered at both places. Students who will be away from their address on Election Day and during early voting may request ballots by mail. Student IDs are not adequate photo IDs for voting and will not be accepted at the polls.
