Local League Coaches Committee Report - The team continues to work to find additional LLCs, providing monthly reminder of national and state League items to local League leaders, work on materials to assist local Leagues and LLCs, and providing support to local Leagues. Below are summary notes from the March 14 (13 attending), April 1 in person meeting (22 attending, with seven remote), and May 9 (9 attended) meeting. Monthly meetings are recorded for coaches not able to attend.

Trainings/Tools for Local Leagues

- Just In Time Training We are collaborating with staff to move over the completed JIT videos to the LWVC YouTube website (Chairing a Board Meeting and League Committees). Other JIT topics in the works include League Lingo, Board Minutes, Record Retention and Non-Partisan.
- Officer Videos Recognizing positions differ based on local Leagues needs and size, the coaches are looking to create videos for certain positions. Currently exploring the president and five other positions.
- In-Person Meeting for LLC The coaches met in person the Martin Luther King Library in San Jose. Twenty-two coaches were in attendance with seven attending remotely. We got to know each other better, shared highlights of remarkable things and challenges happening at local Leagues, explored ways we could assist local Leagues better and discussed topics we would like to cover at the LWVC workshop. All coaches were aware that there were no funds budgeted for this expense and were told their expenses would be covered if submitted. Several coaches traveled many hours to get to this meeting. Your dedicated team of coaches all chose to cover their own expenses. Their in-kind donations total approximately \$3500. In addition, Sharon Stone your dedicated staff liaison joined us in person at this Saturday meeting.
- LLC Convention Workshop A pre-convention survey for local League boards to complete. They were asked the top three operational issues they struggle with as a League, asked them to assess different League resources, and suggestions on how to help these resources as well as suggestions to help them be more successful.
 - While results are still being gathered and reviewed, we can report the top three operational issues are: Membership, Communication and Leadership Succession.

- In addition, about a third of the participants are not familiar with the available resources and another 10-15% do not use these resources for varied reasons.
- The workshop will share the results of the survey and provide information about the different resources that are available to them now.
- We will also introduce the Just in Time Training videos, the work in progress Membership Engagement Cycle Toolkit, and Fall 2023 webinar on nonpartisanship to prepare all League members for the Election 2024 season.
- Election 2024 The coaches discussed planning webinars for Fall 2023 to prepare our members and local Leagues for the upcoming 2024 elections. Topics include nonpartisan and producing local League Pros/Con materials.

Membership Comparison Report

LWVUS sends an official membership report in early March. Accompanying this report is Membership Comparison Report that includes the January 2023 membership numbers and the six prior years for all the California Leagues. Here are major take aways from looking at the data:

- Total LWVC members is 3% higher than last year, however it is also the second lowest membership level for the past seven years.
- The membership change represents a small gain of less than \$1400 per member payment.
- This year the larger Leagues did not have the decline like last year.
- 24 Leagues showed an increase of 10% or more in membership from last year. However, several of these Leagues were making up for the large losses from the prior year. We have reached out to these Leagues to understand what they did to increase their membership and highlight insight into the change where known.
 - Five Leagues membership truly grew more than 10%. This includes San Luis Obispo, Davis MAS unit, El Dorado County, Solano County, and North Orange County.
 - San Luis Obispo continues to grow an additional 108 members (41%) totaling 369 members. It is now the second largest Leagues in California. As mentioned last September their increase is due to program events, participating in the redistricting efforts, and voter service projects.
 - Davis MAS unit ran a particularly good campaign to capture members that lapse the year before and gained few new members.
 - El Dorado County has been struggling and made deliberate efforts to their community partnering with both the democrat and republican parties, reach out to different communities and hosted candidate forums. These actions gained them new members.

- North Orange County has a strong membership committee, a popular Lunch with the League events and good community outreach programs.
- Twelve local Leagues have less than 50 members. Five years ago, six of these Leagues had more than fifty members. The remaining six have been hovering around the same number of members for the past five years. While fifty members is not a magic number for a League size, it is an indicator of Leagues needing to prioritize their work and rely on dedicated League individuals to be successful in their communities. A few of them are truly struggling to stay a viable League. Coaches have been assisting them, giving them guidance to help make them stronger. More than one is still in a precarious situation.
- 23 Leagues lost members, with nine of them either losing 20% from last year or lost 10% or more two years in a row. While we have not heard back from many of the Leagues, we are hearing a consistent theme of members aging out, moving, or passing and not being able to recruit new members (Santa Monica, Mt. Baldy Area, San Joaquin Area) and struggling to get existing members to take on leadership positions (Alameda).
- Eight Leagues had no change in membership. While this can happen, this could be a sign that membership records have not been updated and we are verifying that the records were updated with the Leagues.
