## **LEGISLATIVE SESSION BEGINS**

The 2024 Oregon Legislative Session convenes on Monday, February 5, 2024 and will last no more than 35 days. With little time for sweeping policy changes, the emphasis will be on budgetary fixes and tweaking of precious legislation. One key bill to keep your eye on is HB 4002, the bill put forth by the Addiction and Community Safety Committee to strengthen parts of Measure 110, the 2020 Drug Addiction Treatment and Recovery Act. Learn about our <u>OLIS (Oregon Legislative Information System)</u> and we invite you to see 2024's <u>LWVOR Action Committee Legislative Priorities</u>.

Find out how to turn Ideas into Legislation with AAUW Diversity Chair Laura Buhl, on Saturday, Feb. 3rd, from 2:00-3:30 p.m., at the Salem Public Library, Anderson Room A. Join Laura as she shows us how to gain an understanding about the legislative timeline and the steps Oregonians can take to impact the laws that govern us. Learn strategies to effectively advocate for the laws and policies that are important to you.

Join Laura Buhl on **Tuesday**, **February 20th, at 7:00 p.m**. **for a Zoom presentation** on how to navigate OLIS (Oregon Legislative Information System). If you're interested in knowing which bills have been proposed, participating in the legislative process, or looking up any information about current or past legislative sessions, you need to know how to navigate OLIS. #### VOTER SERVICE by Maureen Mader voterservice@lwvclackamas.org

This spring we have two opportunities in Voter Service needing volunteers. They are Oregon Student Mock Election (OSME) and/or Voter Education. No experience is needed and the majority of this work can be done from home. Time commitments can match your availability and now is the time to engage to make a difference in the 2024 election.

#### **Oregon Student Mock Election (OSME)**

The Oregon Student Mock Election is an experience-based educational program that involves participating students in the electoral process and

demonstrates the importance of voting. Students will vote for candidates and measures on an abbreviated Mock Election Ballot created for them. All students, grades 6-12 are eligible.

The LWV of Oregon has developed the program with turn-key materials making it easy for educators to integrate into their lesson plans. Our job is to get the word out to the over 40 middle and high schools in Clackamas County encouraging them to identify educators to register. Many hands will make the work light and this can be done at home by making a few phone calls, email from home, or drop off materials at their administrative windows.

#### **Election Services**

In our local league we will be involved in the non-partisan County Commissioner race where 3 seats are up for a vote. The incumbent for each seat is running but other candidates have also filed. The rule on these elections per the County Clerk's office is the following:

A nonpartisan candidate that filed with the county clerk will be elected on the primary ballot if the candidate received a majority of votes cast. If a nonpartisan candidate did not receive a majority of the votes cast, then the two candidates that received the highest number of votes are nominated and will appear on the General election ballot.

In other words, these elections could be decided in the Primary so we want to provide voters with information on these candidates in the May primary. There are several ways we can do this:

- Candidate Interviews broadcast via our website and local cable TV
- Candidate Forums format TBD.
- Vote411.org & Video Voters' Guide asking candidates to complete their profile.

**BOARD OF CLACKAMAS COUNTY COMMISSIONERS:** The BCC was on leave over the holidays. They recently published a 2024 State Legislative Policy Agenda. The link to that is here: <u>https://dochub.clackamas.us/documents/drupal/4e38fb28-e930-4a5c-8363-fa86a986dfd2</u> During the January 11th Business Meeting, the BCC strongly suggested that people make their voices heard with regard to tolling on the website <u>https://votebeforetolls.org</u>. On January 17th there was a Policy Session for two items that may be of special interest, when they discussed the county ambulance services contract with AMR NW and concerns about long response times. ## CLACKAMAS COUNTY BECOMES THE FIRST PUBLIC AGENCY IN OREGON TO OFFER VITAL RECORDS ORDERING ONLINE

Clackamas County Public Health Division recently partnered with Permitium to bring residents of our large county a secure and convenient online option called VitalDirector, to modernize and streamline the vital records ordering, payment and issuance of birth and death certificates. Each copy of a death and birth certificate costs \$25, and residents still have the option to order in-person. The task force is pulling together a team to research K-12 education positions of other state Leagues to determine whether to propose a concurrence at the 2025 LWVOR Convention. **Contact Jean if you can help research this issue on the timeline below!** 

- Through January 2024: Education Position Task Force formation
- Feb Sept 2024: info collection from local Leagues, national research
- Oct Jan 2025: consolidating info into a report to the Board, including concurrence proposal
- Feb June 2025: pending Board approval, campaigning statewide concurrence for June 2025

Work continues on the LWVOR Recall Study and feel free to email Keli to join in! The final report will include Oregon's recall history, a comparison to other states and discussion questions for members of local Leagues - and will explore some of the issues and potential impacts that are part of any kind of election: equity, money, ethics, succession, roles and relationships.

The statewide League team continues to meet with the following timeline as their goal:

- February 2024: Complete interviews and research
- March to April 2024: Write the first draft. Expert review of draft.
- May to June 2024: Complete the second draft and compose in readable/professional format with edits from an editing committee. Assign to Editing Committee.
- July 2024: Send a formatted and edited copy LWVOR Board for approval. Write Consensus Questions.
- August September 2024: LWVOR office publishes and shares the finished study and consensus questions with local Leagues and Units.
- September 2024 to January 2025: Local Leagues and Units to present consensus questions to their members. Study Committee may choose to be part of these presentations.
- February 2025: Local League consensus question answers are collected and presented to a specially appointed Agreement Committee that will draft positions.
- March 2025: Positions presented to Board for approval to publish, post, take action.

#### LIFETIME MEMBER IN 2024! SPOTLIGHT ON LIBBY MEDLEY by Libby Medley, Secretary info@lwvclackamas.org

Once upon a time there was an introvert, descended from covered wagon pioneers who crossed the plains to settle in the western United States. She was more comfortable dealing with "How?" questions than with "Why?". Born in Portland, OR at the end of World War II, Libby Lou Evans grew up the middle child, living with her parents and two brothers in a two-story ocean front home continuously under some level of construction. Designed by her mother, a school teacher, and built by her father, using his practical, hands-on skills, the home was nicknamed "Evans Relatives Roost", reflecting the pioneer spirit of hospitality that led to



multiple family gatherings over the years. Encouraged to use her imagination, Libby flourished in the small community, learning to keep an eye on the surf while playing among the driftwood and beach grass.

Her family kept the house when they moved to Lake Oswego, led by employment and good schools to suburban life as she entered her teen years. In addition to playing trombone in the high school orchestra (Lili, Bye-Bye Birdie, Sound of Music), her favorite subjects in school included diagramming sentences and geometry. Seeking a small school with an interest in mathematics, she left Oregon for warm, smoggy southern California to attend Harvey Mudd College in its 10th year. Libby was one of three women in her class, where the majors were limited to math, physics, chemistry and engineering, and earned a BS in chemistry after 4 years on scholarships. The intensity of the academic workload led to a burn-out, and she

turned away from graduate school in favor of working for the Jet Propulsion Laboratory in Pasadena on the Martian Viking Lander payload, with the special perk of being among the first to see moon rock.

She met her husband, Jay Medley, on a Sierra Club Singles campout blind date in 1970; a year later they got married, and spent two years in southern California, enjoying "skill-gimmick car rallyes", developing film, backpacking and climbing Mt Whitney. Homesick for rain, Libby convinced Los Angeles born Jay to move to Oregon in 1973.

Once they bought a house in need of repair and got settled, Jay found work building electrical controls and eventually purchasing, while Libby joined our West Clackamas County League of Women Voters in 1974 to learn about people and government. In selecting a local Unit to attend, she became intrigued by multiple presentations of their regional study of the Port of Portland, and became hooked. Volunteering to serve on this presentation committee for its final year led to confidence in public speaking, while she found a niche learning about accounting practices under the mentorship of then president Norma Jean Germond, serving on the board as treasurer at local and state levels before being appointed state budget chair (a term which lasted 30 years), including a short term on the national budget committee.

Meanwhile, their daughter Emily was born in 1980, and attended LWVOR board meetings with Libby, pushing buttons on the office printer as a toddler. When Emily entered school, Libby obtained a part-time consultant job preparing drug and medical device submissions to the FDA (*e.g.* convincing the FDA that this totally new/improved product was substantially equivalent to one previously approved–a special type of chemistry lab report.) Libby and Jay both took Leadership positions with Emily's Girl Scout troop, while annual family vacations featured camping in national parks, especially Yellowstone geyser gazing.

Participating in numerous League activities, from explaining financial statements to fellow League members to presenting the complexities of ballot measures and researching governmental issues, in 2006 Libby received the Carrie Chapman Catt Award for outstanding service to the League. She served as LWVOR state direct mail chair, writing letters to members and nonmembers to invite them to be a part of our mission by financial contributions towards informing the public about governmental issues and ballot measures.

When Emily turned 18, she joined the League to get an early start on her own Lifetime membership. Obtaining a BS in graphic design from the College of Wooster in Ohio, Emily returned to Oregon, assisted Libby in the design of her direct mail letters, served as secretary on the LWV of Clackamas County board and then LWV of Portland office manager prior to getting married. Jay also joined the League, served on research study teams for local libraries and emergency preparedness, and became renowned for his ability to sell raffle tickets as a state League fundraiser. In 2016 Jay was diagnosed with a bleeding gastric ulcer caused by an aggressive lymphoma, and he died in time to meet and approve of Emily's fiance, Dr. Adam Smith, but not in time to know about the engagement or participate in the wedding.

Meanwhile, Emily and Adam made their home in Tacoma and joined the Pierce County League, where he teaches computer science at the University of Puget Sound. In 2020 Rosalind Catherine Medley was born, adding one more member to the Pierce County Washington League and making Libby a grandmother at 74!

As for being an introvert, these few years without Jay and then without Emily nearby have exposed Libby to loneliness, having to make more decisions than she ever wanted, and left her wondering how to come to terms with a forgetful mind and a dedication to the League that keeps her searching for a new niche. Her part in writing the second edition of "More Power Than We Knew" serves to remind her of the value of history and the multitude of memories of a life worth living as our country faces another historic challenge. As Norma Jean Germond phrased it, "The League is a most wonderful organization." May you find it so as well.
