What are Pros & Cons?

- Unbiased, non-partisan explanation of a ballot measure to help voters make informed decisions
- Do not advocate for or against the measures they simply explain:
 - What the measure would do if passed
 - What a "Yes" or "No" vote means
 - Who supports or opposes it and why
 - Fiscal and practical impacts





What are Congressional Districts??

- Parts of a state where people vote for someone to represent them in the U.S House of Representatives. There are 435 congressional districts in the U.S, and California has 52 of that total.
- A Congressperson represents the people from their district in Washington, D.C. They help develop the federal budget and U.S. policy priorities, and work with other U.S. Representatives to make new laws. Each representative is elected for a two year term.



Who Draws Congressional District Maps in California?

- Prior to 2008: Legislators drew lines.
- 2008-Present: Prop 11 approved; established a non-partisan commission to draw the maps for State Senate, State Assembly, and the Board of Equalization.
- 2010-Present: Prop 20 approved; transferred authority to draw congressional maps from legislature to independent commission.







The California Citizens Redistricting Commission (CCRC)

- Was established by Article XXI of the California Constitution.
- Is made up of five Republicans, five Democrats, and 4 not affiliated with either of those two parties.
- Requires the district lines be drawn in conformity with strict, nonpartisan rules.


How do other states draw congressional maps?

- In most states, the legislature has primary control of the redistricting process, both for state legislative and congressional districts.
- Only <u>California</u>, Arizona, Colorado, Idaho, Michigan, New York, and Montana use independent commissions to draw congressional lines.



When are the lines redrawn?

- New maps are redrawn every 10 years
 - after the US Census is completed
 - to reflect the state's number of representatives
 - to ensure roughly equivalent population in districts
- The CCRC certified new district maps on December 27th, 2021 (after the 2020 Census).

Why are we having a Special Election?

- In June and July, 2025, President Trump asked Texas state legislators to re-draw their congressional maps to improve Republicans ability to win 5 districts now held by Democrats.
- In August 2025, the Texas Legislature passed a bill to adopt new maps for the 2026 elections.
- In California, a plan to counterbalance that action was initiated by members of the Legislature and Governor Newsom.
- On Aug 18, 2025, new congressional maps were approved by the State Legislature (Assembly Bill 604). But the bill cannot take effect without voter approval of Prop 50 via the special election in November.

What will Prop 50 do?

- Change the California Constitution allowing new maps in AB 604 to take effect and replace maps drawn by the CCRC.
- Require that these maps are used until the CCRC draws new maps, following the 2030 U.S. Census.
- Establish policy that supports the use of fair, nonpartisan redistricting commissions nationwide.





Prop 50 would also:

Change the percentage of registered Republicans and Democrats in ten districts so that:

- Democrats would have an advantage in five districts currently represented by Republicans
- More Democrats would be pulled into five swing districts currently represented by Democrats.





Fiscal effects (IF Prop 50 passes):

- One-time costs to counties of up to a few million dollars to update election materials to reflect new congressional district maps.
- One-time costs to the state of \$200K.





California's 2024 presidential election results by existing congressional districts









What does your vote mean?

A **YES** vote on Prop. 50 means:

The state would use new, legislatively drawn congressional district maps starting in 2026. California's new maps would be used until the California Citizens Redistricting Commission draws new maps following the 2030 U.S. Census.

A **NO** vote on this measure means:

Current congressional district maps drawn by the California Citizens Redistricting Commission (Commission) would continue to be used in California until the Commission draws new maps following the 2030 U.S. Census.





Important Dates

November 4, 2025 Special Election

October 6, 2025: Ballots mailed to all registered voters and Early Voting sites open

October 7, 2025: Ballot drop-off locations open

October 20, 2025: Voter Registration deadline (for non-provisional ballot). After this, until election day, people can register, but they will receive a provisional ballot.

October 25, 2025: Vote centers open for early inperson voting

November 4, 2025: Election Day. All votes must be cast, or a mailed ballot must be postmarked by this date.

What is Gerrymandering?

Gerrymandering is the political manipulation of electoral district boundaries to advantage a party, group, or socioeconomic class within the constituency.

Are other states also redistricting?

Efforts to redraw U.S. House districts for partisan advantage are spreading to more states ahead of next year's elections:

- The trend began in Texas, where the Republican-led Legislature passed a plan backed by Trump.
- California Democrats responded with their own map to help their party, though it still requires voter approval.
- Republican Missouri Gov. Mike Kehoe signed a revised congressional map into law.

- Missouri plan seeks to help Republicans win one more seat
- Indiana governor says redistricting session is probable
- Kansas Republicans working out details on redistricting
- Utah is taking public comment on proposed new districts
- Ohio must redraw its maps before the 2026 midterms
- Louisiana Republicans looking at times for a special session
- Maryland Democrats are proposing new districts
- Florida's governor pledges support for redistricting
- New York Democrats propose changes to state law
- Illinois' governor says it's possible to redraw the state's congressional districts to create more seats favoring Democrats





Can't we just stop all this mid-decade gerrymandering madness?

Preventing states from redrawing lines mid-decade would require Congress to pass legislation to that effect. Several bills have been introduced in that past:

- The Freedom to Vote Act of 2023 along with the companion bill John Lewis Voting Rights Advancement Act (Brennan Center for Justice).
- Currently, the Fair Representation Act (H.R.4632) was reintroduced and would create multi-member districts, ranked choice voting a new requirements for congressional redistricting (FairVote).

However, until there is bipartisan support and a supermajority in the Senate able to break a filibuster, we won't see any solutions coming out of the legislature.
