

MAYOR – CITY OF DEARBORN HEIGHTS

Per the City Charter, the Mayor is the chief administrative and executive head of the City. The powers and duties of the Mayor include the enforcement of City laws and ordinances; appointment and removal of all directors, the comptroller, commissions, and boards which are in charge of the several departments of this City; preparation and administration of the annual budget; administration of all departments of the City government; approval of the rules and regulations of the several directors, commissions or boards in charge of the departments of the City government; and all administrative functions of the City that are imposed by law, the City Charter or any other city ordinance.

I believe we should look at our Warren Valley Golf Course contract, we could consider allowing cannabis businesses, and we can also expand the offerings by our parks department, rather than asking voters to raise our taxes. BUILDING AND SITE SINKING FUND RENEWAL PROPOSAL

Note: This proposal will renew and restore the authority last approved by the electors in 2016 and which expires with the 2025 levy for the School District to levy a building and site sinking fund millage, the proceeds of which will be used to make improvements and repairs to the School District's facilities. Pursuant to State law, the expenditure of the building and site sinking fund millage proceeds must be audited, and the proceeds cannot be used for teacher, administrator or employee salaries, maintenance or other operating expenses.

Shall the Dearborn Heights School District No. 7, County of Wayne, Michigan, be authorized to levy 4.6682 mills (\$4.6682 per \$1,000 of taxable valuation) for a period of ten (10) years, being the years 2026 to 2035, inclusive, to maintain a sinking fund to be used for the construction or repair of school buildings, school security improvements, the acquisition or upgrading of technology, the acquisition of student transportation vehicles, trucks and vans and parts, supplies and equipment used for the maintenance of these vehicles and for any other purposes permitted by law? This millage if approved and levied would provide estimated revenues to the School District of approximately \$1,388,632.00 in the first year that it is levied.

- ✓ Return to the Clerk's office or use a secure ballot dropbox! Located at City Hall, John F. Kennedy Jr. Library, Justice Center, and Richard A. Young Recreation Center
- ✓ Absentee ballots must be returned by 8 PM on Nov. 4
