

Airway Heights, Cheney, Deer Park, Millwood and other Small Towns in Spokene County——An opportunity to co-operatively address community problems while not losing municipal authority.

Rural Spokane County --- Better representation and the ability to use the initiative and referendum.

ISN'T IT TIME TO MAKE A CHANGE???

Already 5 counties in Washington State have adopted County Home Rule Charters. While each county has structured a charter for specific local needs, all have the following in common:

- 1. No new taxing authority was created!
- Separation of the Administrative and legislative areas.
- 3. Local powers clearly defined.
- 4. More flexibility in handling citizen's business.
- 5. Citizens increased their role in local decisions.
- 6. Power was provided by the initiative and referendum process.

# WE NEED A COUNTY CHARTER!!!

### TEN REASONS WHY.....

- 1. Government by the people
  Is local government more responsive if
  it is written by and for the people?
  Spokane County voters could write a
  Charter to fit Spokane County needs.
- Representation
  Do 3 County Commissioners give adequate representation to 350,000 people?
  It takes two of them to make a quorum or to make a decision. How well are you represented??????
- 3. Administrative Efficiency
  Is administrative efficiency possible when some department heads are elected and some appointed?

- 4. Orderly Change
  Should Spokane County Government be able
  to change to fit changing needs?
  Most County Home Rule Charters include
  an amending process.

administrative authority.

5. Services and Planning
Could county planning and provision of
services improve if the basic government
is more simple and efficient?
A County Home Rule Charter could simplify
the administration and be more open to
the people.

6. Right of Self-determination
Should Spokane County continue to operate under an out-dated form of government?
The Washington Constitution provides a choice for change to a County Home Rule Charter which 5 Washington counties have adopted.

7. Financial Authority
Does it make sense to keep county finances operating under a system which the State Auditor has analyzed and found inefficent?

A County Home Rule Charter could modernize the method of financial accounting and reporting.

8. Citizen Participation
Should citizens have the right of initiative and referendum?

A County Home Rule Charter could include these.

9. Checks and Balances
Should the 3 County Commissioners continue
to have pewer to make laws, enforce laws
and hear citizen appeals on them?
A County Home Rule Charter could separate
these powers.

10. State Domination
Should the State Legislature continue to make decisions for local government?
A County Home Rule Charter could authorize many functions which now must be requested, from the state.

#### STEPS TO GET A CHARTER....

- CITIZENS SIGN THE PETITION
   First, sign the petition for the election of
   a Board of Freeholders to draft a proposed
   Charter. About 10.000 signatures are required.
  - CITIZENS THEN ELECT FREEHOLDERS
     At election time citizens vote for
     the creation of a Board of Freeholders,
     and then vote for the most qualified
     freeholder candidates.
    - CITIZENS INPUT CONCERNS
       You will have a chance at open meetings
       to express your ideas. So Freeholders will
       draft a charter that meets our needs.
      - 4. CITIZENS VOTE ON THE COUNTY CHARTER
