Committee Reports:

Voter Services:

- Columbus City Schools- Mary Austin Palmer has been doing a lot of work. Just under 1200 packets for students that will be eligible to vote were delivered. Packets including: voter registration application, absentee request application, instructions on use vote, instructions on how to cast ballot. Card they can use to ask their parents about their voter registration status and link to online registration. Schools are posting info on their social media. Students are getting emails to their school emails. One school had 67 students register bc of these efforts.
- Issue Guides are in progress
- Elizabeth and Barb met with Auditors office asking for W9 form- they are going to pay 6900 for an ad in the voter guide.
- We have a lot of volunteer opportunities coming up. Lots of speaking requests.
- Have done a lot of work with OH votes to get an ad about voting in all the COTA busses.
- Unprecedented level of interest than other elections we have seen

Education and Advocacy:

Presidents Report:

SOS Press Conference: Talked about unofficial election results will come out very early wed morning but official results wont come out till 3 weeks after so they can deal with trailing absentee ballots and provisional ballots. Made a large point that there will be no interim reports.

Elizabeth, barb, ben Cheryl – putting together talking points so we can communicate this. We will use resources for this info – not recreating the wheel.

SOS has asked controlling board to approve money coming out of his budget to provide money for return postage on absentee ballots. As of now, he has no answer. Next meeting is the 14th.
