I was asked to print the report I presented at the Annual Meeting on May 15 on the "State of the LWV of the Columbia Area" for the first issue of *League Lines* for the 2014 - 2015 fiscal year:

"As president finishing my first year of a 2 year term, I am honored to report to our members the many accomplishments we achieved this past year. We took on a number of challenges and sponsored programs that enhanced the Columbia area's understanding of voting procedures and critical public policy issues. I also want to take this opportunity to thank the Board for their support as we carried out our work.

The year started in mid-July with a board retreat where we discussed and identified our goals and action items for the fiscal year. In reviewing that list, I am pleased to report that we not only accomplished most of those stated goals, but were also able to conduct or participate in a few additional activities that were not anticipated at the time of the July board retreat.

Some of the more significant and visible activities included:

- 1) conducting two public information forums and a consensus meeting on the proposed change in city government;
- 2) preparing an easy-to-read brochure on the "Facts and FAQs on the Forms of City Government" almost 2,000 copies were distributed to the public;
- 3) preparing and conducting a presentation on the history of the Women's Suffrage movement to the 10th grade U.S. History classes at Fairfield High School;
- 4) setting up a social media presence on Facebook and Twitter;
- 5) conducting voter registration drives at 11 area high schools as part of a statewide youth voter registration initiative;
- 6) conducting an Agriculture Update consensus meeting;
- 7) conducting 7 Public Policy Luncheons featuring expert speakers on topics ranging from 3rd grade reading, out-of-state waste disposal, sustainable farming, and sensible gun controls;
- 8) public support of the successful passage of a RCPL capital investment referendum;
- 9) co-sponsorship of a panel discussion with the Delta Sigma Theta sorority on the change in form of city government;
- 10) sponsorship of a "Road Trip" with COMET representatives;
- 11)partnering with the Columbia Municipal Election Commission to conduct 8 voter education sessions;
- 12) writing a guest editorial on effective city government; and
- 13)forming a new Outreach Committee, with renewed focus on enhancing our Local League's visibility in the community.

Let's pause and take a second to give ourselves a "pat on the back" with applause to celebrate our accomplishments.

Notwithstanding the past good work, we continue to face challenges, and much work needs to be done. Although we have approximately 108 members, our numbers have held fairly steady in recent years –

from a low of 98 in 2011 to a high of 115 in 2013. I ask every member to make it part of their "psyche" to invite a new member, engage a current member, and/or expand your own participation. The strength and active participation of our members will be very important as we head into mid-term elections. Our visibility as an organization will be "front-and-center" as we initiate or receive requests to conduct or co-sponsor various voter services activities, including voter registration education sessions and candidate forums. How much we can accomplish is a direct function of the strength of our membership – as it is our members, with their financial support, that do all the leg work for our activities.

I would like to pay tribute to two members we lost during the year - Mary Kelly and Bill Barron, Keller's husband. A donation to our Ed Fund in honor of either or both is greatly appreciated by the League and by their families.

In closing, I give my many thanks to so many of you who worked behind the scenes and center stage to advance the mission of the LWVCA."

Your board and committee chairs met on June 21 for a retreat and leadership development session. I am pleased to report that our members can look forward to another exciting and informative year of public policy luncheons, voter services activities, and membership events.

LEAGUE OF WOMEN VOTERS NATIONAL CONVENTION – DALLAS, TX – JUNE 6 – 10, 2014

So many different women of every shape, color, and size participated in this year's Convention

-- However, they all had one thing in common: They believed in the constitutional right of all citizens to vote.

The National Convention of the League of Women Voters was held in Dallas, Texas, at the Omni Dallas Hotel, from Friday. The schedule offered days filled with plenaries, workshops, caucuses, and an occasional meal. Even the entertainment was tightly scheduled into the day's activities.

Wonderful speakers added insight into some of the problems of the US today. Stephen Murdock, of Rice University, spoke on the demographic trends facing the US. Annise Parker, mayor of Huston, and Peter Harkness, founder of Governing magazine, discussed the reality of governing in cities and states today. And at the banquet, Wade Goodwynn, of National Public Radio, captured our attention with stories of the events he has covered as a journalist.

In addition to the attack on voter's rights, other issues were added to the League's agenda. The League of New Jersey presented a motion that passed dealing with the problem of human trafficking. This issue will now be on the League's list of active concerns.

A motion to adopt a comprehensive three-part program combining study and review of key, specific structures of American democracy passed. The statement included a study of the process of amending the U.S. Constitution; a review and update of the League position on campaign finance in light of forty years of change; and a review of the redistricting process for the U.S. Congress

The League of Kansas proposed that the LWVUS take the position concerning a living wage that it is reasonable to expect government and for-profit businesses that receive tax incentives and/or other public funds to pay a living wage in order to prevent or reduce poverty and to promote self-sufficiency.

As a first time member attending the convention, I experienced the excitement of attending such an awesome event. I thoroughly enjoyed getting to know the other delegates from South Carolina and other states. However, I also suffered temporary confusion over the meanings of League terms and procedures. By the time it was over, I understood pretty much what was happening and knew I wanted to attend the 2016 Convention in Washington, DC.

FINAL REPORT ON THE 2014 YOUTH VOTER REGISTRATION GRANT

League of Women Voters of the Columbia Area

The League of Women Voters of the Columbia Area was selected to receive \$500 from funds awarded to the South Carolina League of Women Voters in cooperation with the 2014 National League of Women Voters Youth Registration Grant.

In its response to the call for proposals, the League of Women Voters of the Columbia Area committed to reaching diverse students at ten high schools in Richland and Lexington counties to facilitate the opportunity for them to register to vote.

The following is an accounting of the results of this action:

- By June 2014, a team of six League volunteers had registered 481 students in twelve high schools. Each student who registered received a sticker that said, "I Registered to Vote Today."
- By October 2014, each student who registered to vote will receive a post card from the League of Women Voters of the Columbia Area congratulating them for registering, encouraging them to vote in the November 2014 election, and reminding them of the documents they will need to take to the polls, including an approved photo ID and a proof of address document.
- Teachers who assisted by registering students in their social studies classes received a certificate of appreciation from the League of Women Voters of the Columbia Area and a copy of the League publication, *Know Your State*.
- In addition, each high school that invited League of Women Voters volunteers to register students at the school received a certificate and a copy of *Know Your State.*

CLEAN ENERGY SUMMIT: I was glad I decided to attend the 2014 Clean Energy Summit in Columbia on July 9. Over 150 business people, government and university officials, and members of nonprofit organizations attended this annual conference which highlighted what is going on in SC related to development of clean energy. It was informative and impressive. A highlight of the meeting was a panel discussion with representatives from Santee Cooper, Duke Energy, the SC Coastal Conservation League, SCE&G, The Electric Cooperatives of SC, the SC Public Service Commission Office of Regulatory Staff, and The Inter Tech Group.

SC Secretary of Commerce Bobby Hitt made it clear to attendees: Investment in wind and solar power production systems in SC is increasing significantly, and their cost has declined substantially in the last several years, making their use more attractive.

Here are some statements made from panelists and presenters during the conference:

- Renewables are going to be a big part of SC and the country. Incentives are still very important for development of renewal energy and keeping prices down is critical to Duke.
- Clean energy is a huge job opportunity for SC. We need to create incentives for investment in manufacturing facilities in rural areas.
- SCE&G is planning to get more involved in the solar business. They stated they expect to increase solar power generation to 40-50 MW by 2020. (* This is far less than some supporters of the SC Solar Energy Bill, who said it would eventually result in production of 300 MW in SC. So where is the rest going to come from?)
- Customer generation of power brings value to the system. It will be an increasing trend across the country.
- The issue of net metering policies needs to be resolved. New SC legislation on net metering is needed. SC is poised to be a leader. The PSC expects to develop a proposed net metering order by next March.
- Passage of the SC Solar Energy bill in 2014 was a major achievement, demonstrating that all parties could work together.
- Storage of energy using solar or nuclear power, such as using batteries to do so, will not happen quickly.

- BMW gets 53% of its energy from trash. Technology for converting trash to energy has been exported to countries like Samoa who have very limited land space for disposing of trash.

It was an excellent and worthwhile opportunity to learn about development and operation of the energy business in SC

Folks, you need to know that we are hearing concerns around the state about low flows in many of our rivers this summer. The article in *The State* concerns the Little Salkehatchie. DNR was asked recently to look at recent drops reported on the Edisto. Whatever is going on, it's not a sudden phenomenon – and there is no one cause. We need more monitoring, more science, more understanding of the relationships between surface and groundwater – and more vigilance from you as well as from state DNR and DHEC authorities. We cannot just sit back and watch our rivers dry up, especially since we are not in a declared drought. TRANSPORTATION UPDATE:

Lill Mood, off board specialist for transportation, submitted the letter below to *The State* newspaper in response to an op-ed in *The State* by Joe Taylor and Daniel Rickenmann (<u>http://www.thestate.com/2014/07/02/3542332/taylor-rickenmann.html</u>).

Her letter has been published, and she to wants the League to be aware that Mr. Taylor's and Mr. Rickenmann's assessment of CMRTA's progress with the revenue from a portion of the penny tax did not paint an accurate picture. "Revenue provided for the bus system by the "transportation penny" has enabled the CMRTA to restore and extend weekday and weekend service, replace aging vehicles, develop plans to reach underserved areas and populations, begin providing shelters and benches at bus stops, and re-brand The COMET with a distinctive and vibrant image.

To my surprise, Mr. Taylor and Mr. Rickenmann (Op-Ed 07/02/14) overlooked these accomplishments and focused on one tied vote on the operator contract. Since the sales tax resources gave the CMRTA Board a first opportunity to open the operator contract to applicants, the procurement process has been a new challenge for a diligent and dedicated volunteer Board. Some members believed we had arrived at a sound and beneficial contract, but others were not yet satisfied with the outcome of negotiations. Recognizing the importance of reaching consensus on such an important decision, the Board decided to reopen the process. We are mindful of both time and costs, and are committed to getting the possible operator contract for citizens who are investing in public transportation."

Lill Mood is also the Lexington County representative to the CMRTA Board.
