## From Civil Discourse to Deliberation

#### Highlights and Lowlights

- Sifting through the best and worst examples of civility. . . This one came to our attention from the LWVUS newsletter about the Johnson County League in Kansas City, MO which received the city's Civility Award for their work

on The Civility Project. Here is a list of what they are asking elected leaders to do, based on what they heard from hundreds of local residents. A few simple, practical changes in the way counties, cities, school boards and others engage the public would make a world of difference.

- 1. Involve people before you've made a decision. The earlier you involve us, the less conflict you'll face
- **2. Actively recruit participants.** Don't just post an ad or send a postcard, build networks. Reach out to us.
- **3. Set ground rules**. They help us feel safe.
- **4. Expect more from the public.** Let us help make the hard choices. Let us be citizens, not just customers of government services.
- **5.** Let us work in small groups with other citizens. We want to hear from one another and have a dialogue with people who think differently.
- 6. As often as possible, **don't separate yourselves from citizens** up on a stage, but join us as peers.

Would our list look any different in the San Diego region? We invite you to join us in thinking creatively about civility as our group embarks on a collaborative book read that meets the qualifications of book group: available in kindle format, available in audio format and available in local libraries. We'll be making the selection within the next few weeks in preparation for discussion at the July meeting of the book group. Keep checking the League website for more information.

The County League's study of San Diego agriculture is proceeding apace with interviews of both officials and stakeholders. The primary purpose of the study is to assess the present and future of commercial farming in our county. Every League member will surely recognize how complex this topic is-- including as it does, attention to water and land use programs and regulations, the ever-present environmental concerns, and ultimately, crop sustainability in an area of limited resources.

Committee members are: Chair Peggy Dornish, Kathy Anderson, Mary Hanson, Diane Mochizuki, Anne Omsted, Anita Reith, Roni Seay, Nancy Telford, and Nan Valerio, to any one of whom members may direct questions and concerns as the study proceeds. Our "target" date is this coming fall for Local League general meetings and the subsequent recommendations to the County League.

It may be argued that agriculture in our county is unique in California: there are more organic crops grown here than elsewhere in the state. The Board of Supervisors strongly supports farming ventures into new areas, especially grape and wine production; and the "footprint" of farming with respect to land use still eludes a viable rationale for future development.

## LWVSDC (ILO) Update of San Diego County Mental Health Position

The ILO has concluded a half-year study of San Diego County's mental health program to update the 1997 LWV of San Diego County Mental Health Position. Key stakeholders were interviewed and dozens of documents were reviewed by the small but mighty committee led by Bettie Reinhardt. Findings will be presented at February unit meetings and members will learn about the County's progress in nine areas of care and services for patients with serious mental illness: regional care and case management; dually-diagnosed care; outreach programs; age-specific care; funding streams; shelter beds and housing; criminal justice system; law enforcement training; and community and partner input.

Since 1997, many improvements have been made, but hurdles remain. The recent integration of behavioral with physical health care, and mental health with substance abuse care, is good news countywide, but adequate Medi-Cal coverage for serious mental illness is still a challenge. Targeted outreach programs for vulnerable groups (i.e. older adults, homeless, and youth), and community support and partnerships (i.e. schools, faith groups, and law enforcement) have expanded as well, but many needs are still unmet in the areas of housing and inpatient beds, recovery and criminal justice support, and provider access to patient medical records. And the infusion of state funds from the Mental Health Services Act (Proposition 63), known as the millionaires' tax, introduced dozens of new programs in the past ten years, but coordination issues as well.

## Remembering Phyllis Rosenbaum

Longtime League member Phyllis Rosenbaum passed away at her home in Cardiff by the Sea, Calif., on Thursday, Jan. 8, 2015. She is survived by her husband, Sheldon,

daughter, Sharyn, son, David, brother, Barry and his wife, Jane, and many nieces, nephews, and cousins.

In 2011, Phyllis was profiled in an article in the *VOTER* describing her as quiet, intelligent, charming, and "so good at drawing out other people." Her many friends in League can attest to these qualities in Phyllis.

Phyllis first joined the LWV in the 1970s in Illinois; she joined our LWV in 2004 and was an active participant for many years. She served as observer to the San Dieguito High School District and was a San Dieguito Unit co-chair. She was a participant in the LWVUS Immigration Study, the LWVUS Education Study and the National Popular Vote Compact Study. Her research skills were a definite asset to any League study.

Phyllis was a member of the Civil Discourse Interest Group, volunteered for voter service activities during election times, and twice served on the LWV nominating committee. She was a founding member of the Media Monitors Issues Group.

A teacher for 23 years in Illinois, she received a Distinguished Teacher Award from Glenbrook North High School. After moving to Cardiff by the Sea in 1999, she continued to use her teaching skills in various ways, from being a coordinator at the Osher Lifelong Learning Institute at UC San Diego to tutoring international students. At Osher, Phyllis taught a class in modern and contemporary novels and facilitated a popular poetry class. Her literature class was always filled to capacity.

Our League was very fortunate to have such a remarkably talented member. Phyllis will be missed.

Rosella Heffner was a kind, capable, and caring person who is remembered for her great sense of humor. She was a wonderful support for her husband and fellow League member, Howard, who passed away in 2003.

Howard maintained the League Database, the League Directory, directed Unit Communications and actively supported Smart Voter.

Marilyn Voorhies was a long-time faithful member of the League. Those who knew her will miss her gentle intelligent presence.

## Facts about our Founder: Carrie Chapman Catt

On January 9th in 1859, Carrie Chapman Catt was born in Wisconsin. While we all know that Carrie Catt fought tirelessly for women's suffrage both here and abroad and that she founded the League of Women Voters, here are some facts about this remarkable woman of which we may not be aware:

Originally interested in practicing medicine, <u>Catt</u> received a Bachelor of Science degree in general science in <u>1880</u>. She was the only woman in her class.

Before working in the suffrage movement, <u>Catt served as a teacher</u>, <u>principal and superintendent in Iowa</u>. Catt began her career as a political activist at the age of 27 <u>when she</u> joined the Iowa Woman Suffrage Association.

When her husband died in 1885, <u>Catt made a living by</u> becoming San Francisco's first female newspaper reporter.

By 1900, <u>Catt succeeded the 80-year-old activist Susan</u> B. Anthony as president of the National American Woman <u>Suffrage Association (NAWSA)</u>, the organizational predecessor to the League.

She served as president until 1904 when internal political issues within NAWSA caused her to take a break to advocate for the rights of women across the globe, not just in the U.S. As the president of NAWSA, she founded the International Woman Suffrage Alliance (IWSA).

Catt returned to NAWSA as president in 1915. Catt's relentless campaigning is <u>credited with helping win President Woodrow Wilson's respect and support</u> — which ultimately lead to the passage of the 19th Amendment.

Catt was <u>close friends with Eleanor Roosevelt</u>, a <u>fellow League leader</u> and women's rights pioneer.

In her later years, Catt advocated on behalf of working women and tirelessly lobbied for world peace efforts.

She supported efforts for both the League of Nations and the United Nation, the latter of which the League of Women Voters helped establish.

For decades throughout the women's suffrage movement, <u>Catt traveled across the country</u> to make speeches and lead parades. Even when she was in her late 70s, she remained an effective and impassioned speaker.

Carrie Catt described the League as a "mighty experiment". Nearly 95 years later the League is still a mighty experiment in making democracy work work through citizen education and engagement. No doubt, Mrs. Catt would be exceedingly proud of her legacy.


