League of Women Voters California November 2016 Election Debrief

Wow...just Wow...

Congratulations and thanks to all our Leagues for the tremendous voter service work performed in the November 2016 Election Season!

Face-to-face voter service work:

- 1. The LWVUS survey shows over 1,100 voter service events, including voter registration, Pros & Cons presentations, and candidate forums.
- 2. Requests for Pros & Cons presentations exceeded, sometimes far exceeded, normal numbers. Our League members waded through complex and numerous ballot propositions to give their listeners unbiased information in hundreds of presentations.
- 3. Leagues wrote their own voter guides, including pros and cons of local ballot measures.
- 4. Of course, there were numerous candidate forums and voter registration events by our Leagues.
- 5. Over 200,000 copies of the Easy Voter Guide were distributed throughout the state. This number does not reflect copies downloaded directly from the Easy Voter Guide website.

LWVC online presence:

- 1. Voter's Edge California's preliminary numbers show approximately 1.7 million visitors to the site looking at multiple pages during the combined primary and general election seasons. This is a thrilling achievement for all who worked on the site.
- 2. Voter's Edge California formed partnerships with a variety of public media and community groups including CA's four main PBS outlets, NBC and ABC affiliates, two Telemundo affiliates, the

ACLU, CA PTA, and CalPIRG (California Public Interest Research Group).

- 3. Voter's Edge also partnered with Mi Familia Vota, NALEO, the National Council of La Raza and other Spanish community groups.
- 4. Mi Familia Vota not only put the Voter's Edge widget on their website, they produced a <u>video</u> promoting the Easy Voter Guide.
- 5. Several county registrars placed the Voter's Edge widget on their websites.
- 6. Voter's Edge California contained Easy Voter Guide and the Pros & Cons in both English and Spanish.
- 7. Our Voter's Edge California (VEC) county and local coordinators contacted and cajoled 2,053 candidates (45% of all candidates) to place information on VEC so that the general public could learn who they are and what they stand for.
- 8. Our <u>CAVotes.org</u> site received 2 1/2 times the amount of traffic that it received in 2014.
- 9. The top five subjects accessed on <u>CAVotes.org</u> were the Pros & Cons of ballot measures, Prop 52 in particular, plus the basic voter information of how to register and how to vote by mail.

Please extend the gratitude of the LWVC Board of Directors to your team of voter service directors and volunteers. They carried out the mission and voter service strategy of the League of Women Voters in the best tradition of our 96 year old organization. Well done!

Foster Care Position Review

This year our local League has chosen to review in depth our position on Foster Care in Humboldt County.

Our position summary was developed in 1999: Support of services which prevent children from being placed in foster care, and which provide safe and supportive foster care when required.

I encourage you to open your annual meeting kit and review the Foster Care position. It's extensive and covers a variety of thoughts from support of the child to support of the staff involved.

Do you have questions that you want answered? With a firm and correct position in place, League can take a stand to influence government policy and make our community a better place to live.

What has changed? Is it still a good idea to support those services which attempt to keep the child with its parents or should foster care be the first choice? Has the increase in drug use made a difference in the foster care world? How great is the need in Humboldt County? Is it true that some persons go into foster care parenting for the money or is that another urban myth? How is foster care funded? Let's find the answers so we can influence public policy when needed.

We plan to host a panel of education, healthcare, public service individuals and parents who have been involved with foster care to hear what's happened in the 17 years since our League last studied foster care. We need to have a well-rounded panel of both government and private sector personalities to see the entire picture. The date we have set is February 16, 5:30 PM at the Aquatic Center.

Statistics from 2014 report 324 children in foster care in Humboldt County. Most stay in foster care homes for under a year. Over 50% were returned to family homes. Those who remain in foster care often live in five or more homes. Our panel will have more information and statistics to clarify the subject.

The Intersection of the Criminal Justice System and Mental Illness

On Wednesday, November 2, the League of Women Voters of Humboldt County and the National Alliance on Mental illness of Humboldt County presented a panel on the Intersection of the Criminal Justice System and Mental Illness. Despite being held at the same time as the final game of the 2016 World Series, over 100 people attended. The panel included Public Defender, Kevin Robinson; County Mental Health Clinical Psychologist, Mark Lamers; long time Chief Probation Officer, Bill Damiano; Eureka City Police Chief, Andy Mills; and District Attorney, Maggie Fleming.

The panel concluded that jail is no place for a person with a mental illness, and several alternatives were suggested: urgent care centers, intensive case management services, and crisis sanctuaries for those with mental illness who need a respite. In the past, Humboldt County has had a mental health court, and it may be time to try one again. The panelist agreed that adequate housing helps in the prevention of crime.

The audience was engaged and asked numerous questions. Unfortunately, the panel did not have time to respond to all questions. If you missed this event, you may watch the forum on Access Humboldt.

Access Humboldt -- Our Own Public Media Company

Access Humboldt is our community's very own home-produced television station, radio station, and online archive of public meetings. With major funding from Sudddenlink, under the mandate of the Public Utilities Commission, Access Humboldt provides four TV channels in northern Humboldt and one in southern Humboldt for education, civic affairs, and as a free outlet for local videographers.

Local schools, including College of the Redwoods, can use Channel 8 for educational purposes. Meetings of the Board of Supervisors, the Eureka City Council, the Arcata City Council, and the Harbor District are broadcast on Channel 10. Locally made creative videos are featured on Channels 11 and 12. When not running programming, Access Humboldt runs a community bulletin board on the channels.

Twenty dedicated fiber networks are already in place; Access Humboldt can broadcast live from any one of them. They are located in the council and board chambers where public meetings occur, at the Municipal Auditorium, and many other places throughout the county.

These multiple networks are useful for allowing live community participation at some public meetings, without participants having to go very far. For example, during county budget hearings, interaction sites were set up at five different locations, so that people could talk directly to the Board of Supervisors-- and everyone else who was watching.

Access Humboldt has recently introduced a new FM radio station, KZZH-FM -LP at 96.7, which plays recorded public meetings. If you want to hear your local news in depth, this is the station to listen to! Between meetings, KZZH sometimes plays works created by local students. Because this is a low-power station, its reach is limited to Eureka, Arcata, and McKinleyville, although I can pick it up in my driveway in Westhaven!

Access Humboldt also has a very complete website at www.accesshumboldt.net where all its programs are archived. If you need to watch a meeting that occurred three weeks -- or three years ago---you can find it there.

The website is also linked to similar public access stations from all over the nation. Look up your hometown -- if it has a public access station, you can link to it from Access Humboldt's website, and find out what the folks there are doing. It is also linked to internetarchive.org, a non-profit which strives to be the "universal access to all human knowledge" and currently has nearly a quarter of a million videos. It's an interesting place to surf -- you can see some really amazing stuff there, including TED talks, the Big History Project, and PopTech.

Access Humboldt is also a teaching center. In a world where electronic communication is the primary means of spreading information, people can learn how to create, edit, and broadcast their own video productions. Access Humboldt has a complete high-definition TV studio at their central location on the campus of Eureka High School. Equipment can also be checked out for work in the field. You can go out and record an event, then

come back to the station and edit it yourself. You can animate your own graphics. If you have other media that you want to include in your production, the studio also has CD/DVD players, tape players, and even turntables. If you want to stage an event in the studio, you can reserve it and use it. When everything is done, you fill out a form, hand your DVD over to the staff, and they will put it on the air. In addition, Humboldt residents who create their own videos and upload them to You-tube can send the links to Access Humboldt for broadcasting on the local channels.

Of course, you must know how to use all this equipment, and you can learn by becoming a member and taking a few classes at the studio. Classes are given twice a month and a small fee is charged, in addition to the initial membership fee.

Access Humboldt is especially interested in teaching the next generation these essential skills, and works closely with Eureka High School, HSU, College of the Redwoods, the County Dept. of Human Services, the Arcata Arts Institute, and the Eel River Multi-generational Project to achieve this. They are also planning to work with the *Times Standard* to teach reporters how to do online reporting.

Media creators are encouraged -- but not required -- to use a "Creative Commons" copyright, which allows them to keep their basic right to their work while allowing others some rights to use the work.

Access Humboldt believes strongly in free speech, and they do not edit or censor anything that is given to them. They do require the creator to sign a form taking full responsibility for libel. The only restriction is that if a video contains "adult" material, the creators are required to indicate this, and then it is played only during "safe hours" in the middle of the night.

Access Humboldt also serves as a communication center for the creative community, bringing together local people who have skills and know-how to produce non-commercial media projects. If you write, design web pages, perform, edit, create videos, or have stage skills, you may want to connect with this group called the Humboldt Interactive Pool or HIP.

Access Humboldt and the League have long worked together. The League was instrumental in Access Humboldt's formation, and Access Humboldt has recorded and broadcast many of the League's forums.

Access Humboldt has 232 members. This year, Access Humboldt has broadcast more than 500 hours of local programming. Orientation sessions on Access Humboldt's activities and facilities are offered free to the public every second Saturday of the month.

In addition to all this, Access Humboldt acts as a watchdog for public access to TV channels both at the state and at the federal levels. Page 6 THE VOTER January 2017
