Public Policy Luncheon Thursday, January 16, 2014 – 11:45 AM "Update on Gun Control Legislation" and

"Overview of Important Issues for the 2014 Legislation Session"

Two timely topics will be the focus of our first Public Policy Luncheon for the New Year. **Erin Dando of the South Carolina Chapter of** *Moms Demand Action* will begin with an update on gun control and pending gun legislation before the S.C. General Assembly. In particular, Erin will address Senate Bill 308 allowing guns in bars and restaurants.

Much as Mothers Against Drunk Driving was created to reduce drunk driving, Moms Demand Action for Gun Sense in America was created to demand action from legislators, companies, and educational institutions to establish common-sense gun reforms. A non-partisan grassroots movement of American mothers demanding new and stronger solutions to lax gun laws, the group supports the 2nd Amendment, but believes commonsense solutions can help decrease escalating gun violence. (Data show that gun violence kills one American child every 3 hours and 15 minutes.) See www.momsdemandaction.org for more information.

Lynn Teague, VP, Issues and Action, LWVSC, will give an overview of important issues for the 2014 legislative session. In particular, Lynn will outline the current status of pending state ethics legislation, a major concern of the LWVSC.

"Old" MacDonald Had a Farm, E-I-E-I-O"...and it WASN'T a giant potato farm!

In early December, Commissioner of Agriculture Hugh Weathers recognized the value of small farms

to South Carolina's future, noting "as more consumers buy local, we need to not only meet that demand, but we must also capitalize on it."

NOVEMBER PUBLIC POLICY LUNCHEON SUMMARY

With the many topics that we've covered already this year, including the Richland



County Library Bond Referendum and Public Transit, it makes one wonder how farming and foraging fit. We, as an organization, address a variety and a multitude of topics. At the national level in early 2014, The League of Women Voters will be studying an update on current technology and finance issues directly related to agriculture. The topic for the November PPL perfectly complements the national study on agriculture.

Even the caterer for the luncheon, "Gourmet Rose," got into the theme by serving locally grown organic produce for our salad entree.

Marzi Knight introduced both of our speakers with whom she has worked and studied. **Eric McClam**, a graduate of Tulane University School of Architecture, is Farm Manager of City Roots, South Carolina's first urban farm, certified organic, and recognized as one of five in the world. Eric used his architectural skills, along with those of his father Robbie McClam, an established Columbia Architect, to design a passive solar building at their location, 1005 Airport Boulevard, near Owen's Field and adjacent to the Rosewood neighborhood.

The farm uses "old-fashioned" as well as "new-fangled" ideas of composting and aquaponics. The farm recycles materials and by-products from many different sources. The year-round produce varies widely by season from microgreens, greens of all kinds, blueberries, strawberries, blackberries, as well as fish and eggs. Many restaurants, organic grocery stores, and individuals are regular customers. The Community Supported Agriculture Program (CSA), in which subscribers pay up-front for a share of the crops produced each week, is very popular. And you can join!

Our second speaker, **Matthew "Matt" Kip**, is a Certified Permaculture Expert, having studied in the US as well as abroad. He was first influenced by a neighbor who took him out to the forest to show him how he could gather enough food for dinner. Permaculture respects the environment's need for sustainability. Matt encouraged us to learn to grow our own food in this way that nourishes healthy soil. He teaches the classes, offers tours of gardens that are outstanding examples right here in Columbia, SC, and is available to advise. His web site is <u>www.MatthewKip.com</u>
