"Fighting for Low Income South Carolinians – Filling the Healthcare Gap and Fixing DSS"

Sue Berkowitz, Director, South Carolina Appleseed Legal Justice Center



Sue Berkowitz is an attorney and Director of the South Carolina Appleseed Legal Justice Center. SC Appleseed is dedicated to advocacy for low income people in SC to effect systemic change by acting in and through the courts, legislature, administrative agencies, community and the media, and helping others do the same through education, training, and co-counseling. She will speak to us about filling the healthcare gap

(f/k/a Medicaid Expansion or "ME") and the proposed restructuring of the Department of Social Services.

Sue has focused her practice in the areas of health, welfare, hunger and consumer issues. She has worked on the passage of numerous pieces of legislation, including the eligibility increase for the State Children's Health Insurance Program (2007), the High Cost and Consumer Home Loan Act of 2003 and the Family Independence Act of 1995. Sue works with a number of state agencies on policy issues that impact the low income community including changes to Family Independence, Medicaid and Food Stamp rules. She has authored defenses to the foreclosure chapter for a manual produced by the South Carolina Bar. Sue was awarded the Order of Palmetto and the Woman of Achievement Award by the SC Commission on Women for her work on predatory lending and poverty issues.

Happy New Year! As we close out 2014 and as 2015 begins, it seems like a great time to reflect what the Columbia Area League has accomplished and share the plans we have to finish the fiscal year.

Reflections of Fall 2014 -

Voter Services — We co-sponsored and conducted a forum for the Richland District 2 school board candidates and agreed to be a partner in a voter advocacy network initiative sponsored by the State League. As part of that initiative I volunteered to attend and observe the hearing for certifying the election results for Richland County. A guest editorial written by me on behalf of the Columbia Area League on preparing to vote was printed in the *State* newspaper, and Rosalyn Glenn and I appeared on Meaghan Norman's Sunday morning community affairs program to talk about the importance of voting and barriers to voting. Barbara Brown from the Sumter League joined me in passing out voter registration forms and voter information materials to newly sworn in citizens at a Naturalization Ceremony conducted at the Congaree National Park.

Public Education – We continued our long tradition of presenting educational forums on issues through our monthly Public Policy Luncheons. Featured guest speakers spoke to us on a range of issues, including the homeless in the Midlands, the scientific truth on climate change, and legislative issues facing SC women in making reproductive choices.

Membership — To promote involvement of current members we initiated a "Call to Service" to recruit members to actively participate in their League and we are working to resuscitate the LWVCA Speakers Bureau. Our annual member & guest socials were held in August and December and Suzanne and Curtis Rhodes continued the LWVCA's Purple Martin tradition by hosting a pontoon ride to view the birds. To promote the League and League membership I made presentations on the League — who we are and what we do — for two community organizations. Marzi Knight and I also attended a networking event hosted by PASO to share ideas and engage in dialogue about improving healthcare access and outcomes for Latino families living in SC.

Plans for Spring 2015 -

Voter Services – As part of the State League's voter advocacy network initiative, we will offer a regional voter education meeting in one of the Region 4 counties in partnership with local voter advocacy groups to educate voters regarding voting laws and their rights, to register voters, and to involve voters with the election process in their county.

Public Education – The Public Policy Luncheons for January through March will feature speakers on the healthcare gap and fixing DSS, African American Women in history, and mistreatment of inmates with mental illness. In keeping with tradition for our April PPL, we are planning a fun, but educational, visit to the new planetarium and 4-D Movie Theater at the state museum.

Membership - League Education and Advocacy Day ("LEAD Day") will be held on January 31 and the biennial State convention will be held in April in Hilton Head. The Annual Meeting will be held in May.

Program – We plan to hold our annual program planning meeting on February 10. At this important meeting members will have an opportunity to suggest, discuss, and recommend League programs at the local and State

level. For all the services, events and activities we conduct or provide, in the end all of our success is a result of our members' hard work and support. You are the League's most valuable asset, and working together we can make a difference. Thank you for all you do.

Before I sign off, my very special thanks go out to Pat Forbis and her husband Joel for hosting the Holiday Member & Guest Social at their wonderful home. It was a great way to help celebrate the holidays.

PROGRAM PLANNING - LWV Columbia plans to hold its annual program planning meeting on February 10 at Arabesque Restaurant, 2930 Devine Street (in same plaza as ZaZa's Pizza). Participants can order dinner and drinks from the menu and pay by separate check. Dinner service begins at 5PM and the meeting will start at 6PM. This year we will consider what, if any, state and local public policy issues we want to study. Formal adoption of a local issue for study is done by Columbia Area League members at the Annual Meeting in May. In order to guarantee that our program planning is genuinely grassroots, it is important that we have maximum participation in the process from our members.

BACKGROUND: In odd-numbered years, Local Leagues participate in the LWVSC Program Planning (alternating with LWVUS Program Planning). Local Leagues, however, can review existing positions and make recommendations on local issues every year. One of the highlights of the state convention in April 2015 will be the adoption of the state program that will set the course for advocacy and education in SC. At the program planning meeting you will be given the opportunity to review existing state and local public policy positions and to select the issues in which you would like the League to invest time, talent, energy, and money.

S.C. SUPREME COURT RULES IN ENVIRONMENTALISTS' FAVOR IN CAPTAIN

SAMS SPIT CASE - Southern Environmental Law Project is savoring this victory, but the Developer vows to continue the fight in the Administrative Law Court, where the Supreme Court remanded the case.

Writing for the majority, Justice Hearn called Captain Sam's Spit "one of this State's natural treasures." The Court's legal ruling is here.

CONSERVATION GROUPS REACH SETTLEMENT AGREEMENT WITH SOUTH

CAROLINA UTILITIES ON NET METERING - Conservation groups, represented by the Southern Environmental Law Center, filed a settlement agreement with utilities and other intervening parties in the South Carolina net energy metering (NEM) proceeding before the SC Public Service Commission (PSC).

The settlement agreement is a critical step forward in implementing South Carolina's recently adopted Act 236, which laid the groundwork for residents and other nonprofits to begin to capitalize on the state's significant solar potential.

Under the settlement, residential and commercial utility customers that install solar panels on their rooftops before 2021, when the settlement agreement expires, will receive full retail credit for any excess power that flows back onto the electric grid, and will be eligible to remain on this rate until December 31, 2025 without any solar-specific charges or fees.

MINING - The state Sierra Club took legal action to force stricter controls on the largest gold mine ever proposed for South Carolina, saying the industrial scale operation could leave the public on the hook for a pollution cleanup long after the mine shuts down. Elected officials have expressed their disappointment and have said the appeal could jeopardize jobs.
