FIRST FRIDAY FORUM, JANUARY 7, 2022: 2021 REDISTRICTING IN MASSACHUSETTS

At our January First Friday Forum, beginning at 9:30 am on Zoom, the League will host **Will Brownsberger**, President Pro Tempore of the Massachusetts Senate and Chair of the Senate Committee on Redistricting, to discuss the challenges faced in redrawing voter districts across the state. Presenting an intellectual road map for redistricting, he will address the elements that contribute to better representation of constituencies. Senator Brownsberger has represented Second Suffolk and Middlesex Districts (Belmont, Watertown, parts of Boston) in the Senate since 2012, and previously served as a State Representative from 2007 to 2012. He also serves on the Senate Committee on Bills in the Third Reading, and on the Senate and Joint Committees on Rules. There will be time for questions after his presentation.

This program is the fourth in the 2021-2022 First Friday Forum series hosted by the League of Women Voters to promote awareness and understanding of public policy issues. OPENINGS FOR LEGISLATIVE ENVOYS

A large part of the state League's advocacy work is conducted through direct contacts with our legislators by topic Specialists and member activists. Throughout the legislative year they monitor bills of specific interest to the LWV and advocate for passage or amendment. The information link between this ongoing work and local Leagues is provided by Legislative Envoys, who keep members apprised of the progress of bills and provide feedback from members to our League representatives on Beacon Hill. Envoys are connected to the LWVMA Legislative Action Committee for periodic updates and receive training in the Massachusetts legislative process and best practices for advocacy. Like League topic specialists, Envoys develop a working relationship with State Senators and Representatives and track the progress of League priorities in the Legislature. ACTION ON CLIMATE CHANGE

In March 2021, after long and determined advocacy by our own Senator Mike Barrett, the Massachusetts legislature passed milestone legislation setting out a "road map" and time table for the reduction of greenhouse gas emissions over the next 30 years and the development of clean energy sources in our state. As always, the key is implementation, which has been predictably slow.

With the fate of the federal Build Back Better Act uncertain, it is all the more important to take action at the state level. League-supported bills dealing with implementation actions are currently in committee, and must be reported out by February 2 to stay alive. Below is a list of League priority bills, all currently in the Joint Committee on Telecommunications, Utilities and Energy (TUE). Please call or email our legislators to urge them to report these bills out before the deadline. (See contact information at end of this Bulletin.)

<u>H.3302</u>: An Act to promote offshore wind energy and renewables and <u>S.2155</u>: An Act relative to enhancing reliability of renewable resources in the Commonwealth (Same bill; different titles).

A clean energy future depends on a clean source of energy. The New England coast has a bountiful supply of wind energy, and boosting clean renewable energy sources will boost efforts to decarbonize our economy.

<u>H.3350/S.2202</u>: An Act relative to building energy and decarbonization Buildings represent the second largest source of greenhouse gas emissions, a close second to emissions from transportation. Massachusetts is way behind in reaching its goal to decarbonize the building sector and needs to significantly ramp up its efforts around energy efficiency of new and existing buildings and electrification of the building sector.

<u>H.3298/S.2148</u>: An Act relative to the future of heat in the Commonwealth This bill offers a path forward for gas utilities by allowing them to become clean energy distribution utilities as they transition off gas. Several pilots have already been approved, and major cities are asking for pilots in their jurisdictions.

ACTION ON BASIC HUMAN SERVICES

<u>Bills in Committee</u>. Three small but consequential bills need support. Please contact the committee chairs for each bill and request that the bill be voted swiftly and favorably out of committee.

Bills Seeking Co-sponsors. A Right to Counsel bill (<u>S.874/H.1436</u>), which is currently in the Joint Committee on Housing, would ensure that when facing eviction, low-income tenants and owner-occupants of 1 to 3 family homes receive full legal representation. Representative Michelle Ciccolo is a co-sponsor of this bill. Please urge Senator Mike Barrett and Senator Cindy Friedman to co-sponsor it as well. The League submitted written testimony noting the devastating effects of evictions on women, particularly mothers and women of color, and the relief that a right to counsel program could provide. UPDATE ON OTHER LEAGUE SUPPORTED BILLS

Signed into law by Governor:

H.715/S.298—An act to promote student nutrition October 14, 2021. This law outlines how schools handle student meal debt.

Bills passing one chamber:

<u>S.2554</u>—The VOTES Act, passed the Senate and is in the House Ways & Means Committee.

Bills referred to House Ways and Means:

<u>H.1290</u>—An Act to streamline access to critical public health and safety-net programs through common applications.

H.3157—An Act to ensure gender parity on public boards and commissions 12/30/21'

Bills referred to Senate Ways and Means:

<u>S.2077</u>—An Act to ensure gender parity on public boards and commissions 12/27/21.
