OCTOBER FIRST FRIDAY, OCTOBER 2, 2020, PRESENTS VOTING UPDATE

The 2020 federal election looms. Voters will select the United States President/Vice President, all of the House of Representatives, one-third of the United States Senate, and many state offices, including Lexington's State Senators and Representative. There are also two ballot questions. The COVID-19 pandemic has resulted in new voting regulations across the country. In July, Governor Baker signed into law new procedures passed by the Massachusetts legislature to facilitate safe voting, and they received their first test in the state primary contests in September.

On October 2, 2020, at 9:30 am via Zoom, the LWV Lexington First Friday Forum will present a Voting 2020 Update. Town Clerk Nathalie Rice will provide up-to-date information about voting in Lexington, including (a) voting by mail; (b) early voting, available October 17-30; and (c) in-person voting. We'll hear about local voter turnout in the September 1 primary. (Spoiler Alert: it was high.) The program will emphasize lessons learned from the primary election, and how we can assure that each of our votes is counted in November. There will be a Q&A session after the program.


This program is the first in the 2020-2021 First Friday Forum series hosted by the League of Women Voters to promote awareness and understanding of public policy issues with local implications. She is the co-editor of the award-winning *Education, Justice, and Democracy* (2013, with Robert Reich.

VOTE411 Updated for November Election!

Find Massachusetts' candidate and election information for the Nov. 3 general election at <u>VOTE411.org</u>, the League's national online voters' guide. The guide has been updated since the Sept. 1 primary. <u>VOTE411</u> covers all candidate races from U.S. Congress through state legislator and contested county races. Information on the two state ballot questions is also included.

LWVMA has worked diligently to encourage Massachusetts candidates to respond to the questionnaire. If you find that any candidate in your district has not responded, please reach out and encourage them to complete the questionnaire; it is not too late. Contact tgrenga@lwvma.org for a questionnaire link that can be forwarded to a particular candidate.

LWVUS has partnered with the National Association of Broadcasters to launch a voter education campaign featuring public service announcements (PSAs) about voting and VOTE411. This campaign began airing on TV and radio stations nationwide in August and will run through Election Day.

Remember, early in-person voting is available in Massachusetts from October 13 -30.

ELECTION PROTECTION WORK

LWVMA is partnering again this year with Lawyers for Civil Rights to make sure the November election runs smoothly and fairly. There are three options for volunteering this year:

- Statewide hotline: Troubleshoot election-day issues from your home
- Mobile field program: Independently observe multiple polling locations for outdoor violations
- Social media and news monitoring: Monitor news and social media platforms to report election-day issues

POLL WORKERS NEEDED

Many cities and towns are in critical need of poll workers, especially those who are bilingual. The new elections law allows municipalities to hire poll workers regardless of where they live, their voter registration status, or political party affiliation.

If you are interested, contact town clerks/local election officials about their needs, especially in larger cities. Check the Secretary of State's website https://www.sec.state.ma.us/ to see where poll workers are needed. Keep in mind that young people, including college students, are prime candidates to work at the polls, given their more flexible schedules this fall.

LWVMA STATEMENT ON THE NOMINATION OF A NEW SUPREME COURT JUSTICE

The U.S. Senate must prioritize protecting the American People during the pandemic and securing our 2020 Elections.

WASHINGTON - League of Women Voters board president Deborah Turner and CEO Virginia Kase issued the following joint statement on rushing the Supreme Court appointment process:

"Four years ago, Senate leaders set a precedent for how the confirmation process for a Supreme Court justice appointee should occur during a presidential election year. In 2016, a Supreme Court seat sat vacant for more than 300 days, showing that there is no reason to rush this process in 2020. If it was too soon then, it's too soon now.

"The American people are in despair during this global pandemic: millions are out of work and more than 200,000 have lost their lives to this deadly virus. It is the duty of our elected officials to provide relief to the American people and ensure all voters can participate in our democracy by safely casting their votes this year.

"Supreme Court justices serve for life and make decisions that impact every American. They require a thorough vetting process that is transparent to the American people. Such a process would be undermined if rushed through.

"Now is not the time to rush a lifetime appointment to the United States Supreme Court."
