# School Funding in CA Headed for Historic Changes

For the first time in 40 years, the process of funding of California's public schools will be changing. When voters passed Proposition 98, they voted to ensure the public schools in California would be guaranteed a minimum funding level of at least 40% of the state's annual general fund. These funds have historically been divvied up by the state to the various educational agencies (school districts, charter schools, and County Offices of Education) using a formula that included over 120 different state-mandated programs.

This year, the state legislature passed a new funding model called Local Control Funding Formula, or LCFF.

With the help of educational stakeholders from all over California, they voted to simplify the state's incredibly complex funding formula and to push more of the decision-making for that funding to the local level. In addition to a handful of federally-mandated programs, the state will now fund just seven broad areas of focus. They will leave many of the decisions as to where that money is to be spent up to the discretion of the local school boards and their communities, with accountability guidance from the state.

The theory behind this massive shift is that those closest to the schools – local citizens, community stakeholders, parents, administrators, teachers, and staff – are better equipped to know what their school district's funding priorities should be. Now, more than ever, is the time for local voters and citizens to become more actively involved in their local school district's budget planning processes. ## **President's Message**

Positions, Action, Advocacy, Voter Service, Voter Education, Community Presentations How do we differentiate?

We've all heard these League buzz words over and over but sometimes it

is hard to make a distinction between Voter Service and Advocacy. What happens when we give a community talk about a subject that the League has a position on — is it still part of Voter Service and supported by our 501(c)3 Ed Fund, or because League supports it, are we now presenting an Action Item?

Although many times this differentiation has to be looked at on a case-by-case basis, there are some general rules of the road to guide us. In Voter Service/Citizen Education, we present unbiased nonpartisan information about elections, the voting process, and issues. We're all very familiar with our Voter Service activities during an election – Pros and Cons, Candidate Forums, and Voter Registration but public education should be all year round. It should encompass all of the other issue-related or processrelated activities that Leagues undertake to help members and the public understand and participate in government and politics. For example, the League can sponsor or co-sponsor meetings on government operations, the political process, or a hot issue. It can work alone or with other groups to explore these issues or provide political know-how about testifying, petitioning, or any other technique for getting something done in the community. It can also present educational forums about issues on which the League has a position, provided that the discussions focus on issues of concern rather than the merits of specific pieces of legislation. No lobbying takes place and no call to action is issued.

We'll address the other side of the equation in next month's VOTER. For example, when do we issue a Call to Action? Are Action and Advocacy the same thing? Where do League positions fit in? Under what circumstances do we lobby? Who decides?

# Movement Toward Deliberative Democracy

Ripples continue to spread from the League's cosponsored July 8<sup>th</sup> event at the Scripps Ranch Library, *What Kind of Talk Does Democracy Need?* featuring Dr. Martin Carcasson of the Center for Public Deliberation at Colorado State University.

A group of local academics, the League, and BH Kim of the San Diego Foundation's Center for Civic Engagement have met three times by conference call since the pebble was dropped by Dr. Carcasson. The group's focus is how the concepts and curriculum of deliberative dialogue could spread in our region. Thanks to an introduction by Dr. Carcasson, the Kettering Foundation, a leader in this field for over 30 years, has joined these conversations.

Two immediate possibilities are being explored by the group: adapting Dr. Carcasson's curriculum at local colleges and universities and sending representatives from the San Diego region to Kettering's Center for Public Life research center for four 2-day workshops held over a year beginning February 2014 in Dayton, Ohio.

So far, the group consists of representatives from SDSU, CSUSM, USD, UCSD, the San Diego Community College District, the Center for Civic Engagement, and the San Diego City and North County League of Women Voters.

By its ongoing support, the League's Civil Discourse group will make sure the ripples continue.

## **Observer Corps Wants YOU!**

Our local League long has prided itself in our outstanding Corps of Observers. Known as "the eyes and ears of the League" it has won awards and praise at the LWV California state conventions. New members initially may feel intimidated by discussions in which League members often can display a rich background of information. Well, many of those same League leaders have "been there" as new members and so began their League involvement as observers!

Great news! Becoming an observer requires NO advance knowledge or expertise. Yet, there are few jobs more absolutely essential to our effectiveness in our communities. More great news! We have begun to make it easier and easier to do.

What does an observer do, exactly? Our observers attend public meetings of boards and agencies wearing a "LWV Observer" ID. They DO NOT speak or advocate at the meeting. They simply record the actions and discussions they observe. Twice each year, they report their observations to their Unit at an Observer Reports meeting (a most popular meeting!) If they observe something happening in a meeting that they feel needs to be reported to their League immediately, they inform the observer chair so that our LWVNCSD may respond quickly.

We need observers for a number of important boards and agencies and would like a "no pressure" chance to talk to YOU about the observer program.

## League Prepares to Launch New Approach to **Online Voter Information**

Big changes are coming soon to the Internet near you! Building on last fall's successful test of Smart Voter's new "Next Generation" web technology, the state League is poised to launch a brand new way of engaging and informing California voters online.

The new approach is expected to incorporate the most current techniques from both online journalism and interactive web technology to create a completely new experience for the 24 million Californians who will be eligible to vote in 2014. Regular updates and news stories based on some of the best coverage and analysis of election-related subjects in the Golden State will be featured at the completelyredesigned Smart Voter® website, along with the award-winning personal ballot lookup that California voters have used for more than fifteen vears.

Visitors will be able to enjoy a robust range of streaming videos, audio clips, interactive graphics and carefully selected stories about upcoming election issues and contests, ballot measures and changes to the voting process. By spearheading these capabilities to expand and innovate in how we will provide voter service, the leadership of Smart Voter® hopes to ensure that local Leagues throughout California will have the tools to be a vital source for voters well into the 21st century.

## News from LWVUS...

The U.S. Supreme Court is set to begin hearing cases in its fall term this month. On the second day of arguments, a case that has been labeled the "next Citizens United" will be heard by the Justices. The case, McCutcheon v. Federal Election Commission (FEC), challenges aggregate spending limits that are imposed on individual donors in order to prevent corruption and the appearance of corruption. Individuals can donate \$2,600 per election to a federal candidate, \$32,400 to a national party committee and up to \$5,000 to a non-party political action committee (PAC). But in addition, there is an aggregate contribution limit of \$123,200 on the total amount that an individual can donate to candidates and party or non-party political committees over a two year period.



Removing the aggregate limits on contributions would allow an unlimited amount of money to be contributed by one person to federal candidates. And it would allow an officeholder or candidate to solicit an unlimited contribution for distribution to a number of candidates.

The League has joined an amicus brief in this case. The brief argues two basic points. First, overturning the aggregate limit would ignore the real world effects that abolishing the limits would have. Overturning the aggregate limit would essentially allow individuals to donate millions of dollars to candidates and political parties and corrupt our political system. Second, abolishing aggregate limits would allow the party and PAC systems to become a funnel for candidates across the country and circumvent the other existing limits.

At its meeting on September 13th, the board heard a report on the acquisition of a storage unit to house the League's equipment and files. Barbara Lorenzen is preparing an inventory list and tracking system to monitor the status of where things are.

The board voted to explore partnering with the Oceanside Charitable Foundation in a presentation on their work and how to publicize it. This could be a perfect opportunity to put into use the techniques the Civil Discourse group has been developing.


