"Read to Succeed" – 3rd Grade Retention Issues

Baron Holmes, Ph.D., currently works with the USC Children's Law Center where he provides staff research support to the Joint Citizens and Legislative Committee on Children. He has also worked with the SC Budget and Control Board/Office of Research and Statistics and as Director for SC Kids Count and the SC Middle Grades Project. His work led to the drafting of the "Read to Succeed" bill (S 516) currently under consideration by the Legislature. His continued research focuses on linking children



from birth through young adulthood to determine the risk factors and program participation associated with academic achievement, risk behaviors, and workforce readiness.

"Read to Succeed" is an initiative, promoted by Gov. Haley in her State of the State address, to intervene with children who are not reading at

grade level by the end of third grade—a predictor that they will have continued problems in school.

TRY AGAIN ON ETHICS REFORM!

If at first you don't succeed - try, try again.* After more than a year of study and recommendations by special ethics reform committees, followed by hearings in General Assembly subcommittees and committees, a comprehensive ethics reform bill (H.3945) made it to the Senate floor in the form of the "working group" amendment developed by Senator Chip Campsen and others. This version of the bill provided for independent investigation of complaints against members of the General Assembly by a restructured Ethics Commission. It was not the ideal fully independent (continued on p. 2)

solution that the League of Women Voters supported in our initial recommendations in December 2012. However, it was a very good solution, one developed thoughtfully and with attention to both practical and constitutional issues. It provided oversight reform that would have made a great improvement on the current system in which conflicts of interest and institutional relationships have produced unreliable, inconsistent, and generally inadequate enforcement of ethics laws. Let no one deceive you. The current system serves only the interests of the politicians who hide behind it. The citizens of South Carolina at present have no reliably effective recourse when legislators become corrupt. Unfortunately, the bill was "on the Senate floor" in only the most technical sense. Debate was limited, and no public vote was taken. As **Cindi Scoppe** noted in her February 23rd article in *The State*, titled "We Could Call It the Oversight Oversight, If It Weren't a Studied Decision". . "We've never had a public vote on that part of the ethics reform bill or any part of it. Or even a real debate. What we've had are closed-door meetings, as senators tried to work out a grand compromise that they could present as a done deal." As Ms. Scoppe went on to note, there are good reasons for some behind-the-scenes negotiation, but in this case the process served to avoid accountability on an issue that is very important to the people of South Carolina. In the end there was no grand compromise. *There was failure*.

Yes, there are good and indeed necessary things in the remaining bill, such as disclosure of private income sources. However, reform falls far short of what is needed without independent investigation. This is not just the opinion of the League of Women Voters and its allies. A February 21st article in the *Post & Courier* by Jeremy Borden quotes **Senator Vincent Sheheen**: "Sen. Vincent Sheheen, D-Camden, said that he plans to prolong the debate next week and offer several amendments. He said he's not sure how "historic" the ethics reform bill is without an independent panel to investigate lawmakers and full income disclosure, which would include the amounts, not just the source of lawmakers' private funds, he said. "I call this an improvement," he said.

The most important amendment that could be offered by Senator Sheheen, or by anyone, would be one that identifies an independent investigation solution that the majority of both Democrats and Republicans will accept. With that, we would be much closer to having the genuinely historic ethics reform that the General Assembly owes to the citizens of South Carolina. Other refinements might be nice, but would never have the importance of this one. POLLUTION OF OUR CREEKS: You may often see *The State* newspaper or *Free Times* articles about the quality of Gills Creek, Rocky Branch, and other waterways in Columbia. However, other Columbia area creeks with pollution problems get little attention. This includes Kinley Creek and Stoop Creek in the St. Andrews and Bush River Roads area. Both are valuable biological and recreational resources but are degraded. They are heavily polluted, especially after rainfall. Here's a summary of what DHEC says about Kinley Creek and pretty much the same about Stoops Creek:

Kinley Creek – Studies of aquatic life show biological communities are degraded and dissolved oxygen levels are getting worse. Health standards for protection of recreational users are not being met because of high levels of fecal bacteria. Storm water runoff, leaking sewer lines, and sewer system overflows contribute to the poor conditions.

Rawls Creek is another polluted waterway in the general region and drains the Irmo area. The problems are the same as those in Kinley and Stoop Creeks.

There is also an undesirable discharge of sewage at the Saluda Shoals Park overlook of the Lower Saluda River right next to a boat ramp used by kayakers and swimmers. One can see this sewage waste bubbling up as one unsuspectingly floats by it. Decades of plans to remove this discharge have run up against political barriers. There is not even a warning sign for river users as they swim or float by this discharge.

All these problems have existed for decades with little to no improvement and citizens, politicians, and environmental organizations have been lax in demanding change.

MESSAGE FROM LWVUS: The IRS has proposed very significant changes in the regulations that govern what kind of political activity and how much of that activity a Section 501(c)(4) organization can carry out. This is important for two reasons: 1) it is a tremendous opportunity to rein in the secret "dark money" that

has been polluting our elections since the Supreme Court's decision in *Citizens United*, and 2) the current proposal would significantly undermine the League's ability to conduct truly nonpartisan voter service activities across the country.

The LWVUS has submitted comments to the IRS on the proposal, which can be found <u>*HERE*</u>.

It would be very helpful if you would submit comments on behalf of yourself. Only the State and Local Presidents can comment for the League; you are urged to speak for yourself.

Reforming IRS regulations is a critical opportunity to respond to *Citizens United*, which allowed political operatives to raise and spend unlimited amounts of secret money in candidate elections. By stopping 501(c)(4) organizations from spending on "candidate-related political activity," the IRS can stop this abuse of (c)(4) organizations in its tracks.

For 94 years the League has played a unique role in our elections by providing truly nonpartisan voter services and information to voters across the country. Unfortunately, the IRS proposal as it stands would jeopardize our work because it does not provide any exception for truly nonpartisan voter service activities like those carried out by the League. This is a terrible mistake, both for voters and for our democracy.

Please make some or all of the key points listed below and send them to the IRS:

1) Truly nonpartisan voter service activity must be allowed. The proposed IRS definition of "candidate-related political activity" errs by including truly nonpartisan voter service activities by organizations like the League.

2) The "dark money" system must be stopped, and the exploitation of the 501(c)(4) status by organizations that intervene in candidate elections must be eliminated. The IRS should prohibit "candidate-related political activity" by 501(c)(4)organizations.

3) The IRS should ensure that other 501(c) organizations don't become a new vehicle for groups to hide the sources of vast sums spent on candidate elections.

4) Since any organization or group of individuals can form a tax-exempt 527 organization, the elimination of "candidate-related political activity" by 501(c) groups does not ban any activity, it simply directs funds to a 527, where they are disclosed.

5) Candidate-related political activity" should be defined as:

a) mass paid public communications, such as broadcast advertising, phone banking, mass mailings, outgoing mass electronic messages, and mass leaflets

b) the use of the name or likeness of a candidate or otherwise clearly identify a candidate or political party.

6) "Candidate-related political activity" should not include taking a position on or advocating for a ballot initiative or referendum.

FEBRUARY LUNCHEON HIGHLIGHTS

Do you think about what happens to your trash after it leaves your home? Most people don't, and neither should you. What you do need to think about is what other states are doing with their trash because those other states are dumping their trash on you.

Our guest speaker was Shawn Drury, Field Director for the Conservation Voters of South Carolina (CVSC). You might have seen their "Don't Dump on South Carolina" media campaign, which has included ads on television and an on-line presence. This is part of a coalition of which the LWVSC is a member. The coalition is fighting against House bill 3290, known as the Business Freedom to Choose Act, which would remove counties' ability to control the flow of trash. At present, it costs New York State \$140/ton to dump trash in its own state, but only \$40/ton to dump it in South Carolina. There are 17 landfills throughout the state, 9 private and 8 county-run. Waste Management is the largest of several private waste companies in SC.

Shawn, originally from Pennsylvania, said that where he had lived, trash was put in the coal mines; when these began to fill, the trash was set on fire. Some of those fires are still smoldering. Shawn's mission is not to let a similar situation exist in SC.

The CVSC pointed out in their Report Card on Governor Haley that forestry, agriculture, outdoor recreation and tourism account for \$54 billion-about one-third of our State's economy-and provide 25% of our jobs. The Governor was given a "D" grade with regard to protecting this industry. Something to think about, in economic terms: If protecting our environment is not important, how much do you think houses are going for in the counties of West Virginia that have the polluted water?


Q: What glows in the dark and stinks?

- 1. The Federal Government is ultimately responsible for spent reactor fuel.
- 2. There is weapons waste at SRS, but SC already has more than its share of curies.
- **3.** More efficient use of reactor



must wait 20 years instead of five before it can be put into a cement cask for permanent storage.

Did you know that Canadians want to ship their liquid medical waste to the Savannah River Site (SRS)? They, along with 39 states with their own nuclear waste, want to dump it at SRS. If we get dumped on, no one but us will care if there is no permanent storage site.

PROGRAM PLANNING OUTCOMES

Those attending the Program Planning meeting on Tuesday evening, February 25, engaged in lively discussion on several topics (see February League Lines). The meeting met the League's goal of grass roots participation of members. We could submit only two recommendations to National, which were:

1) Review of an existing League position: Under the heading "Representative Government," it was recommended to emend current policy by inserting a sentence (underlined) to read: "Promote the election of the President and Vice-President by direct popular vote. If this is not possible, adoption of a Constitutional Amendment that would abolish the use of individual electors and would also state that in case of an Electoral Tie, the ticket with the most popular votes be declared the victor." [position initiated by LWVCA member Jody Thomas]

2) Concurrence with proposal of New Jersey on Human Trafficking.

Participants also reached consensus on:

1) Alternatives to Partisan Primaries - to support a new national study, with limitations. Focus needs to be narrowed and use of "best practices" of states should be reviewed for recommendations as a possible solution.

2) Campaign Finance - to support the proposal to review and update the LWVUS's existing position.
