From Civil Discourse to Deliberation

Highlights and Lowlights – This cautionary tale from <u>Public Works</u> comes via our State League President, Helen Hutchison:

How (Not) to Talk About Politicians

Most Americans think about politics and politicians when they think about government and fall into politician bashing. In the end, that only further erodes faith in government, and ignores the good work of all the upstanding electeds. Here are some rules for us: **Positive job descriptions:** Calling electeds *stewards*, *managers*, *planners*, *problem-solvers*, *consensus-builders* or *our voice* in the capitol, sets higher expectations, gives us real yardsticks for performance, and reinforces what our government is for.

Give frustration a positive direction: Ward off apathy by steering frustration toward *participation*. Rather than "throw them all out," emphasize that "voting is our chance to say if our representatives are doing the job we gave them."

Remember powerful little "reframes": Avoid: *Us* and *Them* language; lumping all politicians together (even the "other side"); stereotypes; and petty squabbles. Instead of *politicians*, say *our representatives*. Focus on shared values and real people with a job to do. Talk about government as *our tool* for getting things done together.

What's New? - In July the Civil Discourse group will join with the Book Group in reading and discussing, <u>Freedom for the Thought That We Hate</u>: Tales of the First Amendment by Pulitzer Prize winner Anthony Lewis (available through the Carlsbad city and SD County libraries and in Kindle and audio versions through Amazon). HEALTH INTEREST COMMITTEE

The Health Interest Committee has been focusing on the services and care that seniors receive in SNFs (skilled nursing facilities) and RCFEs (residential care facilities for the elderly), This involves laws governing those facilities and their enforcement, legislation, lobbyists, politics and power, money—always money, elder abuse, community support, evaluation of the facilities by governmental agencies and the value of that evaluation. We have learned a lot from San Diego County ombudsmen who visit facilities troubleshoot problems and the practicality of the regulations and laws. We have visited two locked dementia units, several SNFs and RCFEs so that we could learn the difference between a two star rating and a five star rating in what services were offered and the style in which they were offered. All facilities were for profit except one. The one not-for-profit facility is run by a dedicated board and staff that devote their lives to the operation of the RCFE.

Two of our members went to downtown San Diego to visit one of the four UCSD Student-Run Free Clinics. They were amazed. It is housed, one night a week, in a church, serving only those people who are unable to pay for medical care. It offers one-stop shopping for those patients - with general medicine, medical specialties, dentistry, pharmacy, social work, legal advice, acupuncture, and referrals to other resources in the community. If hospital services such as x-rays or surgery are needed, arrangements are made for that care. The clinic is supported by private donations and the work of volunteers, students and faculty.

The Heath Interest Committee has discussed Durable Power of Attorney for Health Care vs POLST (Physician order for life-sustaining treatment). We had Trish Halsey-Munroe lead a discussion at our last meeting about SB 128, the Death with Dignity legislation. Although no consensus was expected or sought, the discussion was lively and encouraged some of us to take up this discussion with our own families.

Since the Committee normally meets on the third Saturday of each month and this May the LWV 's convention will pre-empt that Saturday we will have no meeting in May. June starts vacations so we will not be meeting until September 19, 10 - 12 at Jane Dunmeyer's house. You are invited to join us and learn along with us

WHAT WE LEARNED -- LEGISLATIVE INTERVIEWS OF 2015

The meetings with our local legislators were an interesting education for me and for our team of League Interviewers. We met with the following State Senator Patricia Bates (District 36), Assembly Member Rocky Chavez (District 76), and the staff from Assembly Member Marie Waldron's office (District 75). My committee was composed of Carol Grimes-Gartland, Patricia Halsey-Munroe, Arlene Meadows, Connie Ulrich; our expert advisors were Martha Cox, Amber Ter-Vrugt, and Cathy Greene. My thanks to all the team for a fine job!

The State LWV supplied local leagues with the four questions. Here are the highlights:

1. <u>Money in Politics (focusing on the Cal-Access</u> campaign finance database).

All three believed that having a website for on-line disclosures was important. Chavez and Bates favored including local races in the database.

- ASM (Assembly Member) Chavez--believes that the Secretary of State, for health reasons, did not make progress in the revamping of Cal-Access. He felt that someone in the Administration should have been monitoring progress/lack of progress.
- Neither Marie Waldron's staff nor Senator Bates seemed fully familiar with Cal-Access, although they followed the reporting mandates for campaign finance. ASM Waldron's staff had used the database to answer constituents' questions on campaign financing.

2(a) <u>Early Childhood Education-Who should receive</u> it?

- ASM Chavez sees himself as a leader in promoting and ensuring cognitive education in pre-school settings for children 0-5. He notes that too many children are being "warehoused" in childcare programs and then unable to compete in school with kids from more enriched environments.
- ASM Waldron home-schooled her son and favors parent choice in education.
- Sen. Bates believes exposure to a structured environment with organized play at an early age help children develop self-discipline. She would review any legislation and funding proposals before giving support.

2(b) <u>Cap on Education Reserves--Should the cap-</u>related language be repealed?

All three legislators favored repeal of the cap-related language and giving control on reserve amounts to local school boards.

3. Water--did Prop 1 address the important issues in our district? If not, what else is needed?

All the legislators believe that water is a critical issue for our district.

Legislative Interviews continued:

- ASM Chavez worked on the negotiations for the percentage of Prop 1 funding that would go for groundwater retention improvement in San Diego. Northern counties had wanted this funding eliminated, but 6.5% was restored.
- ASM Waldron sees a need to develop methods to reuse water. She has attempted to pass legislation to fund development of a pumping system to provide area farmlands with Escondido's treated wastewater. She favors local solutions to water storage that would not require an Environmental Impact Report, which can take up to 5 years to complete. She supported the Governor's revised Water Bond because of the local \$750 million provided.
- Sen. Bates is a strong proponent of desalination plants. She supports the Governor's plan for water storage expansion and favored the emergency allocation of bond money to help communities that are running out of water. She supports CEQA (California Environmental Quality Act) but feels that the process needs to be modernized.

4. What other major issues must the Legislature deal with in 2015 and what are your personal priorities?

- ASM Chavez feels the ramifications of the Affordable Care Act will be a major issue in 2015. Problems he sees include taxpayers not receiving anticipated tax refunds because of incorrectly estimated incomes, and competition within the system for funding. He fears that pharmaceutical companies may be discouraged from new drug development because of reduced federal funding.
- ASM Waldron feels the Legislature should restore the cuts in the Medicaid rate paid to doctors. She is also concerned

- about privacy issues regarding the use of drones. She supports requiring businesses that have customer Social Security numbers in their records to encrypt this data.
- Sen. Bates plans to introduce a bill to ensure that home care
 workers and consultants for elderly or dependent adults
 have not committed any type of abuse, including financial.
 She favors a database of those found guilty of crimes. She
 sees a need for Brown Act modification to limit the use of
 special meetings with public disclosure of why a special
 meeting was called to replace a regular meeting.


Additional Comments and Observations

- Both ASM Chavez and Sen. Bates are relocating their Carlsbad offices--ASM Chavez to Oceanside and Sen. Bates to a more accessible location in Carlsbad.
- ASM Chavez is running for U.S. Senator Barbara Boxer's seat. He notes that the new "top two" election rules for primary elections has changed the makeup of the Assembly, creating a more cooperative atmosphere and more productive committee work. He noted that about 70 legislators out of 120 were freshmen this year.
- ASM Waldron has been a staunch supporter of legislation to provide protections for persons in Community Care facilities. She calls for the implementation of Laura's Law in San Diego with an extension of assisted outpatient services for involuntary clients from 6 months to 1 year.
- Sen. Bates would like to team with the LWV and other organizations to increase voter turnout. She sees as a real problem the possibility of low turnouts giving a dominant voice to a minority of voters whose interests do not reflect the interests of the general public. She reports that the Senate Republicans and Democrats are working cooperatively in committees toward shared goals; she has worked on several occasions with Democratic Senators to craft legislation.
