League members, we have set records this year. I have never received so many requests for our services. Most of these activities were packed into a few short weeks of intense effort and back-to-back scheduling challenges. I certainly did not do this job alone. Voter Service committee chairs this year included Barbara Lorenzen, Roni Seay, and Anne Omsted. These ladies spent hours training volunteers, scheduling programs, and working events to ensure that North County could answer all the calls for voter service programs and assistance. They have my eternal thanks.

Barbara, Roni, Anne, and I were so gratified at the tremendous response of our League members to the call to volunteer. This fall we have had 60 League volunteers working to provide voter education opportunities and service to our North County communities. What was really fun this year was the number of first year members who joined our experienced members in volunteering to work the many voter service activities.

A brief rundown of what we have accomplished!

- Eleven forums were successfully moderated by our League. The total forum attendance this fall was close to 1,000. We are so proud of the teams that helped our fellow North County residents meet their candidates and discuss the issues of their communities.
- Even more astounding are the statistics for the Pro and Con presentations. Thirty-two programs were given by our intrepid volunteers over 6 ½ weeks. As I write this, our League volunteers are still out there giving pro and con programs.
- Voter registration requests started off strong this spring and continued through the year. Since March, we have sent volunteers to a total of 16 voter registration events. We have also given four training sessions to organizations planning their own registration drives.
- Volunteers are continuing voter service to our communities right up to Election Day by staffing the drop off ballot boxes at the local libraries.

Our heartfelt thank you to all who came out to help.

## President's Message

At the time of this writing, the election is two weeks away. There are many unanswered questions about the direction our country will take over the next four years. But, one element is without question: this has been one of the most caustic, divisive elections that voters can recall in their lifetimes, leaving many feeling frustrated, angry and unsettled about the outcome.

Many have expressed concern about the suggestion of a rigged election, fearing this goes beyond election rhetoric and undermines faith in one of our country's foundational cornerstones of open, free elections. In San Diego, Registrar of Voters Michael Vu, will conduct pre-Election Day testing to ensure equipment accuracy and polling site procedures this week with members of the League of Women Voters, the Grand Jury, political parties and various campaigns. The same group will participate as Election Day observers to ensure the validity of our county election. Though it may feel that the country is coming apart at the seams, there is hope. Think about the last question posed to the presidential candidates at the second town hall forum – it wasn't about policy, it was about civility, "...regardless of the current rhetoric, would either of you name one positive thing that you respect in one another?" Dr. Carolyn Lukensmeyer, Director of the National Institute for Civil Discourse, stated in a recent article, [After the Presidential Debates, Where Do We Go From Here?](#), "We're going to have (to) pick up the pieces and rebuild our nation's commitment to civility. There's a lot of work ahead of us-and we are all going to have to do it together."

Working to inform voters has been our mission of the fall; working to empower, include and problem solve with members of our communities will be our mission going forward after this election. Our work is far from over.
