## Watching Your Local Government By Elaine Weinreb

The first step in becoming an informed citizen is knowing what your local government is doing with issues that you care about. You can certainly get some information from reading local newspapers and websites, and you can get a few of the hottest topics of the day on local radio and TV. But there is no guarantee that reporters, who are deluged with information, will focus on the particular issues that interest you.

### Watching a Meeting --at Home

To really find out what is going on, you need to watch the meetings of the public agencies that deal with your concern. You can do this from the comfort of your own home. Channel 10 broadcasts live meetings of the County Board of Supervisors, the County Planning Commission, the Eureka City Council, the Arcata City Council, the Fortuna City Council, the Humboldt County Association of Governments (HCAOG), and the Humboldt Waste Management Authority. These recordings are also posted and archived on the website of Access Humboldt, so if you miss a meeting and want to watch it on your computer, go to [https://archive.org/details/access\\_humboldt](https://archive.org/details/access_humboldt)  
Harbor District meetings are posted here, as well, although they do not appear on television.

The Board of Supervisors and the County Planning Commission also post their recordings on their own websites, and match them up with the agendas, which makes finding your topic a lot easier.

To watch one of these meetings, go to <https://humboldt.legistar.com/Calendar.aspx> Scroll around on the page and click on the meeting that you want.

### But What Will They Be Talking About?

You will need to look at an agenda. State law requires agendas of all public agencies to be posted 72 hours before the meeting. For example, if you are following the Eureka City Council, google "Eureka City Council." On the left side of the page you will find a button for "Agendas and Minutes." Look at the agenda of the upcoming meeting, and see if there is anything in it that interests you. With any agency, pay special attention to the "Consent Calendar" because a lot of times, interesting stuff is tucked away in there.

### What Have They Said in the Past?

You will need to look at the minutes of the agency. Find the minutes the same way you found the agenda. If there's a particular topic you're interested in, look at several sets of minutes. There might be more than one agency involved --- for example if you're interested in a particular Eureka street, you might have to research both the county and the city. If it's a waterfront issue, it might be the city and the Harbor District.

### Background Listening

For those times when you just want some interesting sound in the background, turn on KZZH-FM (96.7) which re-broadcasts local government meetings most of the day. You might be surprised at what you learn.

## The Language of the League by Leslie Leach

The League of Women Voters is an entity large enough and important enough to have acquired its own vocabulary as well as incorporating some well-known terms and acronyms.

Following are the words and definitions continued from the “M” – “O” section of the Glossary of Terms Used by the League of Women Voters from the booklet *Writing for League* by the LWVC:

**MITIGATION:** The definition of mitigation is identical under the National Environmental Policy Act (NEPA) and the California environmental Quality Act (CEQA). It includes avoiding, minimizing, rectifying, reducing, eliminating, or compensating for environmental impacts of projects.

**MONITORING:** A form of action in which the League closely follows the administration of public policy and points out needed revisions in law, regulation, or procedures.

**M/S/C or M/C:** Moved, seconded, and carried. Shorthand for writing in the minutes that a motion has passed. The names of the persons making and seconding the motion should be included in parenthesis following M/S/C. It is the League’s practice to record the name of the person seconding the motion even though this is not required by *Robert’s Rules of Order Newly Revised*.

**MTA-MANAGEMENT TRAINING ADVISOR:** An experienced member of the League assigned to a few local Leagues to serve as a resource person, conduct board training and provide other support as needed, and to serve as a communications link between the local League and the state board.

**NEGATIVE DECLARATION:** A written statement by the lead agency, based on an initial study, briefly describing the reasons that a proposed project, not exempt from CEQA, will not have a significant effect on the environment and, therefore, does not require the preparation of an Environmental Impact Report (EIR).

**NEPA:** National Environmental Policy Act

**NETWORK:** An informal group of organizations meeting periodically to share information and strategies. In contrast to a coalition, a network is relatively unstructured, with each member organization maintaining its own autonomy in acting in its own name.

**NONPARTISAN POLICY:** The League is nonpartisan in that it never supports or opposes any political party or candidate. The League may, however, support or oppose particular ballot measures in line with positions adopted as a result of study and/or consensus reached on program issues. Individuals within the League are encouraged to actively support the political parties or candidates of their choice unless they hold sensitive board positions. Each League board adopts its own nonpartisan policy which interprets for its members and the community any restrictions it places on the political activities of its board members.

**OBSERVER:** A representative of the League who regularly attends public meetings of elected and appointed councils, commissions, boards, or other civic bodies for the sole purpose of listening (not speaking) and reporting back to the League. Observers may respond if asked a direct question. When appropriate, observers alert the League to take action on issues in the areas of the League’s concern.
