## President's Message

Dear Members,

This week we've finished another exciting election season, and I assume you all have exercised your right to vote by heading to the polls or by turning in your absentee ballot.

Most of the action directives coming from the National League this past month have had to do with getting out the vote. Also, our US Representative Sam Farr (California's 20th Congressional District) has asked voters to contact their representatives and encourage them to pass H.R. 3899, the Voting Rights Amendment Act, which restores part of the VRA that the Supreme Court saw fit to gut in this 49-year-old law. The House of Representatives, with its abysmal non-action MO, has also failed to act to protect our at-risk voting rights. I repeat, again and again, constant vigilance and moves to action by all are sorely needed to keep voting fair and assure equal access to the polls for every citizen.

This is also a good time to praise your local board members for their diligence and dedication, particularly in maintaining and going beyond what we do best: registering and informing voters in our county.

Voter service co-chairs Sue Becker and Dottie Fry have had an active election season, doing a great job registering voters around the county and in high school classes, arranging candidate forums, and presenting pros and cons on the state ballot measures to various organizations. Many kudos for Sue and Dottie's grand efforts, and to all those assisting them with their time, labor, and expertise on the events of this election year (see page 3 for the full Voter Service Report).

Keeping us equally informed on what is happening is our VOTER newsletter editor, Pam Newbury, with her comprehensive reporting on our program's study issues and her monthly dedication to presenting an A-1 newsletter for the League.

Board member-at-large Dee Takemoto has kept the populace informed about our events through her effective announcements and contacts with the media and the Sentinel's Coast Lines.

## Rethinking Substance Use and Co-Occurring Disorders in Our Criminal Justice System:

*A look at the HSA's draft Strategic Plan and planning for our May, 2015 panel discussion*

Our November 11 meeting will focus on this year's program planning topic concerning treatment of individuals in the county justice system with substance use disorders (SUD) and co-occurring disorders (COD). At the meeting, chaired by Pam Newbury, we will review and discuss the County Health Services Agency's newly-released *Draft Strategic Plan for Substance Use Disorder Treatment and Prevention Services* (available online at [www.santacruzhealth.org](http://www.santacruzhealth.org)). We will also discuss plans for our May 2015 speakers' panel on the topic.

Questions to be put before the May, 2015 panel for discussion will address concerns about the best practices for treatment of those with SUD/COD who have entered Santa Cruz County's (SCC) criminal justice system. Questions will center on whether individuals can or should be diverted from the jails into treatment and how this can be accomplished. With every dollar in treatment saving at least four dollars in acute health care, criminal justice, and other public costs, how can we begin to invest more dollars in treatment? Why have some seemingly successful efforts in this direction, such as the recently disbanded drug court, failed? How can successful programs, such as the Serial Inebriates Program, be expanded?

Currently, in SCC efforts for treatment and prevention account for only 3.3% of the costs of SUD/COD, and less than half of those who seek treatment receive it. By reallocating resources from prosecution and incarceration to treatment, can we reduce our overall costs?

This meeting will begin with a review of the Draft Strategic Plan and a discussion of our response to the plan. Attendees are encouraged to read the plan and attend the [November 5 HSA presentation](#) of the Strategic Plan if possible. Following that, we will discuss possible speakers, topics, process, venue, publicity, and other aspects of planning our May event.

Come and contribute your ideas and energy to this effort on Tuesday, November 11 from 11 a.m. to 1 p.m. at the IHOP in Capitola. This meeting is open to all LWVSCC members. Attendees will order lunch on separate tabs. All are welcome to stay and attend the LWVSCC Board meeting immediately following at the same location.

# Voter Service Report

## *NOVEMBER VOTER REGISTRATION ACTIVITIES*

This September 23, National Voter Registration Day, the League registered voters at three sites throughout Santa Cruz County.

On the Westside of Santa Cruz, at the Safeway store, Sue Becker, Joan Hebert, Eric Thomassen, and Dottie Speidel held forth from 3 until 7 p.m. Six people reregistered due to an address change.



In Boulder Creek, in front of Johnnie's Super Market, another team of four worked: Dorrie Kennedy, Connie Leas, Wendy Harris, and Karen Smith. This turned out to be a good site, with several new voters registering, and five people taking forms home to fill out and mail in.

In Watsonville, at the Cabrillo College extension, Dottie Fry, Jan Karwin, Kathy Donovan, and Laura Grossman registered students. Altogether we registered nineteen people that day, from all three sites.

Then, on October 8 and 9, three of us talked to three different senior history classes at Harbor High School, registering seven new voters and a student teacher whose address had changed. We were asked to talk about why it is important to vote, and we each made presentations of 20-30 minutes. We three "teachers," Dorrie Kennedy, Joan Hebert, and Sue Becker, enjoyed talking to these young ones and inspiring them to be informed and to vote as soon as they turned 18. After our talks we went about registering the students who would be 18 by November 4.

Overall, our team of volunteers registered 27 voters. Thank you again to all of those who gave of their time and energy to promote the cause of responsible voting.

## *CANDIDATE FORUMS*

The League co-sponsored two candidate forums for the November 4th election on September 30: the San Lorenzo Valley Water District and the 29th State Assembly District forums, co-sponsored with the Valley Women's Club. The SLV Water District had six candidates for three seats and the Assembly seat had two candidates. Ashley Wheelock moderated, with Jan Karwin as prompter, Dee Takemoto as time-keeper, and Dottie Fry, Sue Becker and Eve Roberson as question sorters.

On October 8 the Lompico Community Center and the Lompico-Zayante Women's Social Club co-sponsored the Lompico Water District forum with five candidates vying for two seats. Celia Scott moderated, Jan Karwin prompted, Dee Takemoto kept time, and Dottie Fry and Sue Becker sorted questions.

Thank you to all the League members who volunteered as part of this excellent team to make these three forums happen. They were successful and informative due to your efforts.

## *PROS AND CONS PRESENTATIONS*

The League made four presentations of the pros and cons of the November 4th ballot measures. Sue Becker and Dottie Fry presented to the Methodist Women's Group at the United Methodist Church in Santa Cruz on October 14; the LWVSCC monthly meeting at the Scotts Valley Library on October 15, the AAUW luncheon at Mei Gardens Restaurant in Santa Cruz on October 25; and finally, the P.E.O. (Philanthropic Educational Organization) meeting at Trinity Presbyterian Church in Santa Cruz on October 27. Both presenters enjoyed the lively discussions during and after the presentations. The Voter Service team is proud to have provided information to help so many voters make informed decisions on the ballot measures for the November 4th election.
