## Louise Daniel Women's History Luncheon to honor women in oil & gas industry

"Women in the oil and gas industry" will be the focus of the 9th Annual Louise Daniel Women's History Luncheon and Women's Equality Day Celebration at 11:30 a.m. Friday, August 24, in the Great Hall of Polk Street United Methodist Church, 1401 S. Polk.

Our League is one of the sponsors of this event, which has grown each year. Last year we had some 280 attendees! League members on the steering committee include SUSAN COLEMAN, who has written the interesting history handout for the luncheon; MARILYN VAN PETTEN. who has coordinated Louise's (donated) landscape photographs, one of which will be offered in a raffle drawing; JANETTE KELLEY, who helps with registration, and me, who does Caroline Chamblin, former publicity. member Amarillo League now of Albuquerque, one of the committee founders, plans to come in to give a remembrance of Louise at the luncheon.

Featured speaker will be Juanita Malecha, longtime landman and a Vice-President of Pantera Energy Co. of Amarillo. She will share her story of how a girl who grew up on a farm at Umbarger with five brothers got into the oil and gas business and became one of the first women landmen in the Panhandle—and how attitudes toward women in oil and gas management have changed in the years since.

Louise, who died in 2003, had been a longtime League member, science teacher, education advocate and community leader. The luncheon honors her last wish, to remind women of all ages of the efforts and struggles of earlier women to overcome barriers to equality and to celebrate their contributions to Panhandle history.

The luncheon is held close to Women's Equality Day, which commemorates passage of the 19th Amendment to the U.S. Constitution in 1920 giving women the right to vote.
