A Message From the President

Dear Members,

These are truly strange days as we shelter in place doing our small part to “flatten the curve” of the coronavirus peak. I have been very impressed by the leadership of Governor DeWine and in particular Dr. Amy Acton, Director of the Department of Health, through this crisis to date. Their early data-driven approach to preparing the state for the pandemic undoubtedly will save lives.

Not all has been perfect. The last minute decision to eliminate in-person voting on March 17, while consistent with the state’s sheltering in place guidelines, created a lot of confusion for voters, poll workers and boards of election.

Despite extensive lobbying by LWV Ohio and its partners to ensure a fair primary voting process, we are now playing catch up with a vote-by-mail extension approved by the legislature that doesn’t allow for additional voter registration as required by the National Voter Registration Act, and is too short and too cumbersome particularly for the poor and minorities, who may not have printer access, envelopes, or stamps.

On March 30, the ACLU, the Lawyers’ Committee for Civil Rights Under Law and Dēmos filed a lawsuit on behalf of LWV Ohio and others that addresses these issues. Click [here](#) to read the press release.

The March 17 primary election fix discussed above was part of HB 197, a bill that addresses a number of emergency issues facing the state and its citizens during the pandemic - from easing unemployment requirements to freezing the number of schools eligible for EdChoice vouchers (a short-term patch, but a needed stop gap to save public schools). HB 197 passed with uncharacteristic speed and bipartisan unanimity. Such collaboration is a welcome change.

Beware of opportunism. But emergencies such as the one we're in often lead to government overreach and the move by Attorney General Yost to classify abortion as nonessential is a good example.

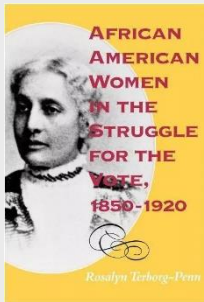
In response the ACLU, Planned Parenthood and others filed a federal lawsuit on March 30 and several hours later a federal judge ordered a temporary halt to the state's order defining the procedures as nonessential. Click [here](#) for the story by Andrew Tobias on cleveland.com.

Ohio Primary Election absentee ballots due April 28

Absentee voting for the 2020 Primary Election has been extended to April 28. If you haven't voted yet, click [here](#) to print an absentee ballot request form or call 330-643-5200 to request a form be sent to you.

Important dates and details:

- **Absentee ballot (vote-by-mail) requests must be received by the Summit County Board of Elections by 4/25. We recommend you mail in your request ASAP.**
- **Voted ballots must be mailed back with a postmark of no later than 4/27, or for Summit County residents, dropped off by 4/28 at the Summit County Board of Elections, 470 Grant St., Akron, OH 44311-1193, 8:00am - 4:30pm, M-F.**
- The Secretary of State's office will mail voters a **postcard** with information about how to request a vote-by-mail application.
- **Once you receive your ballot by mail, the return envelope will have pre-paid postage.**
- There will be limited in-person voting, but only for those with disabilities and for some without access to the postal service like the homeless from 6:30am - 7:30pm, April 28 at the Summit County Board of Elections.

HOW THE 2020 CENSUS WILL INVITE EVERYONE TO RESPOND

WHAT THE U.S. CENSUS BUREAU WILL SEND IN THE MAIL	
On or between	You'll receive:
<i>March 12 - 20</i>	An invitation to respond online to the 2020 Census. (Some households will also receive paper questionnaires.)
<i>March 16 - 24</i>	A reminder letter.
	If you haven't responded yet:
<i>March 26 - April 3</i>	A reminder postcard.
<i>April 8 - 16</i>	A reminder letter and paper questionnaire.
<i>April 20 - 27</i>	A final reminder postcard before the U.S. Census Bureau follows up in person.

- Every household that hasn't already responded will receive reminders and will eventually receive a paper questionnaire.
- It doesn't matter which initial invitation you get or how you get it - the U.S. Census Bureau will follow up in person with all households that do not respond.

Whether you are working from home or needing some diversion while staying at home, remember the incredible, accessible resources provided to you from your neighborhood

library and neighboring libraries. My experience is with Akron Summit County Public Library and the Hudson Library & Historical Society part of the Clevenet consortium (from where I currently work remotely).

The Hudson Library & Historical Society and other libraries have many business and job search online databases-unique collections of specialized information for your information needs. We continue to take patron questions at askus@hudson.lib.oh.us

For kids & teens find Homework Resources TumbleMath, WorldBook, EbscoHost, and more.

Both library systems maintain a vast digital resource collection. There are some similarities but they are different so explore both. Some of the highlights include:

- eBooks and eAudiobooks through Overdrive, hoopla and RBDigital – no late fees!
- Online learning options include Lynda, a leading online platform that helps anyone learn business, software, technology and creative skills and The Great Courses online featuring 150 of the most popular courses taught by the world's top professors.
- Movies, TV and more: Acorn TV, which provides access to British TV shows and Stingray Quello, which offers on-demand full-length concert films and music documentaries. Hoopla, Kanopy also offer movies and TV and more.
- Current Issues of popular magazines such as Time, Rolling Stone and People Magazine available through services like Flipster and RBDigital.

Need a card? As long as you permanently reside in Ohio, own property in Ohio, or live in Ohio while attending school this semester, you can register for a free eCard, which grants you access to the Hudson Library's entire digital collection. [Click here](#) to register for an eCard.

During this extraordinary time, some of our vendors have allowed remote access to many of our in-house only databases during this national health emergency. Resources now temporarily accessible off-site with a library card include Ancestry (Library Edition), Gale Virtual Reference Library and Value Line Investment Survey. Iron Jawed Angels, 2004

"Katja van Garnier's film, **Iron Jawed Angels**, tells the remarkable and little known story of a group of passionate and dynamic young women led by Alice Paul (Hilary Swank) and her friend Lucy Burns (Frances O'Connor) who put their lives on the line to fight for women's right to vote."

Made in Dagenham, 2010

"Based on a true story, **Made in Dagenham** explores the movement that caused a significant law reform. Rita O'Grady (played by Sally Hawkins) leads the 1968 Ford sewing machinists strike at the Ford Dagenham plant, where female workers walk out in protest against sexual discrimination, demanding equal pay." The film is a testament to women's solidarity and resolve as they faced incredible odds.

Crip Camp: A Disability Revolution, 2020

Friendships formed at Camp Jened, a groundbreaking summer camp for teens with disabilities, become the core of a movement fighting for disability rights. **Crip Camp** uses footage from the 1970s to today to document the campers who turned themselves into the activists who spawned a movement.
