Clackamas County's Climate Action Plan (CAP)

For the last two years, a Climate Action Task Force (CATF) has been meeting with consultants hired by the County to draw up an action plan with goals, targets, and an implementation guide to meet carbon neutral goals by 2050. There are many policies, programs, initiatives and infrastructure investments needed in order for the CAP to be fully realized, and Clackamas Co. does not have authority over many of the contributing emissions or energy generation, for example. It is complicated to say the least, but as one participant said, the situation is dire, so we need to swing for the fences. Yet, several task force members expressed unease that there are many goals and actions in the plan that don't appear feasible for one reason or another.

The action plan addresses nine distinct sectors: Active transportation; Clean heating; Building retrofits; New building performance; Low emissions vehicles; Transit; Energy generation; Waste and wastewater; Natural sequestration.

If Clackamas Co. wants to be eligible to receive implementation money from other jurisdictions (State and Federal), it must have an action plan in place. Once past this hurdle, actionable implementation plans, policies, and more refined feasibility studies will be required.

Progress on Gun Safety and Violence Prevention in Oregon

Yet another school shooting, this time in Tennessee, has brought another round of divisive rhetoric on what needs to be done to curb gun violence in this country. I am happy to say that Oregon is taking a pro-active approach this legislative session, despite adamant opposition from gun supporters. Below are links to League testimony submitted to the House Judiciary Committee on three of the gun safety bills scheduled for work sessions before April 5. The League delivered oral testimony on SB 348 in the Senate Judiciary Committee on March 27:

<u>HB 2005</u> bans undetectable, untraceable firearms ("ghost guns"). <u>HB 2006</u> sets a minimum age of 21 to purchase a firearm, with the exception of hunting rifles and shotguns.

HB 2007 expands the number of public jurisdictions that can establish gun-free zones.

SB 348-3 changes Oregon firearm statutes and sets up the implementation of Measure 114, the 2022 ballot measure that requires a permit-to-purchase a firearm and bans large capacity magazines. Despite court challenges to the measure, the League along with other gun safety advocates are urging passage of the bill this session, so that funding and processes will be in place as soon as implementation can proceed.

In addition to gun safety bills, violence prevention efforts will soon receive a sizable allocation of federal and state dollars. Legislation was passed in early March allotting nearly \$40 million for various programs in the state, including:

- \$15 million for community-based violence prevention grants from the American Rescue Plan Act Coronavirus State Fiscal Recovery Fund.
- \$11.25 million for the federal Victims of Crime Act grant (VOCA) to support survivors of violent crimes including gun violence.
- \$10 million for state-funded grants to domestic and sexual violence service providers throughout the state, including federally recognized tribal governments.
- \$2 million for the Crime Victims and Survivor Services Division, as a special payment for distribution to nonprofit entities to assist survivors of domestic and sexual violence and human trafficking in maintaining or acquiring housing.

Lifetime Member Spotlight: Beryl Dahl

Beryl Brechbill was born a rebel into a devout Methodist family in Missoula, Montana that didn't quite know what to do with their 'fun-raiser'. Her mother taught school until she chose to stay home with Beryl and her younger sister. Beryl fondly remembers her brilliant father who worked at the post office for 36 years until he retired. Beryl's younger sister resides nearby in memory care at Mary's Woods.

Beryl worked as a hospital aide and for the telephone company. She then went on to study jazz and music at the University of Montana for a few years. At age twenty, she decided to move to San Francisco, the most exciting city she had heard of.



Her future husband, Vic Dahl, was stationed at Travis Air Force
Base as Adjutant of the Air Police Squadron, but would drive into the city most weekends so they could spend time together. They married in February of 1954. Her math-oriented brain received job offers in banking, but she stayed involved in music while she and Vic raised their son Victor "Tor" and three daughters, Camilla, Antonia and Marcy.

After Vic left active duty, he attended UC Berkeley for \$50 a semester, and received his PhD in History with emphasis in US and Latin American studies. They reluctantly left Berkeley for Lake Oswego when he began an illustrious career teaching at Portland State University.

Their first home was in Southwood Park, where a friend passionate about League of Women Voters invited her to help form a unit since Lake Oswego Village was several miles away. Beryl has been a continuous member of the League since 1960, maintaining her membership through years of travel to all seven continents and more than 60 countries, including a two-year hiatus as a family in Zagreb, Croatia.

Beryl has served as Unit Leader and Voter Service Chair. When Vic became a League member after he retired in 1990, Beryl remembers overcoming fear of public speaking to support one of his best studies on Home Rule, when she testified to the county, even with loud and contentious opposition in the room.

Beryl was an accomplished pianist and is a lifelong lover of music, deservedly proud of her self-taught skills in sight-reading and accompaniment. She loves pop music and worked through entire music books on her own to prepare for almost any type of act. She has been a passionate member of music societies, where they all pitched in to do mailings by hand. She vividly remembers performances of superb classical pieces, Welsh singers, and incredible musicians performing from all over the world, most before they became well-known.

Her encouragement for newer League members is to dive in for the intellectual learning experiences available in the League from incredibly smart and dedicated members and seize every opportunity to be a "fun-raiser" in community service while building lifelong friendships along with your legacy.

I-205 Toll Report comment period extended two weeks to April 21

<u>ODOT Tolling Update</u> With a toll, ODOT helps meet the goal of improved travel by managing traffic flow and helping to raise revenue for infrastructure improvements. The Keep Oregon Moving legislation (House Bill 2017) established a Congestion Relief Fund, which would receive any net proceeds from tolls. The Oregon Constitution (Article IX, Section 3a) specifies revenues collected from the use or operation of motor vehicles are to be spent on roadway projects, which could include construction or reconstruction of travel lanes, as well as bicycle and pedestrian facilities and safety or transit improvements in or along the roadway.

There are serious mitigation concerns in the Clackamas County cities particularly impacted by diversion traffic resulting from this first Abernethy Bridge improvement and I-205 lane-expansion and tolling project.
