Position Review Meeting of Resources and Development of Humboldt Bay

On Thursday, March 16, nine LWVHC members joined the Zoom meeting for the review of the Natural Resources position: Resources and Development of Humboldt Bay. We were joined by Caroline Griffith, executive director of the Northcoast Environmental Center and editor of the EcoNews. Caroline joined us last year to add her expertise to the review of our Natural Resources position Land Use Planning. This year, she not only provided her own expertise, but also that of Jennifer Kalt, director of Humboldt Baykeeper. Although Jennifer was not able to be at the meeting, she met with Caroline, and they looked closely at our position to provide suggestions to members.

The position hadn't been reviewed since 2013, and there have been lots of changes since then. However, I think members of the LWVHC may take pride in the position being comprehensive enough to not require many changes.

As we went over the position point by point, there was time for members to ask questions and discuss the merits as well as any changes we felt were necessary. The biggest change is an additional point to the position: planning on sea level rise.

Thank you to all the members who were able to attend and to Caroline and Jennifer for the time and effort they gave to help the LWVHC. The position will go before the LWVHC board in April and, if approved by the board, will be presented to the members for their approval at the Annual Meeting to be held Thursday, May 25.

Call for Help at the Avenue of the Giants Marathon

The date for the 51st running of the Avenue of the Giants Marathon is Sunday, May 7, 2023.

The organizers have limited the number of runners, but have **changed the course**. Now the runners will make <u>two loops</u> on our section of the Avenue, so we will have double the fun! They have increased our cup allocation by 500! They have been sold out since early January! So, that means we will be very busy. Our League has staffed an aid station near Meyers Flat for over 30 years. Each year brings in between \$300 and \$500 to our treasury. Over the years we have added between \$4,000 to \$5,000 to our treasury and had a good time doing it. It has also raised awareness and good will for the League and has helped the runners as well.

I have committed League to do it again, so I'll need at least 12 of us to handle it. Friends and family are more than welcome too.

Legislative Interview with Assemblymember Jim Wood

Question 1 Do you believe that targeted voter outreach and education would help to shrink California's participation gap?

Would you support funding to the Secretary of State, county elections offices, and/or community-based organizations to address the problem?

Absolutely, I would support this. When you look at the assembly in particular, the voter turnout in districts varies widely. In a presidential election, in my county of Sonoma there will be an 80% turnout, and in an off-year election 50% - 60%. In a Los Angeles district, there may be a 17% turnout. People are not voting in some districts, so we need to make some changes.

Question 2 Would you advocate for changes to the School Facilities Program to reduce [the] inequity [in school funding caused by property taxes]? One way to do this would be to have the School Facilities Program structured so that the required match percentage from a school district is reduced for low-wealth districts.

This question deals with equitable funding for school facilities to fund school construction and modernization. Taxpayers in districts with low property tax value per student have to pay a far higher property tax rate than those in the wealthier districts in order to raise the same per student dollar amount. Would you advocate for changes to this school facilities program to reduce the inequities?

Yes, in theory. One of the frustrations is that some communities are more willing to fund bond measures than others. If we are going to offer resources, the community needs to have skin in the game. Some communities won't vote for bond measures because it increases their property tax. We especially see this in communities where there are lower numbers of school-aged children. Communities should contribute something, because sometimes it takes that investment in order to value it.

Question 3 How would you propose to transform management of California's water resources in response to changing conditions to minimize impact on food production and its associated jobs without adversely affecting food security and other users and uses of water?

Our water conservation efforts need overhaul, especially in certain areas of the state. Right now, with all of the rain we have had in our state, we need some of that water to run out to the ocean for wildlife/habitats/well recharge etc..., but there are opportunities with some of these large storms to find ways to recharge in the Central Valley. Building some large storage type ponds to capture water and recharge groundwater is important-- groundwater recharge is really important. A lot of people focus on above water storage-- there is value to that too. We have approved very little above ground water storage, in part because of the long permitting process. It would be helpful, but it isn't a full solution.

We've been working on drought planning on an ongoing basis. In the past, after the drought crisis was averted, the boards went back to how they were doing things before, but we need to maintain a focus in this area. We just put a bill forward proposing a Drought Planning Agency, with a full-time staff person to focus on droughts, knowing they will likely continue to be in our future.

Water rights need to be redone. At the moment, they are set up so a farmer can't divert and save river water in the winter, when we have most of the rain, but in the summer, our dry season. Getting some of these water rights and management adjusted so that they can be more relevant to meeting needs with climate change in mind would be good.

Question 4 What are your personal priorities, Assemblymember Wood?

My priorities are the district's priorities. We have very different districts across the state, and we need to build

relationships and understanding-- getting people to come out to see our district so they can understand more of where we're coming from and our needs. I work to educate new assembly members about rural districts which are often shortchanged. There are 27 members of the assembly that represent LA County, while I am representing 5 counties. Also, when bills are introduced, they need to take those differences into account. We don't have the same positioning to go after grants like big cities do.

I'm continuing to focus on broadband-- there are big swaths of the district that are underserved. In fact, we have the largest area of the state without the internet. There's a big push to build a middle-mile network through parts of Highway 101 which would give internet service providers a chance to tap in. I've been involved in broadband since I came to the legislature, and I continue to sit on a commission that oversees \$7 billion going into this project. A lot of carriers don't want to say who has access and who doesn't, so we are pushing for accurate mapping not done by cable companies to get the money where we need it to go.

I support alternate energy plans. Offshore wind is coming to the coast of Humboldt County, about 25 miles offshore. It will be a decade-long project to get that up and going.

Healthcare is also a big facet of what I do. I have held this position for eight years and am the second longest serving health committee chair in the history of the state. I authored a bill in 2016 that allowed hospitals to directly hire physicians. It was a sunset bill so it only lasts 7 years, but I am working to remove the sunset so that it can be a permanent bill. I am very concerned about private equity funds in health care and am trying to find ways to get a handle on that. A big challenge to our northern county hospitals are the seismic issues. The cost to retrofit hospitals is very expensive and in some instances may not be necessary. For example, Mad River Hospital in Arcata is a single-story hospital. It has survived seven earthquakes without losing a day of service. I am looking for an assessment of what the costs will be to do this, because losing a hospital would be devastating.

Right now, one-third of California's population is on Medi-Cal and we are entering a down budget. We are going into a big deficit between 25-40 billion dollars. This will likely be balanced by our reserves which have been piled up for years. We are slowing down the implementation of other projects and probably won't see huge cutbacks in programs this year. We're in the midst of a restructuring of Medi-Cal to provide more integration of services and to try to continue care for people, especially those with behavioral health challenges. We are shifting to Cal AIM (Advancing and Innovating Medi-Cal) and have had to apply to the federal government for waivers to do this work.

My staff and I work with our constituency on a daily basis. That is why we are here.
