At our April 19 SOCL at the Adorni Center in Eureka, the keynote speaker will be Jennifer Savage, statewide, national, and international advocate for ocean protection. The reduction of plastics pollution is a particular interest of hers. Her longtime efforts include work with the Surfrider Foundation and California's Ocean Protection Council. She recently addressed an international conference in Portugal. Some of us remember the Surfrider Foundation's success in 1991-92 to clean up the waters of Humboldt's coastline by pushing local pulp mills to lead the industry in changing to chlorine-free processing. Jennifer developed a love of surfing years ago when she took a women's surfing class offered at Center Activities at HSU. Her talk will be titled: "We are All in the Impact Zone."

A Rewarding Collaboration with the Human Rights Commission

In the fall of 2023, a committee of the Humboldt County Human Rights Commission (HRC) reached out to LWVHC with an invitation to collaborate on creating a public event to discuss free speech and hate speech. Our League board of directors recognized this as an excellent opportunity to put into practice our commitment to work with other community groups and on such an important topic for our community!

Three members of our board, Molly Cate, Karen Price, and Anne Hartline, joined board member Byrd Lochtie, who is also a member of the HRC, and four other members of the Human Rights Commission to form the HRC/LWVHC working group. We met throughout the fall and winter on Zoom and on the afternoon of February 21, 2024, presented the "Free Speech versus Hate Speech Forum" at the Sequoia Conference Center in Eureka. The room was full with close to 100 people, proving that local citizens are eager for such public conversations. We were also pleased to see a number of League members in attendance.



The four League members of the working group designed a Question and Answer format for six panelists, much like a candidate forum, something the League does so very well. Anne Hartline, a veteran of many LWVHC candidate forums, was our calm, thoughtful and kindhearted moderator.

Our full HRC/LWVHC working group talked for many weeks about panelists: how many to choose and with what backgrounds. Our tightest constraint was the number; the more responses you have to questions the fewer questions you can include in a two-hour session. We wanted to represent a broad range of community members, chosen for their demonstrated ability to thoughtfully present their perspectives on current, local hate speech or actions and, from their own experience, help people think about how to respond.

The 40 or so exit surveys turned in at the end offered much positive feedback, confirming that the audience especially liked the diversity on the panel, though some were rightfully disappointed that we had not included a speaker from our local Native tribes. Many appreciated the sharing of personal stories. Quite a few wrote that they left with much to think about. Overall, the forum was a very successful event.

Of course, one of the challenges of limiting the panel to six came from knowing that we would not be able to include every voice we wanted in the room. Our working group consoled ourselves with the understanding that this event would probably not be a stand-alone experience; in all likelihood, a follow-up event would be offered.

Those exit surveys were helpful in this regard also. Some suggested we involve younger people, perhaps students. Some sought more clarity about the differences between free speech and hate speech or more instruction on handling an interaction with a person using hateful words.

We were delighted to see that quite a few requested a more interactive event, where participants could ask questions, discuss issues, and interact with small groups. That's exactly what the Human Rights Commission committee who began this process would most like to offer next.

That's where the LWVHC members of this collaborative group would appreciate your feedback. What future events in a similar vein might the Human Rights Commission sponsor? If a follow-up event is not a forum, should the League be involved? If so, how? Traditionally, Annual Meeting has been an in-person meeting at which we come together to eat a meal (usually dinner), socialize, and conduct our business meeting. However, since the beginning of the COVID-19 pandemic, we have pivoted and tried Zoom, in-person, and hybrid Annual Meetings. Our board agreed that inperson Annual Meeting is by far the most enjoyable format for socializing and building a sense of community, while Zoom has the advantage of being easier for those who are not comfortable driving at night. Obviously, hybrid meetings can be a compromise but generally, the technology piece to make that effective is really challenging.

For the 2024 Annual Meeting, our Membership Chair **Becky Simpson** worked hard to find us a venue in Eureka where we can meet and eat together, one that hopefully has hybrid meeting potential.

Humboldt History Day


