

November 2021 Election information

The next election will be a General Election **November 2, 2021**.

Deadline to register to vote is October 12, 2021 for the General Election Register to vote online, check registration status and see what's on the ballot for your district at locality voter information websites (below).

To vote by mail -

All voters are eligible to vote a mail ballot. Voters must request a mail ballot.

Voters can request a Mail Ballot until Oct. 22, 2021.

Ballots must be mailed be delivered in person by Nov. 2, 7pm or mailed with a post mark of Nov. 2nd and received by Noon on Nov 5th.

To vote early in person -

Early voting is open 45 days before all elections. All voters can vote at any early voting location. **Early voting for the November General Election is in process.**

Vote Election Day -

On Election Day, all Arlington polling places are open from 6 AM to 7 PM. You must vote at your assigned location.



Advocates and Voters Ask to Join Election Review Lawsuit Against the PA Senate to Defend Voters' Privacy Rights

On 10-4 LWV of Pennslyvania filed a petition to join Pennsylvania's Attorney General lawsuit against state Senate Republicans' attempt to obtain private information about registered voters.

A federal court ruled that a former US Election Assistance Commission official violated federal law in 2016 when he allowed three states – Alabama, Georgia, and Kansas – to require documentary proof of citizenship on the federal voter registration form.

Redistricting News

Take Action Now!

The Virginia Redistricting Commission has completed their last meeting before consideration of your comments at the public hearings that began Monday, October 4. They have said your comments are vital for them to reach consensus on a House

and Senate map to forward to the General Assembly. The latest versions of the draft

maps are available through the Commission's web page. There are three tabs – House, Senate, and Congressional – which now also include maps submitted by citizens so the list is changing rapidly. The maps submitted by the Democratic map drawers begin with the letter "B"; the Republican maps begin with "A". Don't delay in commenting on what you do and don't like about any of the maps! There is also a public comment form for more general questions.
