Continuing the Discussion on Immigration: The Benefits and Costs of Immigration

In last edition of the *Voter*, we outlined some preliminary thoughts on the League position on immigration (see the May 2007 *LWVCA Voter*, p.2). As we prepare for an immigration consensus meeting this year, you might like to know what some of your fellow Clemson Leaguers are thinking. Here is a brief summary of what those who attended the May meeting thought were the benefits and costs of immigration and what their priorities are in immigration legislation: **Benefits:**

- 1. Diversity
- 2. Productivity
- 3. Immigrants fill jobs Americans won't take
- 4. Immigrants work harder
- 5. Some immigrants contribute taxes and social security

Costs

- 1. Cultural assimilation
- 2. Depress wages
- 3. Concentrated impact on certain states
- 4. Strained relations between natives and newcomers
- 5. Untaxed income in informal economy
- 6. Burden on medical system
- 7. Bureaucratic and enforcement costs

- 8. Fear of terrorists
- 9. Enables overpopulation/sustainability issues

10. Lack of civic participation

Priorities (not rank ordered)

- 1. Family unification
- 2. Expedite the process
- 3. Commitment to democratic process and civic engagement
- 4. Trade policies that improve life in home countries
- 5. Support for English as a Second Language training (by states)
- 6. Amnesty for those already here
- 7. More consistent policy
- 8. Humanitarian issue
- 9. Stronger standards for citizenship for illegal immigrants

Changing the Composition of the Pickens County School Board Update on H. 3782

Most of you probably know that the Pickens County Delegation, not all of whom live in Pickens County, introduced and passed legislation over the objections of B.R. Skelton and Senator Thomas Alexander that would eliminate the at-large seats on the Pickens County School board. Despite his history of vetoing such local legislation, Governor Sanford opted to sign this one.

However, the story of the composition of the Pickens County School Board is far from over. The state attorney general has opined that the Senate's practice of weighted voting, based on the share of county represented by each senator, may be unconstitutional. The city of Clemson will consider the possibility of taking legal action at its first meeting in September. If the city decides to act, the Clemson Area League will support the city on the basis of the state League's position supporting home rule (rather than having decision made by a county delegation that is not made up solely of Pickens County residents) and the national generic support of democratic process (an advisory referendum would be more appropriate). We cannot take a specific position for or against at-large seats because we have not studied and arrived at a local consensus on that issue, although individual members are free to speak as they feel moved.

The issue will be on the city's agenda for the first meeting in September. The date has not been set because of Labor Day and the football game, but it will probably be Tuesday, September 4th. There is an opportunity for public input at 7 p.m. before the council meeting begins.

Making a Difference in our Community: Getting Involved in LWV Advocacy

The Program and Action Team will be hosting an advocacy table at each of our regular meetings this year, not necessarily based on state or national action priorities but on pending legislation or active issues where we think we can make a difference. In September, we will be providing information about the 2007 farm bill in relation to our national agriculture position--a consensus in which the Clemson League participated, and one that is of increasing importance in the light of global trade and environmental issues related to agriculture and food supply. You can read about the proposed legislation at the USDA website, and we will also provide additional summary information at the meeting.

Here is the League position, adopted in 1988:

Agriculture Policy: The LWVUS believes that federal agriculture policies should promote adequate supplies of food and fiber at reasonable prices to consumers, farms that are economically viable, farm practices that are environmentally sound and increased reliance on the free market to determine prices.

Sustainable Agriculture. Federal policy should encourage a system of sustainable, regenerative agricultural production that moves toward an environmentally sound agricultural sector. This includes promoting stewardship to preserve and protect the country's human and natural agricultural resources.

Research and Development. Agricultural research, development and technical assistance should continue to be a major federal function. Resources should be targeted to developing sustainable agricultural practices and addressing the needs of mid-size farms.

Agricultural prices. The LWVUS supports an increasing reliance on the free market to determine the price of agricultural commodities and the

production decisions of farmers, in preference to traditional price support mechanisms.

Agriculture and Trade. U.S. efforts should be directed toward expanding export markets for our agricultural products while minimizing negative effects on developing nations' economies. Consistent with the League's trade position, multilateral trade negotiations should be used to reduce other countries' barriers and/or subsidies protecting their agricultural products.

Farm Credit. Farmers should have access to credit with reasonable terms and conditions. Federally provided farm credit is essential to maintaining the viability of farm operations when the private sector is unable or unwilling to provide the credit farmers need.

Of these policies, the League believes the most essential for the future of agriculture are: encouraging sustainable agriculture; providing research, information and technical assistance to agricultural producers; and increasing reliance on the free market to determine prices. *~Submitted by Holley Ulbrich*

87 Years of Fighting for Political Equality: LWV Marks Anniversary of the 19th Amendment

Washington, DC – This August 26 marked the 87^{th} anniversary of the day that the U.S. Constitution was amended to grant women the right to vote. While American women now comprise more than half of our nation's voting age population, the struggle to become full participants in the political life of the country has yet to be fully realized.

"This anniversary of the 19th amendment, Women's Equality Day, provides us with an opportunity to reflect with pride on the progress made on voting rights in the past 87 years," said Mary G. Wilson, national League president.

"This year, we've witnessed a number of remarkable milestones for women. For the first time, a female has been elected Speaker of the House of Representatives, and a major contender for the 2008 Presidential election is a woman.

"However, these achievements do not mark the end of our journey. In communities across the country, citizens still lack real representation by their elected officials and the policies they pass. It is only with the continued work of citizens and leaders, of all backgrounds, that this can change."

The League's current and recent projects include the launch of a major voter education website, <u>www.VOTE411.org</u>, lobbying against the disenfranchisement of eligible voters, a campaign to end "taxation without representation" for D.C. citizens by granting DC a voting representative, and continuing voter registration drives nationwide.

This anniversary "is a time to celebrate the progress achieved by active citizens over the past eight decades, but it is also a time to look to what still needs to be done to make democracy work for all Americans. The League of Women Voters will continue to be the place where hands-on work leads to a better democracy for all."
