- The Program and Action Team calendar was approved.
- The organizational calendar, which includes meeting dates, dates of board and general meetings, and other activities, has been adopted and is posted at the website and included in this mailing.
- Reggie Turetzky and her team sponsored a very interesting and well-attended Oconee County Council candidate forum.
- The History Team has had two meetings and is archiving important LWVCA documents with the CU Library Special Collections Unit. If you have documents for the archives, please contact me.
- The Membership Team is planning a great new member and prospective member meet and greet activity. I hope that you will attend.

Your board members and others will be involved in the upcoming LWVSC-sponsored League Leaders Day. League Leaders Day is an opportunity for leadership training and education on identifying local League resources and strengths, the basics of conducting effective, fair and exciting candidate forums and debates, social networking, and critical social and criminal justice issues for women in the corrections system and their children. The training will be held on August 15, 2009 at the Swearingen Engineering Center on the campus of USC in Columbia. Any league member may attend. Please see the website for additional details.

LWVCA member, Lyn Norton, has volunteered to serve on a LWVSC team to study school district structure and authority. In addition, the *LWVSC Positions in Brief 2009*, has been published and is accessible at <www.lwvsc.org>.

Finally, I want to share with you four areas that I will be focusing on this year as President. The first is member involvement. My goal is that there will be increased participation of current members in LWVCA activities. The Program and Action Team plans to host one major meeting in Anderson, Oconee, and Pickens Counties. We will invite our membership and the public to attend. Second, we have set a goal to increase membership this year by 5% as compared to last year. I am asking each board member and all members to invite at least one person to join LWVCA. Let people know that LWVCA provides the public with information on candidates and issues where we have a position. We, also, model and promote respectful dialogue and active citizenship. Third, we want to strengthen marketing efforts and encourage more visibility through the web and media. Fourth, we are exploring increased opportunities for fund development. You will be hearing more about this soon. As of this writing, board members are off to attend the Upstate LWV Leaders' Gathering in Greenville. We are involved and we want you to get involved. Join a team, attend a meeting, or express your interest in an issue area. Let your voice be heard through LWVCA.

Get out Your Calendars! The Program and Action Committee Has Planned a Busy Year

In addition to the scheduled programs that appear elsewhere in this VOTER, your Program and Action Team has been busy in other ways. Eleanor Hare has arranged for a quarterly OpEd in the Pickens Sentinel and Easley Progress. The first one, on electronic voting machines, appeared in July. Subsequent topics: clean elections, the tax realignment commission, and the state of our children.

We have also chosen education finance (under the header Goodbye Minimally Adequate!) as our running theme for 2009-2010. Janet Marsh and I will share responsibility for keeping you posted on developments. The most important development thus far was a meeting in Beaufort in June that set an agenda for the state League in terms of action priorities and an action plan for education finance for the upcoming year. About 20 people gathered, mostly from the low country, a few from Columbia, and me--I was vacationing on Hilton The legendary and delightful Harriet Keyserling, who served 16 years in the General Assembly from Beaufort, was also present. Watch for details in the SC Voter. And plan to advocate for the League's priority education financing positions.

The initial team for the statewide School District Governance study recommended by the Clemson League and approved by the convention has been assembled. There are three of us from the Clemson LWV (Holley Ulbrich, chair; Eleanor Hare and Bea Bailey); and Stacey Lindbergh from the Charleston LWV. We will be having a local meeting on that subject in September, looking at the concerns of the seven school districts in our service area. More details in the next Clemson VOTER.

Oconee County Council Candidate Forum

On Monday, June 8th, LWVCA conducted a candidate forum for the vacant seat on the Oconee County Council District 1 at Duke World of Energy Auditorium. Donna London did an excellent job of moderating. Susan Brandt was the time keeper and made sure that the candidates did not exceed their time limits. Charlotte Holmes and Janie Shipley welcomed the audience and direct them to the auditorium. Janie also got a large number of signatures for the "Goodbye Minimally Adequate" petition for presentation to the SC Legislature. President Della Baker welcomed and thanked the audience for attending. introduced the moderator.

Four candidates attended the forum. The forum was for the Republican Primary but we also invited the lone Democratic Party candidate who will vie for the open seat on August 25th. Over 120 people attended the forum. Each candidate gave an opening statement, answered questions from the audience and finished with concluding remarks. Some of the areas covered were: should there be a council-administrator form of government; does zoning protect peoples' rights; should there be more districts; should the county reclaim "home rule" from Columbia; how do the candidates each plan to keep taxes as low as possible; and how they would protect the county's natural resources.

The newspapers noted that this was an excellent and well-attended forum. There was a photo of the candidates on the front page of the Seneca Journal with a full report of the forum and LWVCA was mentioned in the first paragraph. The candidates participating were: Democrat Jack Collins; and Republicans C. Paul Corbeil, Robbie D. Lee and Steve Moore.

Thinking Ahead to the October Meeting: Considering Sustainable Energy

The committee arranging the October meeting recommends reading the first chapter of *Sustainable Energy — without the hot air.* These pages can be downloaded from the Internet at: http://www.inference.phy.cam.ac.uk/withouthotair/c1/page_2.shtml

This chapter clearly presents the correlation of carbon dioxide in the atmosphere with the Industrial Revolution and the generation of carbon dioxide by various countries. We recommend this chapter because it provides a basis for much of the discussion about energy.

The first section this book examines energy consumption by an average resident of Great Britain and compares the consumption with sustainable energy production. In order to make comparisons, energy use and production are converted to a single numerical unit. The second section examines available options if people are to get off fossil fuels and live sustainably. This book presents an interesting overview of the various components of the energy/global warming discussion.

The author, David JC MacKay, is Professor of Natural Philosophy in the Department of Physics at the University of Cambridge and Cavendish Laboratory. This book can be downloaded free by chapters or in its entirety from the above web site.
