LWVCA September General Meeting Tuesday, September 14 Whose Schools are They?

The general meeting on September 14th will focus on education at all three levels—federal, state, and local. Linda Gahan will give us a briefing on the newly adopted national study on the Federal Role in Public Education. No Child Left Behind, followed by Obama's initiative on merit pay for teachers and the stimulus funds used to keep teachers in the classroom, has focused attention on this issue of great importance both to federal-state relations and to education. This national LWVUS study will focus on the role of the federal government in education policymaking, with possible consideration of funding, common standards and/or governance relationships among all levels of the government.

At the state level, the League has committed to making action on education funding a major priority. The League has decided to start with "fixing" the Education Finance Act, which is underfunded and misallocates funds to districts a result of Act 388. We have developed a primer on EFA and its three components, base student cost, per pupil weights, and the Index of Taxpaying Ability and have laid out how each one needs to be addressed. A handout will be available at the meeting so that you can talk intelligently to candidates and legislators about what we would like them to do in the next legislative session.

At the local level, we will be reviewing the status of the school governance study, which asks three important questions about who should make decisions for school districts. Note: these are NOT the consensus questions, but they are the questions we can address now in preparation for consensus in January. Here are the questions:

Question #1. Who should have the authority to make changes in the school board—the voters of the district, the county board of education if there is one, the county council, the legislative delegation and the General Assembly, or some other entity?

Question #2. Who should have the authority to make changes in school districts by consolidation or redistricting—the voters of the district, the county board of education if there is one, the county council, the legislative delegation and the General Assembly, or some other entity?

Question #3. Who should have the authority to make changes in the amount of fiscal autonomy that a school district has—the voters of the district, the county board of education if there is one, the county council, the legislative delegation and the General Assembly, or some other entity?

Right now the answer to all three questions is the legislative delegation with the normal unanimous consent of their fellow members of the General Assembly.

Please join us on Tuesday, September 14th for a stimulation discussion of what we can do for our schools and for our children.

Tax Policy Update for League Leaders Day

A Tax Policy Booklet will soon be available on the Strom Thurmond Institute website. Copies will also be available at the LWVCA September meeting. This booklet has been sent to the media and to candidates. Election time is an excellent opportunity to remind them of the League's position on tax policy.

If your legislator voted for increasing the cigarette tax, please be sure to thank him/her for doing so. Get ready to ask candidates some hard questions this fall. Here are what I think might be some good questions to put to candidates. Feel free to be more tactful on the first one.

- 1. You didn't take a "no new tax pledge", did you? If you didn't, thank you. If you did, please tell us exactly what you mean by that. Do you mean that we can't raise any more revenue than the pitiful \$5.1 billion that is projected for the next few years, down \$2 billion from 2007? Does it mean that you support starving our schools and colleges, further overcrowding our prisons, and understaffing our state agencies?
- 2. If you were considering how to make up that serious shortfall of revenue, where do you think the revenue should come from?
- 3. The Tax Realignment Commission (TRAC) is doing some good work. Do you support their proposals to broaden the base of the sales tax by eliminating some exemptions, phasing out the sales tax cap on cars, boats and planes, and exploring some extension of the tax to services? Why or why not?
- 4. Would you support making the Commission permanent, as many other states have done? Why or why not?

Finally, we need to think ahead to the next legislative session and what tax proposals may be in store.

Fixing the Index of Taxpaying Ability is high on the list. The General Assembly did create a study committee, which should be meeting by now. We need to support changes in the index that ensure that poorer districts still get their fair share of Education Finance Act funds. Or, more accurately we will work to protect the unfairly small share they have been getting since base student cost was ravaged by the last two budgets at the same time that Act 388 was taking from the poor and giving to the rich. Districts, that is.

5. We will keep you posted on the (TRAC) recommendations and which ones we can support. ~ Submitted by Holley Ulbrich
