Message from the President

Holley and I welcome everyone back to an especially exciting election year. Please put the Women's Equality Day celebration (Aug. 23) on your calendar and join us for music, food and a preview of the coming year.

Watching the TV productions of our National conventions, I am struck by how much of what we are hearing appeals to our emotions and how little



to the policies necessary to produce the promised results. Emotional arguments worry me. Some experts tell us that, when voters accept emotional arguments, the impact of rational arguments and facts recedes. I hope that the presidential debates will shift public attention away from emotion and toward the presentation of facts and ideas, like we observed at our forums.

In South Carolina, our League's very successful Voter Service Chair, Cheryl Lee, plans to launch another extensive voter registration drive. Last spring Cheryl's 29 volunteers registered 726 new voters. Her team is at work again, planning to surpass their previous achievements.

November will bring non-partisan local elections for county school boards and for Clemson City Council. Our seven candidate forums in the spring provided useful information to voters — especially at the forums which were covered by the news media. Arranging forums for local races requires many workers: organizers, publicists, moderators, question sorters, photographers, timekeepers, greeters (who hand out cards for the audience to write their questions), and helpers at membership and information tables. At least 10 members are needed at every forum. A couple additional people would be helpful. Please consider volunteering when the call goes out.

In addition to registering voters and holding forums, we will be encouraging citizens to vote using our Patriotic Partners and other programs. It's going to be an exciting year, so stay tuned.

Voting We Can Trust - Paper Ballots One Computer Scientist's Opinion by Eleanor Hare

South Carolina's current voting system does not use paper ballots, except for absentee voting and provisional voting.

The requirement for a paper ballot, adopted by the LWVUS in 2006, is crucial to the accuracy and reliability of voting systems.

It is essential that the voter receive the ballot in his hand, verify that the choices listed are those he selected, and place the ballot in the ballot box (or in a scanner that records the vote and retains the ballot).

Except as necessary to identify an election, a precinct, a voting machine or to align the ballot with the scanner, barcodes should not appear on ballots. Also, as is customary, any barcodes should contain its digital translation. Otherwise, the barcode can be used to associate the ballot with an individual voter.

People assume that counting the vote is accomplished by recording the choices the voter sees, but some voting systems ignore the names the voter sees and use only the barcode to count the vote. In such a system, the voted is deceived into thinking that he confirmed his choices.

The most basic requirement of a voting system is a paper ballot, but even the paper ballot needs judicious protection.

Report on Lobby Day and Convention 2016

I have served as your Lobby Day team member and voting delegate to this biennial conference in Washington, D.C. and am pleased to make the following report. The Voting Rights Act (VRA) was enacted by Congress in 1965 to prohibit racial discrimination in voting. In Shelby County V. Holder (2013), the U.S. Supreme Court struck down a portion of the Act, Section 4(b), which established a formula for determining whether changes to a state's voting procedure should be federally reviewed. Once formula in Section 4(b) was invalidated, the pre-clearance requirement of Section 5 became redundant. Our team of three South Carolinians met with staffers from the Judiciary Committee of Senator Graham and main office of Senator Scott. (Lobby Day occurred on the same day that South Carolina Senators were speaking on the anniversary of the shooting at Mother Emanuel Church AME.) Individually I met with Congressman Jeff Duncan while the two lowcountry team members met with Congressman Mark Sanford. The objective was to encourage our representation to push the VRA out of committee and be vocal in their support of stronger voter protections. Congressman Duncan agreed to converse with members of the House Judiciary Committee and other Republicans that have been vocal in their support of the Act before deciding whether he would sign a discharge petition.

The Conference brought introduction of new and revised bylaws, and positions that may be viewed on the League of Women Voters website. A noted change in the League Bylaws is that now all members over age 16 may be voting members regardless of citizenship. Significant to South Carolina was a Task Force assembled to study and recommend a redistricting position. This Task Force was assembled of individuals from states not implicated under Section 4(b) of the VRA and did not consult with members from those states. It was heavily debated whether a state issue can be reliably studied and recommended when many states have not been included. Ultimately the position was adopted with the understanding that each State League may study and adopt their own position on redistricting.

Speakers during plenary sessions and breakout educational sessions focused on the main League objectives. A number of articulate speakers made passionate presentations on their involvement in organizations that encourage and inform voters. A panel session called Expanding the Electorate included four speakers from organizations focused on outreach to minority voters and new citizens. Educational sessions on Voter Watch Parties and expanded Voter411 programs will provide our League with better resources to inform and empower voters. More thorough report of the speakers and education sessions will be made at the LWV meeting on August 23.

Help Us Welcome New Citizens to America

The League of Women Voters of the Clemson Area is joining with LWV of Greenville County in a special voter registration project at the office of the Department of Homeland Security (DHS) in Greer, SC. LWV of Greenville County has obtained a grant from LWVUS to support voter registration at weekly naturalization ceremonies of new citizens. The Greenville League has invited the Clemson Area, Columbia and Spartanburg Leagues to join them in each being responsible for one week a month. LWVCA has been assigned to the second Friday each month.

Representatives from the Clemson Area attended the weekly citizenship ceremonies on July 8 and August 12. Diana Stafford, Bill Hare, Sarah McNeil and Janie Shipley were on hand to witness dozens of new citizens from all over the world take their oath of citizenship as they pledged among other things, to absolutely and entirely renounce and abjure all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, of whom or which I have heretofore been a subject or citizen; and to support and defend the Constitution and laws of the United States of America. New citizens received a warm and hearty video welcome from President Barack Obama – and smiles and hugs from their loved ones who accompanied them.

Officials from DHS welcome participation by the League of Women Voters. After the ceremony, new citizens are invited to visit with members of the League who provide voter registration forms and guide them through the registration process. Many people registered on-site and others took forms home with them to complete later. Bonnie Holaday and Janie Shipley are coordinating the project on behalf of LWVCA. Please consider joining them for the trip to Greer on the 2nd Friday of each month, departing Clemson around 8:15 am and returning before noon.
