Dear League Friends,

Happy New Year to all! And a special 'thank you' to all who have participated in the many League activities this past fall. Our winter is lining up to be just as exciting – so please attend at least one of the many activities and add your voice to our conversation!

On January 13, we will hold our annual Membership Breakfast. Jeff Clements, Concord resident and former MA Assistant Attorney General, will speak on campaign finance reform and the Supreme Court case *Citizens United v. FEC*. We are watching this Court case closely, fearing the ruling will invalidate current regulations and take campaign finance reform backward. In March we will co-sponsor a forum on campaign finance reform. As the legislative process for both health care and banking reform has demonstrated, we need stronger, not weaker, regulations on corporate influence.

The *Let's Talk Trash* and *Food For Thought* programs in October and November were a huge success. We reached hundreds of people and received broad coverage in the media. Food For Thought Action Groups are meeting now to change the school lunch program, start a farmers market, protect and promote farming in our towns, and learn/teach about food and nutrition. The *Life in the Balance* series continues on January 22 & February 5 with *Powering The Future*.

In anticipation of Town Meeting, the League gave comment to the Natural Resources Commission at the December public hearing on the proposed Wetlands Regulations. We will be reviewing these regulations and other Warrant Articles in upcoming LWVCC meetings.

On February 10, we will present *Our Town, Our Schools, Our Money* with Town Manager Chris Whelan, Town Finance Director Tony Logalbo, School Superintendent Diana Rigby and Deputy Superintendent John Flaherty. Finances are tight due to the recession and we look forward to hearing how the town and schools suggest we manage the budgets for 2011.

The LWVUS National Convention will be held this June in Atlanta, Georgia. We will have a delegation of Board members in attendance, so let us know if you would like to go! Next month following our February 3rd Board meeting, LWVCC members will meet to decide whether to recommend a new study, review, or concurrence to the national League agenda. As part of the process of preparing for convention, the LWVCC recently forwarded our recommendation that campaign finance reform be moved to the highest priority for advocacy at the national level. This letter has been included in the Bulletin.

Finally, remember to vote for your candidate in the special U.S. Senate seat race on January 19. Look for the LWV Vote signs around town urging everyone to vote in this important race.

In addition, this year is Concord's 375th anniversary and it will be celebrated on September 11-12. Various celebratory activities are in the planning stages including fireworks and a parade. (In 1935, the Concord League had a float in the Town's Tercentenary Parade.)

POWERING THE FUTURE

Jan. 22 – The Great Squeeze Feb. 5 – Our Community and Tomorrow's Energy The Life in the Balance public forum series continues with Powering the Future, a two-part program that focuses on climate change, energy issues and community-based solutions. Powering the Future, Part 1, is a free community screening of The Great Squeeze: Surviving the Human Project, an awardwinning documentary. An informal reception will follow the film, giving audience members a chance to share their reactions.

The screening and reception will be on Friday, January 22, 7-9 p.m., at the Alcott School Auditorium, 93 Laurel St., Concord, MA. Seating is first come, first served; or reserve seats in advance by email to <u>ace@colonial.net</u> (subject line: "tickets"). Snow date Sunday, Jan. 24.

The Great Squeeze (2009) looks at the environmental and economic challenges brought on by low-cost, plentiful energy. With the help of experts in anthropology, economics and biology, the film explores our reliance on fossil fuels, concluding that humankind must change course or face unacceptable consequences. The film was the Official Selection at the 2009 Environmental Film Festival, the 2009 European Independent Film Festival, and the 2009 Durango Independent Film Festival.

Powering the Future, Part 2, is "Our Community and Tomorrow's Energy." a speaker forum on Friday, February 5, 7-9 p.m., which will build on themes framed in The Great Squeeze. The forum, at the Harvey Wheeler Community Center, 1276 Main Street, West Concord, will feature guest speakers including State Rep. Will Brownsberger (Vice-Chair, House Committee on Global Warming and Climate Change), Dr. Warren Leon (author and former Director, Mass. Renewable Energy Trust), and Gretchen Brewer (Earth Circle Conservation & Recycling). Attendees may also participate in group sessions to discuss the issues and local responses. FOOD FOR THOUGHT Forum Launches Community Action

Following the successful screening of *Food, Inc.* early in November, LWVCC and co-sponsors ConcordCAN and Carlisle Climate Action hosted a *Food for Thought Action Forum.* With a focus on moving toward a sustainable food system, over 100 people came to hear five expert speakers at the Trinitarian Congregational Church parish hall in Concord on November 20, 2009.

League Board member Lauren Bakewell moderated the program, first welcoming keynote speaker Brian Donahue, Ph.D., Assoc. Professor of American Environmental Studies at Brandeis University. Presentations followed by Willow Blish of Slow Food Boston, Jim Catterton of the Concord Agriculture Committee, Jen Hashley of Tufts University's New Entry Sustainable Farming Project as well as Pete & Jen's Backyard Birds, and Charlotte Vallaeys, Farm & Food Policy Analyst for the Cornucopia Institute. The speakers then answered questions from the audience.

As the Q&A segment ended, Lauren Bakewell invited audience members to move to action tables for discussion and planning next steps in each of four areas: Personal/Household, Schools, State/National and Local/Regional. League members Debbie Barr, Becky Shannon and Paula Vandever, along with Hasso Ewing of co-sponsor ConcordCAN, led the group discussions.

Lively sessions ensued, with each table designating coordinators, identifying priorities for action and gathering contact information to facilitate scheduling future meetings. Other League members involved in planning or helping with the forum include Anita Barker, Barbara Lewis, Cindy Nock, Erin Pastuszenski and Launa Zimmaro.

Already, the November 20th Schools discussion has spawned an active School Nutrition Coalition working on school lunch issues and school-farm connections (see related article in this Bulletin). In addition, arising from the Local/Regional discussion in November, a Local Food group will meet on January 16 to discuss farmers markets and other topics.

FOOD FOR THOUGHT School Nutrition Coalition

The goal of the **Life in the Balance Series** has been to mobilize our community to become more sustainable and resilient to climate change and changing energy resources by supporting action groups established at the forums. After *Food For Thought* in November, parents and others concerned about the quality of food served at the schools and those who envision a partnership with local farms as a way to help struggling farmers in the community, formed the School Nutrition Coalition.

The goal of the Nutrition Coalition is to provide health promoting, nutrient dense, affordable lunches to all children attending Concord's public schools, to educate the school community about healthy and sustainable food options, to foster community-wide awareness and support of our goals, and to promote reform of state and national policy related to nutritional value and sustainability of our food supply.

The initial focus is K-8. There are three integrated components to our effort: (1) removing unhealthy additives from foods (including transfats, preservatives, high fructose corn syrup, MSG, excessive sodium, dyes, and, eventually, genetically modified foods); (2) establishing a robust farm-to-school program that increases the diversity and amount of food purchased from local farms while preserving Concord's agricultural heritage and open space; and (3) establishing school gardens and food-related curricula that would give our children (and their families) handson experience with growing food, with valuable lessons about health, the environment, and sustainability.

STATUS OF E-WASTE BILL & UPDATED BOTTLE BILL (UBB)

The **E-Waste bill** (formerly H. 833: *An Act Relative to Producer Responsibility for Discarded Electronic Products*, now H. 4374) was reported out of committee favorably before the winter recess and sent to the Joint Committee on Rules. This bill needs to move to Ways and Means this legislative session (by July 2010) in order to be voted.

The Updated Bottle bill (H3515/S1480 An Act To Improve Recycling Rates In The Commonwealth) has not yet been reported out favorably from the Joint Committee on Telecommunications, Utilities and Energy. The LWVMA is working closely with MassPIRG and the Sierra Club MA to promote passage of this bill. Local Leagues in committee member districts have been contacted and asked to contact legislators urging support of this bill and submission of a resolution in support of the bill for approval by town administrations in towns and cities that have not yet passed a supportive resolution. This bill needs to move to Ways and Means this legislative session (by July 2010) in order to be voted; sixteen years and counting!

CAMPAIGN FINANCE REFORM

As this past year has demonstrated, the influence of special interests continues to intrude upon the legislative and elective process, undermining attempts to enact meaningful legislation to address the serious issues we face as a country and society. It is increasingly clear that attempts by citizens and grassroots organizations to impact the legislative process through traditional advocacy channels are no match for the powerful counterforce of special interests. When members of Congress are beholden to special interests, the voice of the citizenry is muted.

While work on single issue efforts must continue, enactment of campaign finance reform is fundamental reform with the potential to transform 'business as usual' and positively affect the full spectrum of legislative efforts.

Campaign finance reform legislation is currently pending in Congress. The Fair Elections Now Act (S.752 and H.R. 1826) would authorize publicly financed campaigns for members of the U.S. House and Senate and is consistent with the principles of campaign reform legislation endorsed by the LWVUS. There is growing momentum across the country for campaign finance reform. Campaign finance reform represents an opportunity and responsibility to reclaim the political process and restore the trust necessary to thrive as a democracy.

For these reasons, the LWVCC has formally requested that the LWVUS assign campaign finance reform to the highest level of advocacy priority during the 2010-2012 program cycle. Plans are also underway to alert local Leagues across the country regarding the urgent need for campaign finance reform. The letter submitted to the LWVUS is included in the Bulletin for your reference. We'll be sure to keep you posted on the response from LWVUS and ongoing work on this issue.

In a separate but related matter, the US Supreme Court is about to render a decision in Citizens United v. Federal Election Commission (FEC). There is grave concern on the part of many who are following this case that the Supreme Court will lift restrictions on unlimited campaign spending by corporations and unions, further deepening the steady erosion of limits on such spending. In her recent commentary on the League's amicus brief to the Supreme Court, LWVUS President, Mary Wilson, describes the threat such a decision poses to our democracy (http://www.lwv.org/AM/Template.cfm? Template=/CM/ContentDisplay.cfm&Co ntentID=14510).

Attorney Jeffrey Clements will be joining us at our Winter Member Breakfast on January 13th to speak about this case. The LWVCC is also collaborating with Alliance for Democracy to sponsor a public presentation by Attorney Clements tentatively planned for March.

LWVUS NATIONAL PROGRAM PLANNING

On February 3rd right after our monthly Board meeting, we will take part in LWVUS Program Planning. This threepart process, a core component of the League's mission, is composed of program planning, study and consensus, and advocacy. It is what makes the League a grassroots organization. Local League's across the country send their recommendations to the national League for issues that they would like to see promoted to the top tier. We have already sent our recommendation for Advocacy Priority. We recommended that campaign finance reform be moved to the top tier.

In February we will decide whether we need a new national study, a review or a concurrence of any of the national positions. Once we have studied an issue and come to consensus, we can take a stand and lobby for that issue. The top recommendations will be reviewed and voted on at the LWVUS National Convention in June.

Join us next month by attending the meeting, especially if there is an issue that you feel strongly about that the League has not addressed.

Dear Ms. Duffy:

We are contacting you on behalf of the LWVCC to ask that campaign finance reform be designated as a top tier advocacy priority of the LWVUS during the 2010-2012 program cycle.

While there are many urgent issues that need to be addressed by Congress, a review of critical legislative efforts in the past year alone leads to the unavoidable conclusion that money has become the most influential determinant of legislative outcomes. Special interests are robbing the electorate of its voice and blocking the essential changes needed to deal effectively with the needs of the citizenry and the monumental issues we face as a country.

The current battle to enact meaningful climate change and health care legislation, two LWVUS advocacy priorities for 2009, are prime examples of this disturbing phenomenon. Unless we deal effectively and comprehensively with the underlying reasons for 'politics as usual', special interests will continue to stymie the democratic process, with diluted and potentially counterproductive legislation as the result.

Given the League's comparatively limited resources in relation to special interests, we urge that the LWVUS focus on fundamental reforms that underlie the legislative and election process.

The Fair Elections Now Act (S.752 and H.R. 1826) is an example of such reform. This legislation would authorize publicly financed campaigns for members of the U.S. House and Senate.

The LWVUS is already on record as being in support of an earlier version of the Fair Elections Now Act (S. 936), as documented in LWVUS President, Mary Wilson's 2007 letter to the Senate (attached). The current House and Senate versions of the bill contain many of the key provisions needed to ensure its effectiveness. Additionally, there is bipartisan support for this much needed reform with 124 members of the House of Representatives listed as co-sponsors.

On November 6, 2008, the LWVUS joined forces with the Brennan Center for Justice, the Campaign Legal Center, Common Cause, Democracy 21, Public Citizen and U.S. PIRG to issue a Government Integrity Reform Agenda for 111th Congress (http://www.lwv.org/AM/Template.cfm?Section=Home&TEMPLATE=/CM/ContentDisplay.cfm&CON TENTID=12350).

Repairing the public financing system for presidential elections and creating a new public financing system for congressional elections is cited as the "overriding priority for fixing Washington" in this document.

There will surely be an ongoing need for public oversight and monitoring of the legislative process, but establishing true campaign and election reform through public financing will level the playing field so that the merits of legislation and the public good—rather than special interests—will dictate outcomes.

We urge the LWVUS to designate campaign finance reform as its highest advocacy priority for 2010-2012. There can be no greater cause than the restoration of our democratic process and the confidence of the people, and no more fitting role for the LWVUS as a force on behalf of that repair.
