JANUARY LWVCC BOOK GROUP INFIDEL BY AYAAN HIRSI ALI

The next meeting of the LWVCC Book Group will meet on Wednesday, January 28, 2009, in the Trustees Room of the Concord Free Public Library from 10:00 – 11:30 AM. The book we will discuss is *Infidel* by Ayaan Hirsi Ali.

Ms. Ali is a Somali-born Muslim, currently residing in the USA, who speaks forcefully against violence against women particularly in the Muslim world. She fled Somalia and sought asylum in the Netherlands, gaining citizenship and becoming a member of parliament. She received death threats after working on a documentary on domestic violence. The director of that film, Theo van Gogh, was assassinated.

This is a powerful and moving book and our discussion promises to be both dynamic and enlightening.

Trinity Church, 81 Elm St, Concord Keynote speaker: State Rep Byron Rushing Asst. Majority Whip and co-chair, MA Commission to End Homelessness

Rep Byron Rushing, an engaging and charismatic speaker, will describe the visions, goals, conclusions and recommendations of the Massachusetts Commission to End Homelessness. These goals include ending the widespread use of shelters and motels and increasing affordable housing opportunities. He also will tell us about initial steps in the implementation of the Commission's recommendations – and shed light on what concerned people can do to end homelessness.

THE LEAGUE ON AIR: ELECTION 2008 ON LOCAL CABLE

Thanks to the cooperation of our local cable television station, CCTV, and the work of many League members, League of Women Voters programming was front and center as the November 4 elections approached. The program schedule on Channel 8 was crowded with a variety of educational programs and public service announcements from the local, state and national Leagues. We are grateful to CCTV Executive Director Charles Paige for his assistance in reaching voters during the fall election season.

Our own Candidates' Forum, held on October 19th and filmed by League Vice President Becky Shannon, was aired repeatedly in the weeks before the election, giving voters a close-up look at Rep. Cory Atkins (D) and her opponent Mr. Richard McClure (I). LWVCC also secured from the LWV of Sudbury a video of the debate they sponsored between Sen. Susan Fargo (D) and her opponent Ms. Sandra Martinez (R), which we asked CCTV to air. CCTV also aired a Fargo-Martinez debate sponsored by the LWV of Chelmsford, which the station obtained from a non-League source.

LWVCC, working with students from Concord-Carlisle High School, produced a program in which students presented the pros and cons of the three state ballot questions relating to taxation, marijuana and dog racing. League board member Cindy Nock organized the program, and Becky Shannon filmed it. CCTV aired the show repeatedly on both Channel 8 and Channel 9, assisting LWVCC in educating the public on these important proposals.

LWVCC also asked CCTV to broadcast public service announcements created by LWVUS and LWV of Massachusetts, and again, our local cable access station helped us in reaching the voters to encourage participation in the historic 2008 election. We hope to use the PSAs leading up to future elections.

Our League is grateful for the assistance of DigiNovations, 676 Elm Street, Concord, in converting the LWVUS beta tape of the

Freedom of Expression public service announcement into the required DVD format. DigiNovations was willing to take on this task and turn it around in a matter of a few hours, helping us to submit the PSA for airing during the two weeks before the November 4 election. We thank particularly DigiNovations owner Michael Kolowich and Director of Operations Shawn Whitaker.

On October 19, 2008, the League of Women Voters of Concord-Carlisle hosted a lively Candidates Forum at the Concord Town House featuring the State Representative candidates for the 14th Middlesex District, Rep. Cory Atkins and Mr. Richard McClure. (We also invited the State Senate candidates, but only one accepted our invitation, so we could not include that race in our forum.) The League forum was cosponsored by the *Concord Journal* and the *Carlisle Mosquito*, both of which provided advance publicity. Our local cable TV station, CCTV Channel 8, aired this voter education program up to the time of the election, and the *Concord Journal* provided newspaper coverage.

Nancy Carapezza, former LWVMA president and a member of the LWV of Wayland, very ably and graciously moderated our Candidates Forum. In addition, the event would not have been possible without the help of the following League members: Becky Shannon, who filmed the program for cable TV; Louise Haldeman, timekeeper; Erica Morrison, refreshments; Ardis Bordman and Nancy Beeuwkes, question sorters; Cindy Nock, usher; and Nancy Beeuwkes, who opened the program.

January 2009 Domestic Violence Prevention activities - January 2009

Introduction: national and state League chapters have made a significant commitment to domestic violence prevention. Our newsletters will now contain a report each month on the activities within Concord and surrounding towns about this issue. Included in these reports will be Rachel's' Box Project, the Concord-Carlisle Domestic Violence Roundtable (Roundtable), Domestic Violence Services Network (including DVVAP and Network for Women's Lives (Network)), and a men's group Men Against Domestic Abuse and Control, which meets in Carlisle. New areas including National Organization for Women (NOW)

<u>Domestic Violence Services Network</u> is celebrating its 10th anniversary this year with an event at the National Heritage Museum in Lexington on March 28, 2009. Law enforcement collaborators will be honored. Gerry Leone is the keynote speaker and recipient of DVSN's first award. Police chiefs who have worked cooperatively with DVSN will also be recognized and honored.

DVSN will be holding its **Advocate Training** from **March 2 through March 21, 2009**. Volunteer training is a 36-hour, 3-week program held at both the Concord and Bedford Police Departments: Monday & Wednesdays 6:30-9:30 PM and Saturdays 9:00 AM to 3:30 PM. Advocates provide direct service to domestic violence survivors via phone and at Concord District Court.

<u>Rachel's Box Project</u> serves victims of domestic violence, as well as child and elder abuse, in **50 locations around the western suburbs**. Please notify Nancy James 978-369-2771 if you notice boxes in disarray or needing materials.

Network for Women's Lives now a part of the Domestic Violence Services Network, continues its primary mission to provide education and outreach. Performances of "A Memory, A Monologue, A Rant and A Prayer" (a collection of monologues from around the world) at Harvey Wheeler Community Center are scheduled for March 6, 7, and 8. In January the *Network* is starting a new pilot program of *6 week Women Empowerment Groups*.

On May 6, 2009 a *Clergy Symposium* is scheduled (watch for details in upcoming issues). *Support Groups for Women with Controlling Partners*: These programs help women achieve safety and self-care, understand the more insidious and coercive behaviors of an abuser, and examine how the control affects their lives. The sessions are led by trained social workers who have been working in the field of domestic violence. For more information, call (978) 287-4089.
