ANNUAL LWVCC WINTER MEMBERSHIP BREAKFAST

Colonial Inn, Concord Center Wed, January 12, 2011 9-11 am

Our speaker will be Commissioner David Morales of the Commonwealth's Division of Health Care Finance and Policy. Join other League members and guests as we gather for this popular annual event. Enjoy a warm breakfast, meet new members, and find out from League leaders about work being done and upcoming plans. This is a good opportunity to find out how to get involved.

After breakfast, Commissioner Morales will provide information on the status of the Massachusetts health care legislation passed in 2006, Chapter 58: An Act Providing Access to Affordable, Quality, Accountable Health Care. This legislation was the model for the national health care law, the Patient Protection and Affordable Care Act (PPACA) signed by President Obama on March 23, 2010.

Currently, according to Commissioner Morales, Chapter 58 has ensured that over 97% of Massachusetts residents now have health insurance coverage and more Massachusetts employers offer health insurance coverage than other states in the nation. But the challenge that remains is the continued increase in insurance premiums. Without intervention over one third of family income will go to health insurance by 2016. The goal of the Commonwealth at this time is to control costs. What are the options? How is Chapter 58 working and how will it be affected by PPACA? Come to this breakfast to learn about the Massachusetts law and be prepared to ask the difficult questions about health care reform in the Commonwealth and in the nation.

The cost per person for the breakfast will be \$10.00. Details will follow in December.

FALL CANDIDATES FORUMS

LWV FALL CANDIDATES FORUMS VALUABLE RESOURCE FOR VOTERS

This fall's election season kept Leagues busy statewide with organizing and hosting nonpartisan candidate forums. From July through October, the LWV of Massachusetts and local Leagues throughout the Commonwealth held over 25 forums on candidates and ballot issues, many of which were broadcast on cable TV and covered in detail by the press. LWV-trained moderators maintained forums' focus on issues and facts and helped carry out the League's policy of nonpartisanship, assuring fairness to candidates and useful information for voters.

Our League was proud to sponsor two candidate forums this fall. Our 5th Congressional District forum on October 16th was the only one that brought all four of the candidates running for that U.S. House seat together on the same stage. Sponsors of other debates limited their invitations to the major party candidates, Jon Golnik (R) and incumbent Niki Tsongas (D), leaving the Independents, Dale Brown and Bob Clark, out of the discussion. LWVCC welcomed them all and gave the voters a chance to hear their views. Risa Nyman (LWV of Brookline, past LWVMA President and Executive Director, and past LWVUS board member) moderated the forum at the Alcott School, and volunteers from Leagues in Acton Area, Harvard and Westford joined our members to make the event run smoothly. Hats off to all who helped!

Just a few days later, on October 20th, LWVCC hosted another forum for the State Senate and Representative candidates, again at the Alcott School. Sen. Susan Fargo (D) and challenger Sandi Martinez (R) faced off first, followed by Rep. Cory Atkins (D) and her opponent, K.C. Winslow (I), with Nancy Carapezza (LWV of Wayland and past LWVMA President) moderating. The exchanges were lively and substantive, and the League and audience questions covered a wide range of topics. As always, League volunteers worked hard on this event, and the efforts paid off.

The media enthusiastically covered both of the LWVCC's pre-election programs. Articles and photos on our forums garnered front-page, above-the-fold coverage in *The Concord Journal* for two consecutive weeks. A *Lowell Sun* reporter and local bloggers also published stories. We filmed the forums for cable TV, and you can still view them online as Video on Demand at www.concordtv.org.

LIFE IN THE BALANCE: TROUBLED WATERS

Last year the Life in the Balance (LITB) team organized five events: a panel discussion about solid waste issues called Let's Talk Trash, a public screening of the movie FOOD INC., a panel discussion about agricultural and nutritional issues called Food For Thought, a public screening of the movie THE GREAT SQUEEZE, and a panel discussion about energy issues called Powering The Future.

This year LITB brought you two forums on water issues. On October 22 a public screening of the movie TAPPED was held at the Alcott School auditorium in Concord and was attended by 70 people. The movie highlighted the issues around fresh drinking water by examining the story of bottled water in which water is privatized and becomes a commodity that is pumped out of aquifers or even out of municipal water systems, shipped great distances and sold at immense profit. The amount of waste and pollution that is generated in making plastic drinking water bottles and in transporting the water bottles is enormous and entirely unnecessary in our local communities where safe drinking water is available right at our taps. The movie raised such questions as where does our water come from, who owns the rights to water, and how do we know our drinking water is safe? The movie is available at the Concord and Carlisle public libraries or can be found on the internet at www.tappedthemovie.com.

On Friday November 5 a second water event was held in the form of a panel discussion about local water issues called "**Troubled Waters**" and was attended by 68 people. The panelists were **Ruth Caplan**, who appeared in TAPPED and is National Campaign Coordinator for the Alliance for

Democracy's Defending Water for Life Campaign and past chair of the national Sierra Club's Water Privatization Task Force, **Alan Cathcart**, Water & Sewer Superintendent for the Town of Concord, and **Valerie Lane**, President, ValiantLane LLC, an environmental and management consulting firm.

Ruth spoke eloquently about water as a human rights issue and the connections between water and waste, energy, food, transportation and political conflict. Alan spoke to us about our local watersheds, water cycle and public drinking water system. He talked about the importance of a well managed water supply. Valerie spoke to the safety of our local water systems and the threats to it especially in the form of emerging contaminants found in pharmaceuticals. The first part of the program with speaker was taped for CCTV and will be available on demand at www.concordtv.org and will be shown on our local cable television channel.

Following the speakers, 50 attendees gathered in five breakout local action groups and discussed issues and actions around Bottled water, Concord water, Carlisle water, Watershed protection, and Household/personal actions. A summary of the group discussions and a copy of the resource sheet handed out at the forum are available at the LITB website.

The **Life in the Balance** forum series is a collaborative effort between LWVCC, ConcordCAN, Carlisle Climate Action, and the Alliance for Democracy. Information and resources about LITB can be found at www.lwvcc.org/lifeinthebalance.html.
