MAY 4 BOARD MEETING


- Minutes of the April 6 Board meeting were approved.

ANNUAL MEETING

LWVCCA held our Annual Meeting on May 13. This was our second Annual Meeting conducted as a Zoom "Virtual" meeting.

We began with a 15 minute "social hour," to let members talk informally and catch up a little -- enjoyable, but not the same as meeting in person, which we hope to be able to do next year.

Suzanne Brock then introduced our speaker for the evening, LWVMA Executive Director Patricia "Pattye" Comfort, who spoke on expanding access to the ballot - nationally (For the People Act, John Lewis Voting Rights Advancement Act), in other states (Georgia, Arizona, Iowa, etc.), and in Massachusetts (VOTES Act). A recording of Pattye's talk is available at LWVMA.



We then proceeded to the Annual Meeting itself, with Florence Seldin as Parliamentarian. We took the following important actions:

- We approved the Local Program for 2021-2022: this will direct all of our actions for the coming year.
- We approved the 2021-2022 Budget as Proposed and Voted by the Board: this will govern our fundraising, and how we will pay for the adopted Program.
- We approved the Report of the Nominating Committee: this establishes the Officers, Board of Directors, and Committee Chairs who will implement the Program for the coming year.

All of this is outlined in the 2021 Annual Meeting Workbook, sent to all LWVCCA members previously.

In addition, members presented the following Directions to the Board:

Directions to the Board

- Discuss when to meet in person and when to meet via Zoom. How do we want to operate going forward? Add this discussion to the June 2021 Board agenda.
- Write MA Secretary of the Commonwealth William Galvin insisting that he join the Electronic Registration Information Center (ERIC) as directed by the legislature.
- Suzanne asks that we all brainstorm ways to attract more members who can be groomed for positions going forward.
- Talk with younger folks to bring their attention to the LWVCCA and membership.
- Brainstorm fundraising ideas. Add this discussion to the June 2021 Board agenda.
- Send a letter of condolence for Richard Costello, former owner of the Chatham Squire and longtime LWVCCA supporter.

A note about the Annual Meeting:

This year we had to scramble to achieve the required quorum of 30 members.

The Annual Meeting is an essential – and legally required – part of our work. It may seem mundane - even boring - but without it we cannot carry out our work for the year. In this meeting, LWVCCA members have the opportunity to set the agenda for our entire year's work: they can modify the proposed program and budget, they can make nominations from the floor for officers, board members, and committee chairs.

Your participation is important. Thank you to all who joined us! We hope to see you all, in person, next year.



PRONOUNS

League Members,

In keeping with our Diversity, Equity and Inclusion (DEI) mission, the League is making a transition towards being more inclusive with our language beginning with the introduction of gender friendly pronouns. Pronouns are used in place of proper names and have traditionally included he/she, him/her and they/them. Our shift will allow members to self-identify instead of having people make assumptions about their gender identities. You will begin to see changes on our League brochures and will be given the option of specifying which pronoun you would be comfortable with.

Over time you will also see a shift away from binary language such as male and female, ladies and gentlemen, and guys and gals: possible changes may include League members, friends, folks, or all. The League is moving away from using binary language so that persons of all gender identities feel welcome.

As with all change, members will need to practice using gender neutral terms. The more practice we have the easier it will become. As we move forward and change our internal and external messaging, preferred pronouns will become more familiar and eventually, when we return to in person events, we can begin to use pronouns on our name tags for members and participants. Our aim is to make the League open to passionate individuals of all genders. With all of us working together, we can remove one more barrier to full inclusivity. If any of you have any questions or concerns regarding this transition, please do not hesitate to contact any Board member.

Gloria Hanson proclaims she is an activist who wants to work with legislative efforts aimed at avoiding gerrymandering of voting districts. She is interested in promoting voter registration. Even though she is a new member to the LWVCCA she is an experienced Leaguer inasmuch as she belonged to the League in Philadelphia for several years. Gloria grew up in Brooklyn, Connecticut. Her undergraduate work was completed at the College of New Rochelle in New York. She continued during her graduate studies as a biology major at Brown University where she met and later married a fellow biology major Richard Hanson in 1961. It was in Cleveland where Gloria and her husband raised their three children: two sons and one daughter. Her daughter resides on the Cape. Gloria's husband died seven years ago and she moved to the Cape in 2018. She also has a granddaughter who lives on Cape Cod. Gloria had spent most of her life in Ohio due to her husband's appointment as Chairman and Professor of Biology and Chemistry at Case Western Reserve University in Cleveland. While raising her family Gloria returned to graduate school and earned her Master in Social Work degree at Case Western; and later worked as a clinical social worker in various agencies in Cleveland.

Currently Gloria Hanson is actively working with Project Connect, a group that she and a friend started. Project Connect is an organization that focuses on diversity, equity, and inclusion issues on Cape Cod. Gloria has also joined the DEI Committee in the LWVCCA. Writing is a major point of interest in Gloria Hanson's life. She states: "I write every day." Her professional writing includes her work with journals and periodicals regarding clinical social work. She is a member of The Cape Cod Writers Studio. She is also an author who has published nine books. Two of her books

are: Coping: Embracing Change and Loss (2020); and The Secret of the Trunk (2019).

Summer reading!

For summer reading, the DEI Committee has selected two books that address racism and inequality in America. We are planning discussion sessions, with the first one to be held by the end of September.

Along with being informative about issues rarely taught in school, these books include useful suggestions to begin healing the racial divide. Our intent in choosing these books is to build on the necessary conversations the DEI Committee has begun.

The books are:

- 1. *Uncomfortable Conversations with a Black Man,* Emmanuel Acho (available at BJ's and in the CLAMS system).
 - Based on Acho's <u>YouTube episodes</u> of the same name, the book builds on those conversations and goes further. He frames a series of questions on racism in each chapter of the book, explores how we as a country got here, talks about the uncomfortable but necessary conversations we need to have around those questions, and then talks about what we can do to educate ourselves about those issues and change things for the better going forward.
- 2. Waking Up White, Debby Irving (available in the CLAMS system).
 This book is a wake-up call for white people who want to consciously contribute to racial justice rather than unconsciously perpetuate patterns of racism. With honesty and humility, Irving shares her own story of transformation —a journey of opening herself to learning about the realities of racism and the unintended impacts of white privilege.

- 3. Everyday Bias: Identifying and Navigating Unconscious Judgments in Our Daily Lives, Howard Ross.
- 4. Blindspot: Hidden Biases of Good People, Mahzarin Banaji.

LEGISLATIVE COMMITTEE

The VOTES Act Public Hearing—May 19, 2021 LWVCCA Was There!

The Massachusetts Joint Committee on Election Laws held its first public hearing of the year—via Zoom—on May 19 to hear input on a variety of election-related bills, such as *An Act Fostering Voter Opportunities Trust, Equity, and Security (VOTES Act)*. This bill will make permanent the election reforms which produced record voter turnouts in last year's elections and will enact several additional election modernization items. The VOTES Act includes early and mail-in voting, risk-limiting audits, joining the ERIC coalition for updates to voter lists, voting materials for eligible voters in correctional facilities, and same day registration to correct errors on the voter lists. To date, more than 120 legislators have endorsed the VOTES Act.

The Committee heard testimony for 2½ hours from MASSPIRG, MassVOTE, the Massachusetts

Voter Table, the LWV of Massachusetts, Common Cause, the Racial Justice Program of the ACLU, Lawyers for Civil Rights, and the LWV of the Cape Cod Area—the only local League to testify in person at the public hearing.

Testimony was overwhelmingly supportive of the VOTES Act proposals and for passing the VOTES Act intact, with all its sections. According to Pattye Comfort, Executive Director of the LWV of Massachusetts, "...We are Massachusetts. We believe in increasing the access to our elections for all eligible voters. And in these frightening times for our democracy, we need to make that clear."

Additional comments for the Committee focused on upfront funding for officials to enact the VOTES Act provisions, kudos to local elections officials for last year's election accomplishments, voting access for caregivers, mobile and blockchain voting for active service members, involvement of more young voters in the election process, and improvements in the automatic voter registration system.

LWVCCA President Suzanne Brock was the wrapup speaker at the public hearing. In a recent email, she credited the staff of the Joint Committee on Election Laws for an excellent job in orchestrating the virtual Zoom participation of those who signed up to appear in person. Her testimony re-emphasized the need to make voting fair and accessible to all, regardless of medical conditions, age, disabilities, transportation, address changes, or work schedules. Suzanne remarked personally on her own rewarding experience working at the polls last year and hoped that the Massachusetts legislature will "lead the way" by quickly passing the VOTES Act. "Voters rights organizations and members of the public have devoted extensive time and energy into sharing their views and expectations with the Committee. That's what public hearings are for. However, it was difficult from my experience to determine whether the Committee was sincerely interested in gathering additional information or fulfilling the requirement of holding a public hearing for this legislation. Were they actually listening to us? Let's hope so," Suzanne said.

We applaud Suzanne for taking the time to speak for the members of the LWVCCA—the only local League present at this hearing—and thank all our LWVCCA members who submitted written testimony to the Committee and to their own legislators. Let's watch for the next steps for the VOTES Act!

VOTER SERVICE COMMITTEE

Redistricting Part 2 – People Powered Fair Maps (Part 1 is in your May, 2021 *Voter*)

The Massachusetts Special Joint Committee on Redistricting is charged with designing district maps based on the 2010 Census. They will determine the Federal Congressional districts, State Senate and State Representative districts and the Governor's Council districts (* - see Note). On Monday, April 26 the U.S. Census Bureau released its initial population numbers. Both California and New York will each lose a congressional district. The number of Massachusetts congressional districts remains the same.

The next meeting of the Special Joint Committee on Redistricting was held at 5:30 p.m. on Monday, May 24th for Congressional District 2, Congressman Jim McGovern's district. District 2 is in Western Massachusetts, from the Blackstone Valley to the Pioneer Valley. Worcester, MA's 2nd largest city, is in this district but much of Western MA is rural. With a shrinking population it was acknowledged several times during the evening that changes in the district will have to be made but at least MA didn't lose a Congressional seat as we did back in 2011. Elected officials, individual citizens, and representatives from the following organizations testified: Drawing Democracy, NAACP, Worcester Interface, the MA Alliance, the Labor Assembly of the United Auto Workers, Lawyers for Civil Rights, and MA Voter Table. It was reiterated during the evening that the districts must be contiguous and congruous - a compatibility with all citizens - majority and minority neighborhoods; immigrants and refugees; the disabled, blind and physically challenged, the incarcerated. Both Co-Chairs Sen. William Brownsberger and Rep. Michael Moran voiced their desire that this be an opportunity to make the disenfranchised included and engaged.

In later hearings they will have translators for citizens more comfortable in their native language so they can be part of the process. As Beth Huang, of MA Voter Table, summed it up, "This is a grassroots conversation. We all eagerly anticipate the final Census data."

Rosemary Shields, co-chair of the Voter Service Committee, will be monitoring these meetings. Rosemary will look for other volunteers for back-up and discussion on the action and concrete steps Cape Cod needs to take. Since LWVMA Co-President Judy Zaunbrecher has been working on this issue since last year and has held several webinars on the subject, we will also be looking for guidance from the LWVMA.

The goals of the LWWMA for redistricting are:

- Ensure the 2021 redistricting in Massachusetts is a transparent process and includes public participation.
- Educate the public and advocate for restoration of the Voting Rights Act of 1965 through the passage in the U.S. House of Representatives and Senate of the Voting Rights Advancement Act, the For the People Act, and other legislation.

Our campaign will include diverse voices and points of view to set goals and strategies and be equitable and inclusive in the organizing and execution of the plan. This campaign will be built on collaboration—between the national, state, and local Leagues and with other civic, good government, and civil and voting rights organizations.

Background:

In 2011 the LWVMA found the Massachusetts redistricting to be a fair and open process. In fact, it was brought up by Chairman Moran at the Joint Committee's May 4, 2021 hearing that MA was one of only five states that was NOT sued after the process of redistricting was completed. That is why the LWVMA did not work towards an independent state commission for redistricting.

The rules for drawing up district maps is that a district must be contiguous, with an equal number of inhabitants. No county, city or town will be split. In 2011 the maps were released in October / November and were approved in late November. There is more of a time constraint in 2021 because official Census results will not be available until September 30 (vs. April 1, when it's usually released). The state Constitution states that candidates for State Representatives must live in their district for one year before the following year's election. The redistricting maps, therefore, must be approved by November 8, 2021.

Summary of the LWVMA testimony before the Special Joint Committee on Redistricting, April 14, 2021:

The League urges the Committee to conduct at least 12 hearings in 2021. The League encourages using open meeting law standards for the Committee's work. The Special Joint Committee on Redistricting should design its public facing website and process to encourage unbiased testimony by citizens-at-large, representatives of public interest groups, and members of historically underserved communities. Providing the information in a variety of languages representative of the diverse communities in Massachusetts, making hearings easy to attend for residents with limited access to broadband and transportation, and ensuring access for people with disabilities is important so these communities feel welcome to participate in the process. LWVMA recognizes that the current health emergency due to COVID-19 limits the Committee's ability to hold hearings in person. We encourage the Committee to work to ensure fair and equal access to virtual hearings and to hold inperson hearings as soon as public health officials determine it is safe to do so.

*Note:

The Massachusetts Governor's Council, also known as the Executive Council, is composed of eight individuals elected from districts, and the Lieutenant Governor who serves ex officio. The eight councilors are elected from their respective districts every two years. The Council meets weekly to record advice and consent on warrants

for the state treasury, pardons and commutations, and recording advice and consent to gubernatorial appointments such as judges, clerk-magistrates, public administrators, members of the Parole Board, Appellate Tax Board, Industrial Accident Board, notaries and justices of the peace.
