If you have the opportunity to assure someone of the legitimacy of our election process, please speak up.

October will be busy for our Voter Service team. Rosemary and Anita are knee deep in preparing for 3 candidate debates for Cape races. The dates will be forthcoming but I hope that you all have a chance to tune in and listen to the candidates' answers to the various questions presented. With today's supercharged issues, making decisions around the best candidate to represent us requires as much information as can be gathered.

Please continue to be as involved as you can. Working remotely has changed everyone's perception of "reality." If you are looking for ways to fill the void, give Renate Sands a call. She is already sifting through legislation that we

Nancy and her husband Jim retired to the Cape in 1997 and it was some short time after that that she joined the League.

Nancy, almost ninety years old, had participated in League activities as recently as this winter when she served on the nominating committee. As we reviewed Nancy's activities with the League it was interesting to see that willingness to serve on the nominating committee, which can be both privilege and challenge, was one of Nancy's frequent choices. Her other choices including working on the League's newsletter – *The Voter*, and serving on the Helen S. Aaron Educational Trust and for many years on the County Committee. Wherever Nancy served she did it with a special grace. Former League president Karen Mazza put it this way: "her contributions on the Board as a smart, kind, insightful woman who spoke with few words but with passion and humility at the same time." This was a common sentiment of Board members who appreciated Nancy at Board and other meetings.

Nancy was committed to the League's study of our county government serving as co-chair and reliable note-taker and simply member of the committee for a number of years. In that committee it was not uncommon to get off track; Nancy had a smooth way of bringing the group back to task. Former League president and County Committee chair Judy Thomas commented, along with committee members Paula Bacon and Renate Sands, that her quiet, thoughtful, knowledgeable comments, approach and kind demeanor were always respected by the members of one of the more "stronglyopinionated" committees in the League.

Another former League President Florence Seldin worked for years with Nancy as coeditors of the *Voter*.

Having nothing to do with the League but everything to do with being human, Nancy set a beautiful example for her friends and League members as she aged, doing all she was able to do for as long as she was able. Meeting Karen Mazza on the beach this past fall, she commented that she walked 45 minutes every day. When serious illness struck in the winter, she approached that with her characteristic grace, choosing to accept her illness and mortality.

Thank you, Nancy, for your service, your example and many good memories.

Approximately 22 members were able to join us for our September 24 Opening Meeting focusing on Diversity, Equity and Inclusion (DEI). This was our introduction to DEI as a Lens to examine our work as a League and reflect on ways that our organization and our work in the community should be informed by a greater intentional commitment to diversity. We have adopted DEI as a major goal at the national, state and local levels of the League because as an organization that is committed to making democracy work, we realize we cannot advance democracy without advancing racial and social justice.

In recognition of this centennial celebration of the suffrage movement, Professor Katrina Huff-Larmond shared profiles of three Black women who were influential in the suffrage movement in Massachusetts: Josephine St. Pierre Ruffin, Maria Baldwin and Sojourner Truth. Katrina highlighted their accomplishments and the obstacles they overcame to advocate that the suffrage movement should also include voting

rights and representation for black women. She pointed out that the development of social clubs was an important strategy and support for educating people and developing social justice organizing skills.

Facilitators Vedna Lacombe-Heywood and Patty Shephard from the DEI Committee of LWVMA presented a definition of the DEI Lens and offered questions to help us reflect as a League on our present level of commitment to DEI. Polling questions revealed we had consensus around most of the questions, but a few questions where we had different perceptions of our progress offer future issues for exploration. We were offered additional guiding questions and resources in helping us identify what our League most needs to do in moving us farther along the goal of implementing diversity, equity and inclusion.

VOTER SERVICE COMMITTEE REPORT

On Tuesday, August 18, a bright, enthusiastic group of Barnstable High School students and alum organized a "Her Voice" rally on the Hyannis Green The purpose was to commemorate 100th anniversary of women gaining the right to vote and the continuing importance of speaking out for justice for women, people of color, indigenous people, and others struggling with a history of inequality. Voter Services had a Voter Information table, and LWVCCA President Suzanne Brock and other inspiring community leaders spoke about the importance of voting and speaking out for justice.

On Thursday, September 10 the Cape Cod Young Professionals (CCYP) Barnstable, League of Women Voters of the Cape Cod Area (LWVCCA) and the Cape Media Center Dennisport (CCMC) sent out invitations to candidates to participate in virtual candidates forums. The invitations were sent to the candidates running for the three contested State Representative races - the First. Second. and Fifth Barnstable District seats; the candidates running for Barnstable County Commissioner; and the candidates for the Plymouth Barnstable State Senate race. The plan is to have the forums on the first three Thursdays in October, beginning at 5:30 p.m. We are in the follow-up stage, sending a 2nd invitation to the candidates who have not contacted us to date (September 15). More details to come.

On Saturday, September 12 Voter Service Co-Chair, Rosemary Shields, met with Correnia Green of the Cape Verdean Cultural Center, and Jenny Putnam and Sally Greer of the Falmouth League met at the CV Cultural Center in Falmouth. We all brainstormed about how we could get in contact with hard-to-reach citizens to make sure they are registered to vote and are able to make it to the polls, especially in this time of Covid 19. The Cultural Center performs all sorts of community outreach, from Friday night take-out dinners to motorcycle ride fundraisers for the community. Besides all of our efforts on social media, Jenny was proposing a big VOTE banner flying across Sandwich Road in Falmouth in the center's parking lot. We will keep making contacts with the Cape Verde Community and the Falmouth League to coordinate efforts to get out the vote.



National Voter Registration Day , September 22. We had a table on the Hyannis Village Green from 10-2pm and at the Cape Cod Mall from 3-6pm.

Other works in progress:

- We're setting up a date to be outside Yankee Ingenuity in Chatham on a weekend in October.
- Amy Harris, Deanie Burdick and Anita Rogers are working to increase ballot & voter information access at the Barnstable County Correctional Facility. (U.S. citizens awaiting trial or incarcerated for misdemeanors have the right to vote.)
- We'll be working with volunteers to get information out to their towns by placing handouts and posters in public buildings and bulletin boards.

LEGISLATIVE COMMITTEE REPORT OCTOBER 2020

The state legislature took time off during August and is just starting to function again. Since we do not have any reports to give on legislation we have been following, the committee decided to write on article to explain Qualified Immunity, part of the social justice and police reform bill.

H48600/S2800 An Act relative to justice, equity and accountability in law enforcement in the Commonwealth.

This bill that addresses racial justice and police reform is presently in conference committee. One major hurdle that is causing oppositions to the bill is the inclusion of Qualified Immunity (QI) in the Senate bill, something which was not in the House bill. QI is a defense that shields police officer from personal liability in civil lawsuits unless the officer violates "clearly established principles."

QI is not a law passed by Congress, nor is it written in the Constitution. It is a legal document refined by the US Supreme Court, passed in 1967, which has been <u>greatly expanded</u> through the years. Today, QI protects public employees violating someone's civil rights unless there is an identical past situation in which a public official was held accountable. This makes it hard to convict someone in the most egregious cases because the action by the police was unprecedented. An example is the death of George Floyd and how it was committed.

QI is an important defense that arose out of a desire to protect government officials. It does not just protect police officers but all public employees. The new bill would ensure that qualified immunity cannot be used to defend civil rights violations.

S2800 does not do away with protection for Police officers: they will remain indemnified and have protection of their personal finances and assets. The Senate proposal would hold the city, town or state where they work financially responsible for misconduct in civil suits. Since QI applies to someone's civil rights being violated, officer violating those rights, would be tried in a civil suit. This gives an injured party the right to sue for damages and is one way of holding police accountable.

If there is a federal (national) law ending Qualified Immunity, then it would supersede any MA state law. According to the Cato Institute, either the Supreme Court or Congress could end Qualified Immunity.

(Rep. Karen Bass put forth a bill to reform QI and Rep. Pressley's amendment would end QI entirely.)

In answer to the question about the difference between Qualified immunity and indemnity, Senator Cyr had this explanation:

Qualified immunity and indemnity are two different concepts. Qualified immunity is a concept that public officials are immune from prosecution in the course of conducting their public work. Indemnity refers to who pays – currently police officers (and most all municipal employees) are indemnified, meaning they are not financially liable. The Senate's bill tackles and limits to some extent qualified immunity; we make no changes to indemnity. If the Senate bill were passed into law, a police officer (or any public employee) could be prosecuted if they violate someone's civil/Constitutional rights; they would continue to be indemnified, meaning they would not be financially liable.

Recall Petition

The Assembly of Delegates, with the approval of the Board of Regional Commissioners, petitioned the General Court of the Commonwealth to amend the Barnstable County Home Rule Charter to include a Recall provision for the removal from office of a member of the Board of Regional Commissioners.

The recall ordinance does not apply to the Assembly of Delegates. Their term of office is only two years whereas the term of office for a Commissioner is 4 years. A recall cannot be submitted until the Commissioner has served one year.

Thank you Judy Thomas for bringing this to our attention.
