Every election season we prepare ourselves and kick into high gear. Supporting voting rights and educating voters is the cornerstone of League. Likewise, "voting at its core is the core of democracy. The more people participate in elections and exercise their right to vote, the more important it is for politicians to represent voter interests. An active voting population protects democracy," as Emmaline Soken-Huberty outlines in this article, <u>Ten Reasons Why Voting Is</u> <u>Important.</u>

Voter Services is continuing their work as they prepare three candidate forums for the fall elections. On Wednesday October 12<sup>th</sup>, the League will host, 6:00-7:00 pm, a Barnstable County Sheriff forum followed, at 7:00-8:00 pm, a Cape and Islands District Attorney forum at Cape Cod Community College. The committee will also host a forum for State Representative of the 1st District Barnstable on October 18<sup>th</sup>, at 7:00-8:00 pm at the Cape Media Center. at Cape Cod Community College for National Voter Registration Day.

In addition, Karen Mazza is planning the first event of the Florence Seldin "Democracy Is Not a Spectator Sport" Speaker Series. This will be a Zoom webinar on October 25<sup>th</sup> from 7:00-8:00 pm to motivate and engage young people to vote. The program will feature a keynote speaker from <u>CIRCLE (Tufts University</u>) talking about their report "Growing Voters" as well as a panel of four local young adults to speak about why it is important for youth to vote.

Finally, all members are welcome to join Grandmothers Against Guns "Get Out the Vote Rally" at the Hyannis Airport Rotary October 14<sup>th</sup>, 11:30 am - 12:30 pm. Please support all of these efforts and help reach out to voters to encourage their participation.

The LWVMA supports Ballot question 4, "The Work and Family Mobility Act" which ensures that all qualified state residents, regardless of immigration status, can apply for a standard Massachusetts driver's license starting on July 1, 2023. The law was enacted on June 9, 2022. making Massachusetts the 17th state to pass this type of law. Read more at <u>LWVMA Statement on</u> <u>2022 Ballot Questions.</u>

We had a successful opening meeting on September 15th with over 30 members participating. Although all American citizens over the age of 18 are entitled to vote and many view voting as a privilege, it has not always been a privilege for every American and some still face challenges to freely exercising their right to vote. Massachusetts has passed a new voting rights act to help address some of those challenges. Still some people take voting for granted and decide not to. Others view voting as an irrelevant task or have become apathetic to the value of their vote. The LWVUS/MA and LWVCCA work hard to educate voters and encourage people not to take voting for granted. It is still very important for League members to motivate people to register and get out to vote! 

# DID YOU KNOW-?

....that, according to LWVMA's Immigration Specialist Jen Muroff in her testimony in the 2021-2022 legislative session, the 215,000 undocumented people in Massachusetts pay \$252.5 million in state and local taxes and \$593.6 million in federal taxes. Their total spending power in the Commonwealth is \$4.9 billion. They own businesses, care for our children, work in our restaurants, and study at our universities.

The LWVMA and the LWVCCA wholeheartedly supported the Safe Communities Act which never made it to a floor vote in the 2021-2022 legislative session. It would have ensured that immigrants are offered due process rights, and that local resources are not used to enforce federal immigration law.

The League also supports a YES vote on Question #4 on this fall's ballot—an effort to safeguard a law passed by our legislators this year against an attempt to repeal it. The law—the Work and Family Mobility Act—promotes safety on our roads and protects us all by requiring drivers' education, testing, licensing, and insurance of all drivers, regardless of immigration status. Vote YES to support this law.

### Margy Mahrdt spoke on gun violence



We were fortunate to have Margy Mahrdt, a local leader for <u>Moms Demand Action for Gun Sense in</u> <u>America</u>, a subgroup of <u>Everytown for Gun Safety</u>, to speak at our dinner. She provided statistics on the tragic use of firearms, as well as some ways to become more involved in gun safety and preventing gun violence. A lively question and answer session followed her talk. It was affirming to see the intense interest in the subject.

If you thought you knew about gun violence in America (editor's note – I thought I did!) Margy recited some statistics that may surprise you.

- There are about 40,000 gun deaths in the United States each year
- Suicide is the leading cause of gun deaths 24,000 per year
- There are more than 200 non-fatal gun injuries *per day* in the US
- Guns are the leading cause of death among children and teens: Annually, more than 3,500 children and teens (ages 0 to 19) are shot and killed, and 15,000 are shot and wounded

Below are some of Margy's suggested organizations and ways to become involved.

### Websites:

<u>Moms Demand Action</u> provides information and ways to become more involved in the gun violence prevention movement. <u>Every Town for Gun Safety</u> provides statistics; e.g., "Every day, more than 110 Americans are killed with guns."

<u>Every Town Research</u> Everytown Research & Policy conducts independent, methodologically rigorous research, supports evidence-based policies, and communicates this knowledge to the public.

<u>Every Town Support Fund</u>: donate to reduce gun violence in America.

<u>Be Smart for Kids</u>: The Be SMART framework helps parents and adults normalize conversations about gun safety and take responsible actions to prevent child gun deaths and injuries.

<u>Sharing Kindness</u> focuses on suicide prevention.

<u>Mass Men</u> This project provides resources for suicide prevention and mental health for men.

The <u>Gun Owners Action League</u> provides quality training for individuals interested in the proper use, handing, and safe storage of firearms, lobbies for and writes legislation that improves our gun laws, grades current legislators on their gun voting records, and more.

## THE CONVOLUTED JOURNEY OF A BILL— VOTE YES FOR SAFER ROADS

### "Work and Family Mobility Act"

- After almost two decades, the bill passed this year.
- Governor Baker vetoed it.
- The bill went back to the legislature
- The bill passed with overwhelming support from both branches.
- The bill is now a law.
- A group of people in opposition gathered enough signatures to put the bill on the ballot.
- Ballot Question 4 will be on the November ballot. Vote YES to defend this bill.

### What is the "Work and Family Mobility Act"?

The bill addressed the problem of undocumented immigrants who live in Massachusetts and are unable to obtain drivers licenses. This bill would allow any qualified driver, regardless of immigration status, to obtain a driver's license in full compliance with Massachusetts law, including passing drivers' tests and meeting insurance requirements.

One concern many people have expressed is that undocumented immigrants would obtain voting rights by getting a driver's license. However, other states with similar legislation have shown this objection to be unfounded. Drivers' licenses issued under this law are kept in a separate data base, not accessible for voter registration. According to the ACLU: *This bill requires minimal changes to Massachusetts law, while keeping our Commonwealth in full compliance with Real ID requirements. In March 2018, our Commonwealth instituted a two tier system for driver's licenses and identification cards—the REAL ID, and the Massachusetts standard license. Only the latter would be affected by this legislation, which*

# means Massachusetts would remain in full compliance with federal REAL ID requirements.

The bill promotes safety because roads will be safer when all drivers are tested and insured. Law enforcement officials support the bill. Sixteen other states have already passed similar bills.

According to the Driving Families Forward Coalition, of which the LWVMA is a member, as soon as the bill was passed, money came pouring in to gather signatures to put a measure on the ballot to overturn the bill. Unfortunately, they were successful, and Ballot Question 4 will be on the November ballot.

The Driving Families Forward Coalition is starting a new public information campaign. <u>Vote</u> <u>Ves on 4 for Safer Roads</u> is up and running to defend the Work and Family Mobility Act. Stay tuned, more information will be coming from the LWV.

# WELCOME to NEW MEMBERS

"I have been very interested in being a part of an organization that encourages people to vote." Nancy Dick

As the final quarter of the calendar year 2022 rapidly approaches, the League of Women Voters of the Cape Cod Area is experiencing a 20% surge in enrolled membership thus far. One eager-tolearn 2022 new member is **Nancy Dick**, R.N.

Now retired and residing in Mashpee with her husband John, Nancy expresses her strong desire to learn more about current socio-political issues via LWVCCA. She realizes, however, that her first step in getting proactively involved will be her initiating an ongoing self-educating process regarding The League itself. Nancy appreciates the fact that The League offers a profusion of learning opportunities through forums, panel discussions, candidates' presentations, symposia as well as the future Florence Seldin Speakers Series which is being planned to start this fall.

Nancy Dick and her family are not strangers to proactive involvement in controversial current events. She and her husband were asked by the Board of Trustees of their residential complex to remove their "BLACK LIVES MATTER" sign from their front porch. The sign actually had other slogans among which were "WATER IS LIFE", "WOMEN'S RIGHTS ARE HUMAN RIGHTS", **"INJUSTICE ANYWHERE IS A THREAT TO JUSTICE** EVERYWHERE". The reason given for the removal request was that Nancy's residential complex did not allow any signs on the premises of the complex. The sign had received a few days of exposure to many neighbors prior to Nancy's family complying with the Board's request to remove it from their front porch; or to place it in a less prominent location. Nancy Dick's family and other white American families across the United States clearly demonstrated courage in their efforts to display their "BLACK LIVES MATTER" signs.

Nancy grew up in a small town in upstate New York : Saquoit. Her father was a welder. Her mother was a hospital operating room technician. As Nancy was growing up in her parents' household, she often heard her mother express how absolutely shocked and dismayed she was regarding how her white hospital staff members spoke about patients who were people of color. According to Nancy's mother's accounts, the patients who were people of color received a lower standard of care and treatment from a predominantly white medical staff.

Nancy Dick graduated in 1970 from the Crouse Irving Memorial Hospital School of Nursing on the campus of Syracuse University. Her professional nursing career was filled with per diem and temporary assignments due to her husband's international employment as an engineer. In the United States Nancy worked on medical services including orthopedics, surgery units, and pediatrics. As a home-care registered nurse she was responsible for patient discharge planning and utilization review for patients. Nancy and John Dick are both retired. They are the parents of two adult sons and three very active grand-daughters

(all under the age of seven). Nancy Dick strongly states, "Equality and democracy are for everyone."

Our QR Code cards with voter registration information were a big hit.

Lots of voter registration QR code cards were passed out. We even registered one student, who didn't have a driver's license, the old-fashioned way, with a paper registration card. ### **Liaisons at Work**

We would like to thank the liaisons who helped the Voter Service Committee put together the data on how many votes were cast in Barnstable County during the primary elections. The liaisons plus one volunteer called their town clerk and asked 3 questions: how many people voted on September 6; how many registered voters do you have in your town; what percentage of voters voted. Here are the results:

So, only 25 to 39% of voters voted in the Primary election. Big decisions were made in the primary. There were competitive races for statewide offices of governor, lieutenant governor, attorney general, auditor, and secretary of state.

On the Cape there was only one contested Democratic State Representative race. On the Republican side the candidates for District Attorney, State Senator and Congress were decided in the primary. All other races were uncontested. With low turnout your vote is worth 3 to 4 times more than it would be ordinarily. And that may seem powerful – but it actually is not. Low voter turnout lulls our officeholders into an entitled sense that they can just slide into their offices, per usual. We need and can shake the system up a bit. Make our government representatives more beholding to their constituents when they can't be sure whether the status quo will hold. We need the wisdom of the crowd. Better decisions are made when more people are involved. With tools like Vote411.org and talking to friends and neighbors about getting out and voting, we can make a difference. And, of course, is what the LWV is all about. Educating people about what is at stake and how important each office is.

And this gets me to the next topic, the upcoming races for District Attorney and Sheriff. The LWV of the Cape Cod Area has done tremendous work in getting the word out on how important these offices are:



Dr. Florence Seldin was a beloved member of the League of Women Voters for more than 55 years, with 28 of those years serving in the leadership of the League of Women Voters of the Cape Cod Area, and as LWVCCA President in the years 1997 - 2000 and as President of the Helen S. Aaron Education Trust for the LWVCCA. She also served on the LWVMA Board and on the LWVMA Legislative Action Committee. Florence's life exemplified the statement that "Democracy is not a spectator sport." In the community, Florence was on the Chatham Select Board, including serving as Chair, and also served on the Finance Committee. She served on multiple community organizations to improve government, housing, the social safety net and the environment. For many years she served as a masterful moderator for candidate forums.
