DID YOU KNOW-?

...that the LWVMA has selected 64+ bills to follow in the 193rd legislative session and is opposing four of them? Three of these are included in the category of *Elections and Voting*. All three require voters to show photo ID or a government-

issued ID, such as a military ID, pilot's license, or Medicare/Medicaid card, when they arrive at the polls,

The LWVMA opposes these three bills because they place unnecessary burdens on voters and officials, and duplicate existing state and federal laws. The Help America Vote Act (HAVA) already requires all eligible persons to provide valid ID when they register to vote and first-time voters to produce ID at the polls. Many studies have shown that voter impersonation at polling places is virtually non-existent. The Brennan Center for Justice at NYU Law School reports that Americans are "more likely to be struck by lightning than to commit voter-impersonation fraud." The LWVMA reminds us that voter disenfranchisement and low voter turnout are much greater problems in our elections.

The fourth bill that the LWVMA opposes would allow the state to petition Congress to call for a Constitutional Convention allowed under Article V of the US Constitution. The League of Women Voters strongly opposes any efforts to call for a Constitutional Convention under Article V until specific conditions governing such a convention are in place. The LWVUS has urged caution and outlined several safeguards for the calling of these conventions because of the potential for unintended consequences, i.e., for "runaway conventions" to veer away from their stated purpose and to adopt agendas which threaten our democracy.

To learn more about Article V Conventions, attend the Cape Cod LWV's Annual Meeting on May 18 where Common Cause MA Director **Geoff Foster** will speak about these conventions.

GOOD NEWS!

It has been almost two years since the proposal for siting a multipurpose machine gun range at Joint Base on the Upper Cape Water Supply Reserve. Just recently the EPA determined that the range represents a significant potential threat to the Cape's water supply. While this is a draft finding by EPA, the first such finding ever issued under its authority pursuant to the federal Safe Drinking Water Act, it does appear to stop the range, but the effort does not end here. The EPA decision is subject to a 60-day comment period before becoming final. It is critically important that all of us concerned with protecting our drinking water make our support of the draft ruling known to EPA. At the beginning of this battle I sent a comment in the name of the League to the hearing commission and will once again reiterate our concerns. However, the more voices heard the greater the chances that this decision will definitely be permanent. I will let you all know to whom you should direct your personal comments.

It is becoming more and more apparent that this ecosystem of which we are all a part is indeed fragile. It is only through ongoing vigilance that we can continue to protect the air, land and water around us and preserve these resources for those that come after us.

LWVCCA COMMITTEE ANNUAL REPORTS

LEGISLATIVE COMMITTEE

Even though the formal session of the 192nd Legislative Session ended on July 31 last year, the fall was still busy. Some bills were not signed until the very end, The Economic bill was affected by the tax revenue cap, and the Work and Family Mobility Act required intensive advocacy after it was placed on the November ballot. Many bills have been resubmitted so we will be dealing with them again. A huge thank you to our committee members for all the work they did advocating for bills with their legislators, participating in lobby days via Zoom and providing testimony. A special thank you goes to Richard for sending out all the alerts.

BILLS THAT PASSED

 Voting Rights – Votes Act (Unrestricted mail voting, expanding early voting, reduction of registration deadline, join ERIC - an interstate org. that helps to clean up voter rolls).

- Reproductive Rights Expanding protections for reproductive and gender affirming care. (Makes abortion more accessible and affordable, providers who offer abortion and gender affirming care will be protected.
- Immigration Work and Family Mobility Act (Allows undocumented immigrants to obtain driver's license, was vetoed by the Governor but passed both branches.
 Opponents of the bill were successful in getting this on the November ballot where it was defeated again.
- Environment Advancing Clean Energy and Offshore Wind. (Meet climate energy goals, develop and expand offshore wind industry, invest in transmission infrastructure upgrades, workforce training.)
- Mental Health ABC Act 2.0 (Guarantees mental health wellness exams, real-time data on open beds, requirements for data collection and reporting)

- **Medicare for All** (Universal single payer healthcare) (*Resubmitted*)
- Safe Communities Act (Immigrants' rights) (*Resubmitted*)
- **Common Start Bill** (Child-care and early education) (*Resubmitted*)
- **Parity on Boards** (Equal representation on boards) (*Resubmitted*)
- **Gun Control (**Ghost guns/3Dprinting**)** *Resubmitted*
- Gun Control (Gun data analysis) Resubmitted
- Affordable Housing (MA rental voucher program) (*Resubmitted*)
- **Pilgrim Bills** (Monitor nuclear fuel casks, emergency planning, discharge of radioactive material) (*Resubmitted*)
- **Good Government** (Hybrid meeting provisions) (*Resubmitted*)
- Racial Justice (Hate crimes)
- **Environment** (Preserve open space, recycling costs)

ONCE IN 35 YEARS

Economic Bill – Economic Growth and Relief for the Commonwealth

The bill was on the way to being passed by the legislature when a 35 year old law was triggered. The <u>Excess Revenue Law</u> states that when the revenue in a fiscal year exceeds an annual tax revenue cap, the excess revenue is returned to the taxpayer. The state had an excess of 2.941 billion which will be returned to the taxpayer and will not be used to fund the bill. This has happened only once before in the past 35 years.

With the opening of the 193rd Legislative session, the Chairmanship of the LWVCCA Legislative Committee passed from the terrifically led and efficient hands of co-chairs Renate Sands and Carole Young-Kleinfeld to those of "needs a lot to learn" Sue Brock. I personally would like to thank both of these dedicated, hard-working women for all that they have done to move the membership forward in our advocacy role, especially Renate for all of her years of leadership. I hope to learn quickly and rely on Renate and Carole's help in the coming months. So far the LWVMA has selected 64 out of over 6000 filed bills for us to follow. There may be more, but our committee will be busy and we will keep you all informed of those bills to push or oppose.

One final addition to a year full of advocacy was the March 24th annual Legislative Meeting. This year it was held in person at CCCC in the new science building. The event hosted six of our 8 member legislative contingent and one aide for Senator Cyr, who once again did not join us. The dialogue was fruitful and informative. Going forward, we need to make sure that the legislators live up to their commitments to the League. Thank you, again, to all of the committee members who worked so hard throughout the year to ensure our successes. I look forward to working closely with all of you in this next year.

YOUTH SERVICE COMMITTEE

The Youth Service Committee continues to support action civics projects in the schools and strategies to increase the participation of youth in voting. In September we welcomed new member Tianka Taylor, a Barnstable High School senior, to our committee. Tianka created a virtual forum program to interest Barnstable students in voting and invited League members to participate in her forum along with a student she recruited. Voter Service Co-Chair, Rosemary Shields, Youth Service Committee Chair, Karen Mazza and Co-President Jeanne Morrison participated. Another joint voting outreach activity occurred at the Dennis Yarmouth Regional High School in the fall as a shared activity between the Voter Service Committee and the Youth Service Committee. We once again set up a voter registration and information table as a station that students rotated to while participating in the Credit for Life Fair sponsored by Cape Cod 5. The new QR code cards available from the Secretary of the Commonwealth were an excellent tool to help students register quickly or to check to see if they are already registered.

Another shared responsibility for youth voter outreach occurred in October, when the Florence Seldin, "Democracy is Not a Spectator Sport" Lecture series kicked off its first virtual forum entitled: "Youth Power: Claiming Our Future With Our Vote." The Keynote speaker was Ruby Belle Booth, Election Coordinator from CIRCLE (Center for Information and Research on Civic Learning and Engagement at Tufts University). The forum featured several young adults speaking to the importance of voting. As a result of the forum, The Sturgis Charter School, immediately contacted us to hold a registration drive at their school. Rosemary Shield graciously offered to represent the League at that event.

In November, Karen Mazza resumed outreach to the LWVMA civic education network to help local Leagues expand their outreach to schools to support the student-led civic action projects which are now required in Grade 8 and in high school. The 2018 legislation that created this project and the Civic Project Trust Fund has had a slow rollout but is gathering more momentum this year. For the benefit of other local Leagues, Karen was joined in a Zoom presentation by members of LWV Needham, LWV Concord-Carlisle, and LWV Worcester to share the experiences our Leagues had with participating in civic education showcase events that were held in their area schools the previous lune. Karen shared our experience with participating in the Barnstable High School Civics Showcase where we talked with students about their projects and provided certificates to classes and selected students to recognize their civic engagement projects. In June, Karen and Cindy Battis (Youth Service Committee) attended the Generation Citizen state civic showcase event in Boston.

In December, the Youth Service Committee completed our second update to the Cape Cod **Civic Resource Directory for Student-Led Civics** projects. We provided this document to all of the Cape public area schools containing a Grade 8 or above to assist them with their civic action projects. We also provided a new menu of services that we could offer to support student work on the projects. Karen was invited to speak to the Sandwich High Social Studies Department to explain the menu of services we are offering. Karen was also invited to speak in the fall to the Martha Vineyard LWV about outreach to schools on these projects. This May, Karen has been asked to speak about the civic action project and the Massachusetts Civic Learning Coalition at the Annual Meeting for the LWV Southcoast.

This year, our League will again be invited to participate in the Barnstable High School Civic Showcase in June. A new invitation has been extended this year from Monomoy Regional High School and from Mashpee Middle/High School for their classroom presentations

One exciting development for this June, is that the Department of Elementary and Secondary Education will sponsor its first two state wide civic showcase events for students in Grade 8 and High School. One event will be held in Worcester and the other event will be held in Boston, this one being exclusively for school districts that have

used the Generation Citizen Curriculum Model for their civic action projects. The Cape is fortunate that two districts, Barnstable and Dennis-Yarmouth, will be participating in the Boston event. Karen and Pattye Comfort, Executive Director of LWVMA participated all of last year in a small planning group with the Massachusetts Civic Learning Coalition and Representatives of the **Department of Elementary and Secondary** Education to plan the state showcases. So, it will be very exciting to actually see them happen this June. LWMA held two fundraising events to provide food for the state showcase event in Worcester and we are recruiting League members to serve as Community Advisors who will speak to students about their projects. Through these two efforts, The League of Women Voters will have a strong presence of support at the state showcase events.

It has been exciting and rewarding to see the continued growth of the civic action projects in schools, the growth of state resources to support civic education, and the continued outreach of local Leagues to support civic action projects at their local schools.

Our committee has already begun brainstorming actions to achieve our new additional goal for the 2023-2024 program year. That goal will focus on additional ways to involve young people in civic engagement in partnership with our League.

Health Committee

The LWVCCA Health Committee has reviewed the March 28 Forum on Preventing Youth Suicide that was partnered with the YMCA. The Forum had, as per the recently provided Program review, over 125 participants and, to date, over 100 viewers of the recorded version. The League's role was as a catalyst, in response to the recently funded Mental Health ABC Act, bringing forward the importance on prevention and of understanding youth suicide to League members and the Cape community. We are addressing audience questions asked during the Forum. The Youth Suicide Prevention Resource Materials is provided on our website:

The Committee's agreed to next step is discussing with other entities – e.g., Massachusetts Department of Mental Health, Southeast Region, NAMI of Cape Cod, Cape Cod behavioral health providers – how one or all of them can maintain and coordinate the momentum of addressing this major public health issue. In support of this intent, we are meeting with the Forum's three student speakers on their interest in supporting this momentum.

We are now transitioning our attention from the Forum to addressing the Committee's other 2023 planned objectives. These include Prevention of Gun Violence and Universal Single Payer Healthcare.

Voter Service Committee

The Voter Service Committee is dedicated to advancing democracy by conducting get-out-thevote (GOTV) events; arranging citizens forums; and informing citizens about important information. such as ballot issues and voter turnout data. To accomplish this work, we collaborate with Town Clerks, town citizen information groups, the media, coalition partners and other LWVCCA committees such as Youth Services, Legislative and Health Committees. We especially rely on a cadre of 20 volunteers to staff events on an as-needed basis. We also acknowledge individual League members who helped on their own by sending out postcards for nationwide GOTV campaigns, asking friends and neighbors about their voting plans and offering rides to the polls. It takes a village and every act we take to promote democracy makes a difference.

We send a huge ******Thank You****** to all who participated in voting activities and events this year!

Some highlights from this past year include:

Candidates Forums: where citizens can meet candidates, ask questions and hear where candidates stand on the issues in order to make a more informed choice.

- October 12, 2022 --The Barnstable Sheriff and the Cape and Islands District Attorney were major races because for the first time in over twenty years, neither incumbent to the office was running. The forum was held on in collaboration with MA Women of Color Coalition, Cape Cod Times and Cape Media Center. The Cape Cod Community College Tilden Arts Center Auditorium staff provided a polished venue.
- April 19, 2022 --spring election contested race for Dennis Water Commissioner in collaboration with the Dennis Town Clerk
- **April 28, 2022** -- Harwich Town Clerk race in collaboration with the Voter Information Committee of Harwich.
- **October 18, 2022** First Barnstable State Representative seat at the Cape Media studios in Dennis.
- We are still in the planning stages of 3 Candidates Forums for Select Board Member in Dennis April 18, 2023; Board of Select in Harwich April 20, 2023; and in Brewster, Select Board, Board of Health and Recreation Commission on April 25, 2023.

Voter Information tables: People are drawn to our tables because of the information we provide on candidate races (e.g. Brief Guides: What's a Sheriff, What's a DA?) and ballot issues ("Millionaire's Tax").

- July 29, 2022 Unity Day also on the Hyannis Green
- **August 20** Amplify POC event at Asleton Park in Hyannis;

- **September 1**, Student Orientation Day, Cape Cod Community College (CCCC)
- September 14 "Club Day" CCCC
- September 20 Constitution Day, CCCC
- **October 21** we were there for High School Seniors at the "Credit for Life" event at Dennis Yarmouth High School.
- **October 22** the proprietors of the store, Yankee Ingenuity, offered their front porch during Chatham Oktoberfest.
- October 25 inspired by the Seldin Speaker Series "Youth Power: Claiming Our Future with Our Vote" we got an invitation from students at the Sturgis Charter School. t
- November 4 (the Friday before election day) a GOTV rally with Grandmothers Against Gun Violence was held at the Hyannis Rotary.

Collecting voter data helps us better understand the voter and where to put our emphasis. Per usual, Cape Cod 2022 Spring Election results averaged only 25% of all registered voters, a dismal turnout. The Midterm Election of 2022, however, showed an increase of voter turnout from 5 to 10%. After working for a number of years in different companies in multiple managerial roles, she recognized that her interest was in the area of leadership. # **TOWN LIAISON MEETING**

The in-person gathering of the LWVCCA's Town Liaisons was held on Thursday afternoon March 30th in the Mashpee home of Mati Ligon, LWVCCA's Membership Chairperson. The Town Liaisons who were able to attend were: Jen Dames-Copp (Barnstable); Susan Brock (Dennis); Elaine Dickinson (Harwich); Carolyn Richardson (Sandwich); and Mati Ligon (Mashpee). The setting was arranged to provide comfortable freeflowing discussion between the five liaisons. The meeting started with Suzanne and Mati leading a quick review of the 5 Town Liaisons Roles as listed on page 33 of the LWVCCA's Members Directory and Handbook. Most of the one hour and forty minutes meeting was spent in a roundtable type of informal discussion with light refreshments being offered.

It was fortuitous indeed that Suzanne Brock a former LWVCCA president was able to attend the meeting. She is currently a Town Liaison and presents herself as a most knowledgeable and informative resource for other Town Liaisons regarding the overall organization of The League. In addition to the review of the roles of LWVCCA Town Liaisons, Suzanne helpfully offered her suggestion for "splitting the lists" for those Town Liaisons who were given long lists of members' names. Example: Jen Dames-Copp pointed out that her Barnstable list of 28 members' names could be shared with another Barnstable member. This would facilitate communicating with all Barnstable members whenever the need may arise in the future. All of the Town Liaisons who were present

agreed. Suzanne also respectfully offered assurance to the Town Liaisons that their own individual comfort level was to be considered/respected in their choice of communicating among the LWVCCA members (e.g., computer, telephone, USPS, etc.).

A suggestion offered to the Town Liaisons by Mati Ligon was as follows: "If you never have done so, serve as a volunteer on Election Day at a polling location in your own town. It is a great way to get an overview of your town's active voters. It is also a positive way to continue developing a relationship with your Town Clerk and other local government workers. Above all, you will have given your service in visible and physical affirmation of the democratic American voting process."

The Town Liaisons were appreciative of Elaine Dickinson's informal brief sharing of information and updates regarding the current nuclear waste dumping battle as it relates to proposed legislative activity. Carolyn Richardson indicated that for over 20 years no members of her family's household ever drink or cook with water from the faucets in their household. There was beneficial and wholesome exchange during the Town Liaison informal discussions before, during and after the meeting.

As the LWVCCA were leaving, Jen Dames-Copp graciously offered to host a future Town Liaison meeting at her home. It is hoped that those Town Liaisons who were not able to attend the March 30th meeting will be able to participate in Liaison meetings in the future along with the LWVCCA's current co-presidents Jeanne Morrison and Mary Utt. The March 30th meeting was productive!
