MLK Action Team of Nauset Interfaith Association awarded its MLK Racial Iustice Advocate Award to Jeanne M. Morrison of Barnstable. Ms. Morrison has been engaged in community activism and volunteer work since her earliest days growing up on Cape Cod and in retirement she has doubled down on her commitment to build a more just society. Civically committed she is serving or has served on many local and state boards and steering committees including League of Women Voters Cape Cod, Barnstable County Human Rights Advisory Commission, AmplifyPOC Cape Cod, and is a founding member of the award winning MLK Action Team's Conversations with Police Task Force.

The Racial Justice Advocate award is open to any Cape Cod resident whose striving for racial equity and justice embodies the principles of our mission statement: "to address systemic racial injustice by educating ourselves and others and building transformative relationships...".

Ms. Morrison received her recognition award at the annual MLK Breakfast event on January 20, 2025 at the Church of the Holy Spirit in Orleans. The Breakfast also featured local artist and educator, Carl Lopes speaking on "Facing Civil Rights Challenges" and a musical performance by Candida Rose.

Sadly, I received communication from Pat Ryle's son-in-law, Colin Farrell, that Pat passed away on January 12 at her home in Maryland after a six year battle with ovarian cancer. Colin shared the following message with us.

"Patty Ryle's, son-in-law Colin Farrell here. I am reaching out to you to let you know Patty died yesterday down here in Maryland. As I believe you know, Patty was diagnosed with ovarian cancer about six years ago. At the time of the diagnosis the doctors informed her she might have six months left. As Patty could squeeze 12 dimes out of a dollar bill, clearly that prognosis did not fit her plans. Not only did Patty have grandchildren to educate about any and every topic (while providing them copious amounts of snack food), there were elections to contest, and important things to do.

Patty's involvement with the League of Women Voters, the AAUW, and the Lions helped to keep her vital. Being of service, being useful, made her feel a part of the community and the world at large. As you all know, Patty could make her opinion known

with just a sideways glance, or a 10-minute soliloquy on the topic and hand. Or a topic not quite at hand. Whether requested or not.

We cannot thank you enough for your friendship to Patty over these many years. Your commitment to the community improved her life, particularly over these final years. And her involvement with your organizations helped Patty to set an example for her grandchildren. They witnessed her dedication to education, community engagement, and advocacy."

Pat was an active member of the Legislative Committee and the Health Committee, at one time co-chairing the Health Committee. I always found her to be enthusiastic, energetic, deeply committed to her work, and incredibly cheerful and positive in her approach to anything, including her illness. Renate Sands and Sue Brock worked with her on the legislative committee and they remember her as diligent, positive, and upbeat. Elaine Bono remembers her as an intelligent, strong woman.



Member Sue Brock describes her past involvement in the study process:

"For those of you who have never participated in a consensus study discussion with the League, this is the actual "grass-roots" participation piece of the LWV. Without the study, the presentation, and the consensus discussion, the League would have no positions. It is through the work and voices of the members that we have built all of our positions at the local, state, and national level over the past 100 years.

The important part of the discussion is to come to the consensus meeting prepared. Materials for the study are located at the LWVMA website at: <u>https://lwvma.org/lwvma-reparations-study/</u>. Key Documents: are the <u>Study Guide</u> and the <u>Study Report</u>, under the heading "LWVMA Study Documents".

Please try to take the time to engage with this material so that you will be prepared to supply input into the discussion process. I have participated in a number of these over the years. The process is stimulating, sometimes challenging but always worth the involvement."

If you have never seen the position statements from LWVMA they are published in a booklet called, "Where We Stand" and the LWVUS position statements are called, "Impact on Issues " Both of these documents can be found on the LWVMA website at: <u>https://lwvma.org/league-positions/</u>. These positions statements are important because they guide League advocacy in supporting or opposing legislation and policy. This means that our members decide the direction of our advocacy, not an Executive Director or a Board taking action based on their own individual preferences.

# **LEGISLATIVE COMMITTEE**

#### Hello Members,

The Legislative Committee is beginning to gear up since the new 2025-2026 legislative session has begun. Bill are being furiously filed. The filing deadline was January 22, so legislators are up to their eyeballs in paperwork. And, we actually have three new members to our legislator list. While Dylan Fernandes is not new to the legislative process, he is new to the Senate side of that process because he replaced Susan Moran as the Senator for the Plymouth Barnstable Senate District. For the 4<sup>th</sup> Barnstable District, Hadley Luddy replaced Sarah Peake, and in the Barnstable, Dukes and Nantucket District, Thomas W. Moakley took Dylan Fernandes representative seat. For those of you who are affected by these changes.

The Legislative Committee is waiting on the State Legislative Committee to sort through all of the legislation being filed to generate their list of bills that they will be following for the next two years. Our local league uses that list to create our own list of bills to follow. There may be a few bills that are specific to the Cape that we may include on our list, such as the Transportation Bill that we supported last session. That bill proposed extending rail service from Boston to the Cape on a regular basis. The bill never made it out of committee but there may be a few that we will specifically target. However, it is much too early to specify any at this time.

Both the House (Rep. Ron Marian) and Senate (Sen. Karen Spilka) leadership have indicated a move towards increased transparency for this new session. They said that their new rules would spell out potential changes but as of yet a date for drawing up those joint rules has not been set. And, in case you have not been paying attention to the papers.... There is a fight brewing between those two legislative bodies and the new State Auditor, Diana DeZoglio. Question 1 on the ballot in the last election requiring the auditor to audit all activities of the state legislative process was overwhelmingly approved by the voters. However, the legislative leaders are digging their heels in to prevent that from happening and attempting to ignore the will of the people. Seems to be a lot of that going around. So, stay tuned for more information regarding the workings of your State Government.

There were a number of last minute bills that were pushed through at the end of the last legislative session. Those bills moved after the theoretical end of session date which was August 31. Anything that happens after that is usually with fewer members present, subject to little or no debate, and sometimes attached to budget items which makes it difficult to find. The leadership has suggested in their rules changes that the formal legislative session may be extended past the August 31, 2026 date but we will have to wait and see.

If any of you have questions that I may answer, please do not hesitate to contact me. I may not know the answer but will do my best to find out what I can. In the meantime, do not hesitate to contact your legislator with concerns going forward. It is never too early to reach out, especially if it concerns legislation from last session. If you do contact your legislator, make sure you indicate your name and address so they know you are a constituent.

I am very thankful to have on my committee the following hard working members: Carole Young-Kleinfeld, Nancy Skinner, Renate Sands, Rosemary Shields, Susan Guill, Tamora Israel, Jeanne Morrison, Diane Turco, Eileen Elias, Elaine Dickinson, Mary Utt and Pat Ryle. If there are any additional members who would like to join us, please just let me know.

Finally, we should all be gearing up for ongoing legislative action on the national level. I believe that we are in for a tumultuous four years. I may be wrong, but forewarned is forearmed. And my heart goes out to all of those in the LA area who have lost everything. Where to begin again and how??? I have friends in the area. Not affected yet but are on constant evacuation alert. Those winds can shift in an eye-blink.

# DID YOU KNOW ...?

....that the 988 Suicide & Crisis Lifeline recently received an FCC upgrade which will make responses to crisis phone calls more efficient? People who call the 988 line can now be *Georouted* to a crisis center within their nearby area. based on the location of the cell tower where the call originates—instead of to a crisis center in their area code. This allows for more localized care for callers. The Pew Charitable Trusts reported that 80% of calls now come from cell phones, instead of landlines. Data also shows that 98% of 988 calls can be resolved over the phone without involving 911 emergency responders. The FCC believes that this new rule change will save lives. It has also voted to propose a rule requiring Georouting for 988 text messages, in addition to phone calls.
