ANNUAL MEETING NEWSFLASH

In a year when our elections may be in jeopardy and the League’s role in supporting free and fair elections is critical, we are fortunate to have the Commonwealth’s top elections official share her thoughts with us. Michelle K. Tassinari, the First Deputy Secretary of the Commonwealth and the Director and Legal Counsel of the Elections Division, will be the LWVCCA’s featured speaker at our Annual Meeting in May.

A graduate of Brandeis University and New England Law School, Ms. Tassinari has worked at the Secretary of the Commonwealth’s Elections Division for more than 20 years. She served as President of the National Association of State Election Directors from 2021-2022 and is an Advisory Board Member of MIT’s Election Data and Science Lab. Ms. Tassinari is also Massachusetts’ appointee to the U.S. Election Assistance Commission’s Standards Board and was named one of the 50 Top Women of Law by the Massachusetts Lawyer’s Weekly in 2020.

Ms. Tassinari is a member of the nationwide Committee for Safe and Secure Elections (CSSE)

composed of experts in elections administration and law enforcement personnel. The Committee promotes policies and practices to protect election workers and voters from violence, threats, and intimidation. They also work to strengthen ongoing, trusting relationships between elections officials and law enforcement personnel to secure our nation’s elections.

DID YOU KNOW...?

Latinx in Action (LIA) is working hard to meet the needs of our immigrant community members, who continue to face many challenges and obstacles in these times. The League has started small by joining the “Harwich Hub” (of LIA), which supports LIA's food distribution program. The Harwich Hub gathers culturally specific foods on the second Friday of each month. The next 3 months dates are: April 10, May 8, June 12.

The foods needed are: Vegetable Oil (not Olive Oil), White Sugar, Ground Coffee, White Rice, Bagged Beans, Cornmeal, Pasta, Potatoes, Sweet Potatoes, Carrots, Onions, Garlic, (all items family size, not bulk please). Gift cards are also welcomed and appreciated any time.

FINANCE COMMITTEE

The newly formed Finance Committee is doing more than budget preparation. Your Board approved the creation of a new standing committee, a Finance Committee. We are 5 members and had our first meeting in December. I'd like to tell you what we've accomplished and what's still on our plate.

We are creating policies and procedures to guide financial administration. Once adopted, these will be incorporated into our existing Board Manual to help future LWVCCA leaders.

The first policy we tackled addressed minimum cash reserve levels. As your new Treasurer, I thought we were in great fiscal health. I felt the Board was not as confident. The Finance Committee therefore evaluated fixed expenses and expense levels for programs that LWVCCA have traditionally organized. We determined a prudent amount of cash reserves that we should retain. We presented that information to the Board and have now established a reserve level that ensures our viability during difficult periods, yet allows us to spend reasonable amounts investing in our programs.

The second policy we tackled addressed the budgeting process. I felt we could produce a more robust budget for our next fiscal year by including the Vice Presidents of Programs and all Committee Chairs on the front end of budget preparation. The Finance Committee agreed. We drafted a document that provides structure to budget prep, including general timelines, defining revenue sources that should be projected, and requiring expense line items for every program. The document also provides general guidelines on financial administration during the year. It addresses spending authority and how to handle expenses that may arise which have not been budgeted, or if the budget allocation is insufficient. This document goes to the Board for a vote at the March meeting.

Next on our agenda is to draft a document providing information about funding program

expenses. This document is expected to inform everyone in LWVCCA leadership the funding sources available for their program activities.

LEGISLATIVE COMMITTEE

Members,

The legislature is mired in the budget battle. The Governor's proposed \$62.8 billion budget, filed as House 2, does not propose any new taxes or fees and represents 1.1 percent growth over estimated FY26 spending, the lowest spending rate since taking office and well under the rate of inflation. This includes \$2.7 billion in Fair Share surtax spending. Alongside House 2, Governor Healey also filed a Fair Share supplemental budget bill to spend \$1.15 billion in surplus FY25 surtax revenue on education and transportation initiatives.

Meanwhile, the House and Senate are busy pulling together their own versions of a budget which will have to be reconciled between the two houses and then reconciled with the Governor's. While it is important to understand the importance of putting together a budget, something that the federal government should learn or maybe relearn, the process is convoluted and takes up an enormous amount of time. During this process, little else is accomplished: Here's a [LINK TO OUR BILL LIST](#) for those of you that would like to see the progress.... However, some of this may even change between the time that I write this and the time that you get to read it.

We have been following a number of immigration bills. On Jan. 29, Gov. Healey filed legislation to keep federal ICE personnel out of courthouses, schools, childcare programs, hospitals and houses of worship. This legislation would also make it unlawful for another state to deploy its National Guard in MA without the governor's permission (although we have seen how that has played out in other states). And it would allow parents to pre-arrange guardianship for their children in case they are detained or deported by federal authorities. Healey said her bill is the most comprehensive effort in the country to protect against ICE activity in sensitive locations. The provisions were included in a fiscal 2026 supplemental budget bill that proposes

\$411.3 million in time-sensitive appropriations for deficiencies.

As of March 20, the bill was working its way through the House and Senate. With luck, there will be a positive outcome. But, like any bill sorting its way through the MA legislative process... the road is long and windy. I will keep you all posted and there may in fact be notices coming to contact those in office. Since the legislature adjourns official session on July 31st, pray for swift discussion and passage.

In the meantime, keep up the pressure to your federal senators to halt the movement of the new version of the Save Act. And if you are feeling particularly energetic let both houses in DC know that they need to do their constitutional duty and to approve or disapprove of the "Incursion" into Iran and control the flow of money. That is more of their major roles for which they have abdicated responsibility. We are now in a truly rudderless ship.

BTW: Save the Date: Thursday, April 9 Lobby Day at the State House. Preserve Democracy and keep nuclear safety Law on the books. Trump is removing safeguards on environmental reviews for new nukes, increasing allowable rad exposure, gutting the NRC and oversight, and pushing fast track nukes that put us all at risk. Now our Governor and legislators want to repeal this law for yet-to-be tested and built SMRs. This is a direct challenge to our democratic process. Keep democracy alive and let the people decide.

NB: This Day is to be focused on the repeal of the 1985 people's petition to have a voice about new nuclear builds in the state.
