The Superior Court has general trial jurisdiction, including all felonies, civil matters, family court involving child custody and support, adoptions, probate and guardianships, dissolutions and annulments, traffic violations, small claims, and misdemeanors. The Court issues jury summonses, provides juries for courts, and maintains the law library. Because increasing the number of judges is not lightly done, the court has acted within its authority to appoint a commissioner with limited judicial authority to assist with the family law caseload.

Legislature

The County of Humboldt is a general law county. It was established in 1853 by the state legislature and is a political subdivision, or unit, of the state. The Board of Supervisors, which serves as the legislative and

executive body of county government and many special districts, is composed of five full-time members elected by their respective districts. The Board enacts legislation governing Humboldt County and determines policies for County departments and various special districts, adopts the annual budget, and fixes salaries. The Board also hears appeals of Planning Commission decisions and considers General Plan amendments.

The Board of Supervisors meets every Tuesday at 9 am, except the 5th Tuesday of the month. Meetings of the Board of Supervisors are broadcast live by Access Humboldt on Public Access Channel 10 and are also rebroadcast Wednesdays at 8 pm. Meeting agendas are available on their website on the Friday before each meeting. Citizens have the right to be heard during any public hearings that are noticed or advertised to the public. Time is specifically set aside for public input on items not found on the agenda. Time is allocated for public input for items on the agenda either before or after discussion by the board, but before the vote. Members of the public may contact a supervisor to request that an item be placed on the agenda. Persons submitting supporting materials must provide an original and nine copies for the materials to be placed in the public record.

The Sheriff-Coroner is also the Public Administrator in Humboldt County, a related but separate responsibility. The Public Administrator is an advocate of the decedent and his/her heirs. The Sheriff-Coroner administers or probates an estate which is intestate (without a Will) at the request of the heirs, when the heirs decline to act, when there is a Will and the executor/executrix requests the public administrator, when there are no known heirs, or when appointed to do so by the Superior Court.

City Councils

City councils oversee, set policy and provide direction in the consideration of ordinances and resolutions pertinent to the city. By law, citizens have the right to speak during any public hearing that was noticed or advertised to the public. The public is allotted time to speak at city council meetings in two different places. Incorporated Cities in Humboldt County include: Arcata, Blue Lake, Eureka, Ferndale, Fortuna, Rio Dell, and Trinidad.

Public comment: Time is specifically set aside for public input on items not found on the agenda. Speaking to an item on the agenda: Normally, the chair of the council will ask for public input on an agenda item either before or after discussion by the council, but before a vote. These segments are identified on the meeting agenda, which may be viewed prior to the meetings at the posted locations. The time allowed for public input varies from two minutes to no limit. The chair will normally tell the audience what the limit is and stop a speaker who has gone over that limit.
