Prusak is one of three female legislators who recently announced they would not run for re-election due to the low salary and heavy demands of public office, careers, and motherhood. ### **Recap of our March Program**

Over 20 members attended our March program on "League Advocacy on Climate Change," featuring Claudia Keith and Peggy Lynch from the LWVOR Action Committee. They shared their impressive knowledge of Oregon's ongoing climate change efforts and the status of the Oregon Climate Action Plan (OCAP), initiated by Governor Kate Brown in 2020. The plan directs a broad array of state agencies to incorporate climate protections into their agency planning and programs in multiple sectors, including transportation, public health, energy, buildings, and land use. ### **LWVCC Observer Corps**

We're happy to announce that our League once more has an active Observer Corps. Four volunteers recently completed a training session and are now ready to monitor local governmental meetings, either online or in-person, and report back on issues that may warrant League action. Mary O'Reilly and Nancy Tolin will work as a team to observe the Clackamas County Commissioners' meetings, Diana DeMaria will observe Oregon City and West Linn City Councils, and Linda Rinnan will focus on local land use hearings and Stafford Hamlet issues.

According to the LWVUS manual *Observing Your Government*, the goal for observers is not only to learn what government is doing, but to monitor whether those meetings are conducted in an open, transparent, and civil manner. Observers help to put elected and appointed officials on notice "that someone is watching what decisions are being made and how they are being made. They help ensure that the issues facing their community are being addressed in the sunshine, in the open."

### Your help is urgently needed to reduce gun violence in Oregon

The campaign to place two gun safety initiatives on the 2022 ballot is in full swing, but many more signature gatherers are needed for it to be successful. 112,020 valid signatures are needed by July 8. Here's a brief recap of the initiatives:

IP 17: bans manufacture, import, purchase, transfer, possession, and use of "semiautomatic assault firearms"

IP 18: requires a permit-to-purchase for all firearms and bans magazines over 10 rounds

As inspiration I'd like to share what League member Mary Bartholomew has accomplished at Mary's Woods. So far she has collected 202 signatures for each petition and is still going strong. She says the response has been overwhelming. A huge thanks to Mary for her efforts!

If gun violence prevention is an issue you care about, I would be happy to mail you one or more petition sheets (10 signatures per sheet) to circulate among your family and friends and return to the campaign.
