# Pesticides and Other Biocides Consensus Unit Meetings



## What does the term "consensus" mean to League members?

Consensus/group discussion is the technique most often used in the League for reaching member agreement. It is a process whereby members participate in a group discussion of an issue. The 'consensus' reached by members through group discussion is not a simple majority, nor is it unanimity; rather it is the overall 'sense of the group' as expressed through the exchange of ideas and opinions.

## **Redistricting Update**

On September 27, following hearings across the state and a contentious special session, the Oregon Legislature completed its once a decade task of drawing legislative and congressional maps with the passage of SB 881 and SB 882. Given that Oregon was awarded a sixth congressional district, this part of the process was especially acrimonious. Here are the newly drawn congressional, Oregon Senate, and Oregon House districts. A court appeal of those maps is expected, so stay tuned.

#### **Independent Redistricting Commission**

Although Oregon's 2021 redistricting process may be a done deal, the League continues to believe that an independent redistricting commission would be much better suited to deciding on district boundaries than legislators, who have a vested interest in the outcome. LWVOR is part of a statewide lobbying group called People Not Politicians (PNP), headed by former LWVOR President Norman Turrill, who have been working on redistricting reform as part of a nationwide effort. Although PNP was not able to collect enough signatures in a previous initiative effort, it is forging ahead with an initiative campaign that would create an independent redistricting commission by 2023. As of September 28, PNP has gotten the go-ahead to begin initial signature gathering to put Initiative Petition 16 (IP 16) on the November 2022 ballot.

#### **Reproductive Rights**

In the wake of the new Texas law and the October 2<sup>nd</sup> Women's March, it's a good time to revisit the national League's position on reproductive rights. The idea of studying the issue originated at the 1982 LWVUS Convention. In January 1983, League members agreed to adopt the following position in concurrence with the New Jersey and Massachusetts Leagues:

The League of Women Voters of the United States believes that public policy in a pluralistic society must affirm the constitutional right of privacy of the individual to make reproductive choices.

Predictably, the announcement of the position was not without controversy, and some members chose to leave the League.

However, to this day the League stands solidly with other pro-choice organizations, including Planned Parenthood, in opposing restrictions on the right of privacy in reproductive choices.



#### **Vaccine Mandates**

Clackamas County has been in the thick of the controversy over Covid-19 vaccine mandates, as the tenor of recent Board of County Commissioner meetings has demonstrated. The national League has urged for equitable vaccine distribution but so far has been silent on mandates. However, we believe it is critical that we speak up when government officials undercut the vaccination recommendations of public health departments.

Since its earliest days the League has supported public health initiatives that benefit "the health and safety of all Americans." When it comes to vaccine mandates, the question arises whether mandates conflict with League support for "the individual liberties guaranteed by the Constitution of the United States." The following article by Ellen Mbuqe posted on a Syracuse University webpage, provides a clear response to that question.

What do seatbelt laws and vaccine mandates have in common?

Throughout the United States, there are people who have come out strongly against mask or vaccine mandates.

But Syracuse University assistant professor <u>Kyla Garrett Wagner</u>, who studies the relationships between public health and the First Amendment, says that laws and protests against masks and vaccines are part of a long history of people challenging public health mandates.

From seatbelt laws to anti-smoking ordinances to requiring helmets when riding a motorcycle, there are precedents to people fighting public health and safety laws, she says.

"What do mask and vaccine mandates have in common with smoking bans and seatbelt laws? They all are examples of lawful government regulation to protect public health," said Wagner. "In a country that prioritizes individual liberties more than most, it can seem questionable when U.S. law mandates and/or outlaws specific health behaviors."

"But in fact, it's quite commonplace for both state and federal governments to compromise and even sacrifice individual liberties for the purposes of protecting public health. Why? Because, sometimes, that's what the pursuit of Life and Liberty demands – the compromise and sacrifice of one for the protection of the other," said Wagner.
