

# Students, College Administrators, and Election Officials Working Together to Overcome Barriers to Student Voting

### Millennial Voters and the Obstacles They Face

Young adults (ages 18-29) will make up at least 24% of the voting age population this year but, unlike other age groups, will face extra barriers to the ballot box. In 2010, only 22.8% of eligible voters under 30 voted, compared to 40.8% of all eligible voters casting ballots.

Students, in particular, face additional obstacles to voting as they move to a new community for school. These challenges include:

- not knowing voter registration rules and deadlines;
- not having acceptable ID for voter registration or voting purposes;
- confusion about where to vote;
- lack of transportation to the polls; and
- occasionally are confronted by unfriendly or unsympathetic elections officials or poll workers.

Registration is key to turning out college students. In 2008, of the 18-24 year old college students that registered to vote, 87 percent actually voted.

Approximately two-thirds of students aged 18-24 cited after the 2010 election reasons for not voting that could be easily remedied by empowering students with information. Registering students locally at freshman orientation, informing them of early voting options, or getting a polling place on campus would eliminate some of the barriers that keep students from the polls.

In addition to existing barriers, state legislatures around the country pursued new laws over the past year that sought to limit access to the polls, such as harsh restrictions on voter registration drives, restrictive ID laws and reductions in early voting options. These changes will make registration and voting even harder for students.

# The toolkit topics include:

## **Campus Vote Project Targeted States**

*CVP* target states include Colorado, Florida, Michigan, Missouri, Nevada, New Hampshire, North Carolina, Ohio, Pennsylvania, Virginia, and Wisconsin. Depending on funding, CVP may add Maine and New Mexico.

### **Campus Vote Project Partners**

CVP is also approaching college administrators and professors through national and state organizations such as the American Association of State Colleges and Universities (AASCU), American Association of University Women (AAUW), National Association of Independent Colleges and Universities (NAICU), National Association for Equal Opportunity (representing HBCUs), the Hispanic Association of Colleges and Universities (HACU) and the American Association of University Professors (AAUP). CVP will also work with partners to include community and technical colleges to reach young adults that are not attending traditional four year colleges.

In 2012, FELN will also place individual student coordinators in *CVP* states to provide additional outreach and organizing support, and to connect student-focused electoral programs with other statewide non-partisan efforts and state c-3 tables.


