Climate Change, the League of Women Voters, and the Power of Native Plant Gardening

Highland Park-Highwood League members know that the national League recently strengthened its commitment to climate change mitigation, deeming it an emergency that requires not just analysis and study, but immediate action. The national League has adopted a <u>position</u> that states that the trajectory of our changing climate represents a serious threat facing our nation and planet; addressing that threat constitutes an emergency.

"The League believes that an international approach to combating climate change — including through energy conservation, air pollution controls, building resilience, and promotion of renewable resources — is necessary to protect public health and defend the overall integrity of the global ecosystem. The League supports climate goals and policies that are consistent with the best available climate science and that will ensure a stable climate system for future generations. Individuals, communities, and governments must continue to address this issue, while considering the ramifications of their decisions, at all levels — local, state, regional, national, and global."

Staying up to date on the wide range of climate-related proposals to address climate change can be daunting. Many of us agree with the League's call for science-based actions to stop or reverse the dangerous repercussions of global warming, yet the scope of climate-related problems can seem beyond any individual's ability to contribute significantly to solutions. There is mounting evidence, however, that *if we join together* to adopt environment-friendly landscaping around our homes, apartments, businesses, and community organizations, we really can make a difference in at least part of the problem.

Numerous groups of "citizen gardeners" are joining the movement to re-shape our landscape with native plants and strengthen environments that support pollinators. One of those groups is *Wild Ones*, a national organization with numerous local chapters dedicated to promoting environmentally sound landscaping practices that conserve biodiversity through the preservation or restoration of native plant communities. From the Illinois Lake-to-Prairie chapter of *Wild Ones* comes this indictment of current landscape practices and *their contribution to climate demise:*

"Recent headlines about global insect declines, the impending extinction of one million species worldwide, and three billion fewer birds in North America are a bleak reality check about how ineffective our current landscape designs have been at sustaining the plants and animals that sustain us. Such losses are not an option if we wish to continue our current standard of living on Planet Earth."

The loss of biodiversity represents one of the repercussions of unchecked CO2 in our atmosphere; but there are solutions and all of us can help make them a reality. On November 13, the *Wild Ones* Lake-to-Prairie chapter sponsored a half-day conference featuring Dr. Doug Tallamy, a nationally renowned ety-mologist, researcher, and author. Tallamy gave enthusiastically received presentations based upon two of his New York Times best sellers, *Nature's Best Hope* and *The Nature of Oaks*. He built a strong case for reestablishing particles of land, large and small, with native plants that attract and support the entire ecological food chain, from insects to birds and small animals, in the process contributing to carbon reduction.

Tallamy argued that four basic concepts are the keys to promoting healthy landscaping:

- shrink the amount of land covered by turf, which does not attract or support biodiversity and coupled with chemical weed treatment and leaf blowing, actually attacks wildlife habitats
- replace non-native plants with the local "keystone plants" that provide the food needed by pollinators
- reduce landscape lighting that repels insects away from the plants that sustain them and all living things above them in the food chain
- stop mowing grass and removing leaves that provide natural homes and food for the insects that in turn provide sustenance to birds and animals that keep our environments safe and healthy.

Grass roots efforts to return yards or parts of land parcels to their natural state do not require legislation, regulations, or government policy changes. Please consider the ideas articulated in Tallamy's two books and the many plant-native advocates that are gathering resources, publishing information, and helping individuals and organizations to attack the menace of climate change right now.

Park District Study

Barbara Kronish and Jean Sogin met with Scott Coren, Highwood city Manager to talk about two issues:

- Our 90-plus year old League has long had members from Highwood, but only about 10 years ago did we formally become the League of Women Voters of Highland Park and Highwood. Nevertheless, most of our local focus has remained on Highland Park. Is there a way for us to become more involved with Highwood issues and residents?
- The League is undertaking a study of Highland Park's Park District and one of the questions is "should the Park District's boundaries be expanded to include Highwood?"

On the first question, he suggested we talk to the Highwood Historical Society as an entrée to residents who might be interested but pointed out that it is difficult to get time-pressed, young families to get involved in civic activities. The Rotary of Highland Park and Highwood and the High School's Rotary club are also possibilities. Parking is the number 1 issue he hears from residents and the Town has an ongoing parking study. If we wish to learn more about Highwood's special events, which have been so successful, we should talk to the Mayor, Charlie Pecaro.

On the second question, he thought economics would be the driving force for Highwood residents. Their taxes would go up if they were part of the Park District, but they would pay lower fees for programs and access to the beach. For most residents, paying the non-resident fees would be more cost efficient. As an example, a house with a Fair Market Value (FMV) of \$500,000 in Highland Park pays about \$900/year to the Park District, while the \$500,000 house in Highwood pays nothing. Consider a house with a lower FMV where the Park District tax might be only \$500 household where there are young children who want to go to Highland Park summer camps and other programs. At first glance joining the HP Park District might be appealing, but they may decide it's only for a few years and for that time they are better off paying the non-resident fees and keeping their lower tax bill. He suggested our first step should compare the resident/non-resident fees in the wide variety of programs.

Anyone interested in pursuing either of these topics should email LWVHP-HWD.



Since April 2021, both LWV HP-HWD and LWV Lake County have been following the closing of the <u>Openlands Lakeshore Preserve</u>, The Preserve was closed in April after explosives were found on the former military Fort Sheridan property. It is unknown (at least to the public) if the explosives came from the bluff or were washed up from Lake Michigan, The site was used for military target practice during World War II.

The Highland Park-Highwood League did reach out to the City of Highland Park and mentioned the issue during League Legislative Interviews last April and May. Initially there was disappointing finger pointing as to where the responsibility for remediation (if it was to happen) lies. In late August, we became aware of progress. With input from The City of Highland Park, Lake County officials, Senators Durbin, Duckworth and Congressman Schneider, the Navy has engaged in an assessment of the problem at Openlands. There is optimism from our local government and Openlands that the Preserve will be reopened by the summer of 2022.



VOTING RIGHTS

If you've been reading your email from LWVUS, you know that League, as part of a coalition promoting voting rights legislation, has been participating in multiple "No More Excuses: Voting Rights Now" protests and rallies in DC. The last one was this past Wednesday, November 17, where hundreds were arrested. You can read about it here (<u>https://www.lwv.org/newsroom/press-releases/largest-direct-action-date-voting-rights-activists-arrested-white-house</u>).

If the United States is to remain a democracy, this could be one of the most critical issues of our lifetime. Please take action to help contact every senator in every state to support abolishing the filibuster and protecting our right to vote. If you go to the LWV.org home page and scroll down to the bottom, you can click on the "Demand that President Biden Protect Our Freedom to Vote" and "Tell Your Senators to Support the John Lewis VRAA" boxes, you will be able to use the League's tool to contact your senators directly. (The "Freedom to Vote" act has failed.) Tell your friends in other states to do the same.

REDISTRICTING

The final congressional redistricting map presented by the Democrats was passed by the Illinois General Assembly on October 29. No consideration was given to the LWVIL's positions.

Lake County's proposed county redistricting map (for the Lake County Board) is now available for public comment. You can learn more, see the map and comment at https://reapportionment-lakecountyil.hub.arcgis.com/

(The League supports these criteria for any redistricting process: Population equity; All districts drawn in compliance with US Voting Rights Act of 1965 and subsequent amendments; Compact and contiguous; Boundaries where towns and cities divided among more than one district be as small as possible, that follow existing political boundaries as much as possible, that do not subdivide any city block, and follow permanent and easily recognized features; No district drawn with intent to favor an incumbent.

Members of the LWV of Lake County, including representatives from our League, are planning to meet to draft a comment on behalf of LWVLC.

OTHER ISSUES

Criminal Justice, Juvenile Justice, Gun Violence Prevention, are some of the other issues being followed and acted on.


