Our printed Voters Guide and online Vote411 services are on track to provide important information as we gear up for the fall election. 

VOTING IS YOUR SUPERPOWER, ELECTION SIMULATION

Over 125 young adults and students with disabilities participated in the "Voter is Your Superpower" voter education events held on August 28th and September 11th. Participants had the opportunity to register to vote, check their voter registration status, experience the voting process and learn about their rights as a voter. The events were a partnership between LWVBC and the Bucks County Center for Independent Living. The Bucks County Board of Elections set-up a voting simulation and guided the participants through the voting process, from checking in on the electronic poll-book to inserting the ballot into the ballot scanner. A big thank you to all the LWVBC members who volunteered and made these events a success!

The State of PA is committed to the safety and security of mail in ballots. Please read about the entire process <u>here</u>, including how mail in ballots are securely counted and handled.

Bucks County is committed to making the voting process safe, secure and convenient. That will never change. Voters who choose to vote by mail can use the United States Postal Service or one of the many <u>ballot drop boxes</u> which will be available throughout the county,

Bucks County has <u>implemented changes</u> to ensure voters can correct their ballot if they forget the secrecy envelope.

The county also alerted voters of <u>illegitimate mailings</u> that lead to voters confusing in April 2023.

ADVOCACY: RULES REFORM IN HARRISBURG

In early 2022, FairdistrictsPA published "Dysfunction by Design: Why Pennsylvania's State Legislature is So Unproductive...and How We Can Fix It." A copy of this document was distributed to all of our state legislators at that time. Now, as the General Assembly returns from summer recess, FDPA volunteers have researched and written a performance report assessing the first six months of the 2023-24 legislative session, entitled "Off to a Slow Start: PA Legislative Performance 2023."

On October 3rd, 3 other league members and myself, traveled to Harrisburg to meet up with statewide FairdistrictsPA volunteers. We traversed the halls of the Capitol and hand delivered a copy of the performance report to every PA legislator. At the conclusion of the distribution, a press conference was held to speak to the report's findings.

The statistics written in the performance report point to the continued need for more productivity in our legislature. FDPA compared neighboring states Virginia, Maryland and New York which have similar geography, demographics, older housing and infrastructure problems.

In Virginia and Maryland, during shorter legislative sessions, over 800 bills were passed. During a 2-year session in New York, over 900 bills were passed compared to only 15 bills being passed in the PA legislature during the 2 year session.

One other glaring statistic in the report shows that our legislature is even much less productive than it has been in recent years. Bills passed in the first 6 months of:

2019:87

2021:85

2023: 15

PA Legislative chambers are not collaborating with each other. The House is not securing support for their proposals and conversely, the Senate is not securing support from the House for theirs.

Even though Article III. Legislation in the PA Constitution states that a bill should not be altered or amended as to change its original purpose; nor should unrelated amendments be bundled; this has continued to happen.

RULES REFORM, CONT.

So many of our legislators go to Harrisburg with good ideas and real solutions to help their constituents. Too often, their ideas are ignored, blocked by party leaders and/or amended to oblivion.

That's why we need rules reform now:

- Bills with bipartisan support should receive a vote in committee
- Passing favorable out of committee, bills should receive a vote on the floor
- Bills passed in one chamber should be given automatic consideration in the other chamber The performance report does end with one positive note:

A newly formed "Meet In The Middle" bipartisan caucus has formed in the State House with 15 Republicans and 27 Democrats. The goal of the caucus, according to co-chair, Rep. Jamie Flick, is "to foster more cooperation between the parties, reduce polarization and find paths to work together to pass commonsense legislation that benefits the people of Pennsylvania." While it is too early to tell how effective this will be, FDPA researchers have noted that intergoverning coalitions in other states have fostered higher levels of cooperation and increased legislative productivity.

Let us continue to advocate for a better functioning and representative government.

Langhorne Borough Councilperson Kathleen is the 2023 recipient of both President's the **Award** exceptionally long and faithful by borough officials and their Distinguished Service Award that recognizes borough officials who provide distinguished their community.

Kathleen is a 40-yr member of the Langhorne Borough Council. She was the first woman President of Council. For all her volunteer efforts, Kathleen was awarded the prestigious Bucks County Women's History 2011 Woman of the Year honor.

Kathleen has served as the Director of Environmental Services for the Bucks County LWV. She was Chairperson of the Marcellus Shale Consensus Study and the followup Pipeline Studies. She has produced several COMCAST videos for the LWVBC, funded by the LWV Citizen Education Fund and other state agencies and featuring students.

She has been actively involved for 36 years with the Langhorne Rotary Club and continues to serve as a VP of the Lower Bucks AAUW. She is a retired school counselor, teacher, and administrator with the Bristol Township School District.

In her spare time (what spare time?) she can be seen supervising Community Service students with the Bucks County Juvenile Justice, gardening, and working on Langhorne Borough projects. She resides with husband, and has two grown children and four grandchildren.
